The Stewards, having received a report from the Clerk of the Course, with tracking system evidence attached, summoned the above competitor's representative (summon No. 3), have considered the following matter and determine the following:

Fact: Crew of car No. 17 failed to follow the prescribed itinerary as defined in the official

road book during the road section between SS12 and TC13

Offence: Breach of Art. 19.2 of the 2025 FIA Regional Rally Sporting Regulations

Decision: Fine of 250 € on the Competitor of Car No. 17 KOWAX DST RACING

In accordance with Article 12.8 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: https://fiafines.fia.com. Any delay in making payment may entail Suspension during the period a fine remains unpaid.

Reason:

The Steward examined the data provided and heard from the Team Representative, Mr. Dawid MARCINSKI, on Saturday 31st of May at 12:00 hrs.

Mr. Marcinski explained that the crew inadvertently deviated from the official itinerary at Km 27,96 on the road section between SS12 and TC13. Shortly after taking the incorrect road, the crew realised the mistake and immediately took action to correct it by turning around and returning to the prescribed route.

The Stewards acknowledged that the deviation was unintentional and that the crew acted promptly to rectify the mistake. Nevertheless, the Stewards concluded that a breach of art. 19.2 has occured, which explicity mandates that the crew must observe the official itinerary, and decided that the penalty imposed above is appropriate.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
