The Stewards, having received a report from the Clerk of the Course, with tracking system evidence attached, summoned the above competitor's representative (summon No.2), have considered the following matter and determine the following:

Fact: Crew of car No. 34 failed to follow the prescribed itinerary as defined in the official

road book during the road section between SS9 and TC9A

Offence: Breach of Art. 19.2 of the 2025 FIA Regional Rally Sporting Regulations

Decision: Fine of 250 € on the Competitor of Car No. 34 MSH RX AS

In accordance with Article 12.8 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: https://fiafines.fia.com. Any delay in making payment may entail Suspension during the period a fine remains unpaid.

Reason: The Stewards examined the data provided and heard from the co-driver, Mr. Erik STORØ, on Saturday 31st May at 11:40 hrs.

The Co-driver explained that the crew missed the junction at Km 42,67 on the road section between SS9 and TC9A.

It is also noted that after this deviation was detected, the Competitors' Relation Officer contacted the crew to inform them of the mistake. Upon being made aware of the mistake, the crew immediately took corrective action to rejoin the correct itinerary.

Although no evidence suggests that the crew acted with intent to gain an advantage, following the prescribed itinerary is a fundamental requirement and the responsibility for following the correct route always lies with the crew.

Therefore, the Stewards, while also taking into account the absence of any intent to gain an advantage, concluded that there was a breach of art. 19.2, which explicity mandates that the crew must observe the official itinerary, and decided to imposed the penalty above.
