4.1 Closing Date for Entries

In accordance with Article 3 above and FIA CCRSR Article 17.2.

4.2 Entry Procedure

Entries must be submitted in accordance with the 2023 FIA CCRSR Articles 16 & 18. See also FIA ISC Articles 3.8 & 3.14.

Entries must be made using the online form available on the website <u>Jordan Baja</u> and on Sportity App. If the application is sent by fax, by email or made electronically, the original duly signed entry form must reach the Organisers within 5 days following the close of entries. A copy of the valid competitor's licence must accompany the entry form. If one of the drivers will be the competitor, he must hold a valid competitor's licence and a driver's competition licence.

4.6 Entry fee refund

The entry fee shall be refunded in full:

- If the event does not take place.
- To entrants whose entry application is rejected.

The organiser may partially refund entry fees if a competitor cannot take part in the event due to a duly proved case of force majeure.

4.7 Waivers

By submitting their entries, the competitors, drivers, and car owners waive any claims or rights to pursue action for damages in connection with the event against the Organizer.

5 Insurance Cover

In accordance with article 15 of 2023 FIA CCRSR.

5.1 Third Party Insurance

The Entry Fee includes the insurance premium, which guarantees the Competitors cover for civil liability towards third parties (Public Liability). The indemnity provided under this insurance is the equivalent of €120'000 as total minimum liability cover.

The insurance cover will come into effect from the Administrative Checking and scrutineering for the event and end upon the expiry of one of the following time limits, whichever is the later:

- Time limit for protests or appeals or the end of any hearing by the Stewards.
- End of the post-event scrutineering.
- End of the prize-giving.

The beneficiaries are covered by the insurance while on the course of the event, throughout the duration of the event. During that time, competitors who have retired or been disqualified continue to be covered by insurance, if they join the finish control or the nearest port of embarkation via the most direct route from the location where they have retired or been disqualified.





5.2 Insurance Company

The insurance company & policy details will be published in a bulletin.

5.3 Exclusion:

The insurance policy on no account covers the theft of vehicles, spare parts, or any other properties.

The service, auxiliary & truck vehicles, even those bearing special plates issued by the Organisers, are not covered by the insurance policy of the event; hence, their insurance policies remain the sole responsibility of the owner.

5.4 Organisers Liability

The Organisers decline liability for any accident caused to competitors and competing vehicles during the whole of the event, or any case of cataclysm, riots, demonstrations, vandalism etc. Competitors and crewmembers will have to sustain all consequences (damages, fines, and penalties) created by any accidents. Organisers also decline any liability for breach of the Jordanian Laws and regulations.

5.5 Additional Insurance

In addition to the insurance covered by the Organiser, all Competitors are required to provide their own insurance covering all vehicles used in Jordan to cover civil liability towards third parties for the entire duration of their visit in the case of foreign crews, or permanent cover in the case of Jordanian residents. This is to cover competitors while they are on the road sections, or on public roads or highways.

Competitors and drivers are free to take on at their own convenience any individual insurance policy that they deem fit, independently from the above-mentioned liability insurance.

5.6 Proof of Insurance

All Competitors must be able to present the insurance papers at the Administrative Checks. The burden of proof for a valid insurance rest solely on the competitor.

5.7 In case of accident

During the Baja, a competitor or his representative must notify in writing the Clerk of the Course, the Crew's Relations Officer, or the Organiser directly within 24 hours in case an accident occurs.

6 Advertising & Identification

6.1 Obligatory Organiser's Advertising

For more details refer to the 2023 FIA CCRSR Article 20.1.4 V2 and appendix 3 of these regulations.

- 6.1.1 Text of the obligatory advertising: "2023 Jordan Baja"
- 6.1.2 Two door competition number plates size 67x17cm, each panel shall be placed horizontally at the leading edge of each front door, with the number at the front. The top of the plate shall be between 7 cm and 10 cm below the lower limit of the window. No signage, other than the colour scheme of the vehicle, shall be placed within 10 cm of this panel.
- 6.1.3 One roof competition number plates size 50x52cm, to be placed on the roof with the top towards the front of the vehicle.
- 6.1.4 One rear competition number size 43x21.5cm, must be positioned in a visible position during the whole event. It must be fixed at the rear of the vehicle, parallel to the axis of the wheels, without covering, even partially, the vehicle's licence plate.





6.1.5 One front windscreen panel size 20x10cm, must be fixed at the front window. If the vehicle has no windscreen, a plate of the aforementioned size may be used instead.

The Organiser shall supply each crew with the identification numbers mentioned above, which must be affixed to their vehicles in the stated positions prior to scrutineering.

A competitor who has definitively retired from an event must immediately remove or cover his competition numbers.

All vehicles are not allowed to cut any obligatory organiser's advertising panels.

6.2 Optional Organiser's Advertising

For more details refer to the 2023 FIA CCRSR Article 20.2 of V2 and appendix 3 of these regulations.

- 6.2.1 The text will be announced in a Bulletin.
- 6.2.2 Two panels, 50x52cm to be affixed on the right and left sides of the vehicle, on the area situated between the wheel arches if they are totally visible from the side.
- 6.2.3 For T3 & T4 vehicles only, the two 50x52cm panels will be replaced by four stickers 25x10cm and they are not allowed to cut it.
- 6.2.4 Two front windshield top left and right corners size 25x10cm.
- 6.2.5 Spaces on the vehicle must be kept free, see Appendix 3 of these regulations for the location of the Optional Advertising (+60% if rejected).

Competitors who accept the Organiser's optional advertising as specified in these regulations must reserve space for it. No modification of the advertising is allowed.

6.3 Driver's & Co-Driver's Names & Identification

- 6.3.1 The first initial(s) and surname of the driver and the co-driver, followed by the national flags of the country according to Art. 9.4 of the Code, must appear on both sides of the front wings or front doors of the vehicle. The letters must have a height of 30 to 50mm.
- 6.3.2 The members of the Crew will be identified by means of an identity wrist band (bracelet). The emergency number and name of the event will be written on the wrist band.

6.4 Restrictions on Advertising

Competitors are allowed to affix any kind of advertising to their vehicles, if:

- 6.4.1 It is authorised by the National Laws and the FIA Regulations.
- 6.4.2 It is not likely to give offence.
- 6.4.3 It is not political or religious in nature.
- 6.4.4 It respects the regulations on competition numbers.
- 6.4.5 It does not interfere with the crew's vision through the windows.
- 6.4.6 It complies with the provisions of the Code.

6.5 National Restrictions on Advertising

6.5.1 Tobacco: Advertising of tobacco, tobacco products and imitations, as well as smokers' requisites is forbidden according to the Jordanian legislation on vehicles, competition\service equipment and on the Team members' outfits.





6.5.2 Alcohol: Advertising of alcoholic beverages is strongly restricted by law and not allowed on competing vehicles, service vehicles, equipment, and clothes.

6.6 Breach of Regulation

The crews must ensure that the advertising is properly affixed throughout the running of the event. If the obligatory advertising is absent or wrongly affixed a fine of 10% of the entry fee will be applied.

If the optional advertising is absent or wrongly affixed, a fine of 10% of the entry fee will be applied for the first offence, and 100% of the entry fee for each repeated offence, as per Article 20.3 of Appendix I of the 2023 FIA CCRSR.

7 Tyres

- 7.1 Regulations regarding tyres which may be used during the event
 - 7.1.1 In accordance with Article 10 & Article 10 of V2 of the 2023 FIA CCRSR.
 - 7.1.2 T1 Priority drivers are allowed a maximum of 12 tyres for all the Baja.
 - 7.1.3 All vehicles must use tyres from a tyre manufacturer's commercial catalogue.
 - 7.1.4 At any time during the event, controls may be carried out to check the conformity of the tyres.

All types of fuel must follow Appendix J Art. 252.9 (Art. 56 of the 2023 FIA CCRSR).

 - 8.1.2 Refuel stations/locations are marked in the Road Book, competitors are obliged to refuel in these stations only.

9 Administrative Checks

9.1 Documents to be presented:

9.1.1 Additional Requirements: €500 MUST be paid in cash during documentation as a deposit for Tracking & Navigation equipment. If the deposit is paid by a Credit Card an additional non-refundable 5% acquiring fees will be added to the total.

9.2 Timetable

- 9.2.1 The Administrative Checks will take place according to Article 03 Programme of these regulations. A schedule for each competitor will be published in a bulletin.
- 9.2.2 Drivers and co-drivers taking part in the event must report to the administrative checks in accordance with the timetable which will be published in a bulletin.
- 9.2.3 Any crew reporting outside their time schedule for administrative checks, a penalty of €15/min to a maximum of 15 minutes will be applied, thereafter they will be reported to the Stewards who may apply a penalty at their discretion.

9.3 Venue

10 SCRUTINEERING, SEALING & MARKING

Refer to Articles 23, 24 & 25 of the 2023 FIA CCRSR.

10.1 Scrutineering, Venue, & Timetable

Vehicles may be presented at scrutineering by a representative of the team. See Article 3 Programme.

Scrutineering venue is at the Service Park which is located at: Aqaba City – Old Port, according to Article 2.8 of these regulations.

10.1.2 Scrutineering Timetable: A schedule for each competitor will be published in a bulletin.

Any competitor/representative reporting outside their time schedule for scrutineering, a penalty of €15/min to a maximum of 15 minutes will be applied, thereafter they will be reported to the Stewards who may apply a penalty at their discretion.





- 10.1.3 When checking in at the scrutineering time control, competitors must comply with the following:
 - All Rally plates, competition numbers and advertising plates must be already fitted.
 - Present the driver's safety equipment for approval.
 - Present NAV/GPS in working order, permanently fitted to the vehicle.

10.2 Driver's safety equipment

All items of clothing including helmets and FHR (Front Head Restraint) intended to be used, e.g., HANS devices, must be presented for scrutineering. They shall be checked for compliance with Appendix L, Chapter III.

The vehicles must be equipped with the medical kit according to 2023 FIA CCRSR Appendix IV-1 and FIA Technical List n°83 and the survival kit according to 2023 FIA CCRSR Appendix IV-2.1, and the defined Safety Type (see SR Art. 1.4).

Because the selective sections are run in the desert and dunes the survival kit must also be carried on board in accordance with the 2023 FIA CCRSR Appendix IV-2.2.

Whenever a vehicle is in motion on any type of Selective Section and until the stop control, the crew must wear homologated crash helmets, all required safety clothing and equipment in compliance with Appendix L Chapter III – Drivers' Equipment of the 2023 FIA ISC as intended by the equipment manufacturer and have their safety belts correctly fastened. Any infringement will be penalised by the Stewards.

10.3 Necessary Technical Installations

10.3.1 Safety Tracking System (2023 FIA CCRSR Article 12.1)

All vehicles must only be fitted with the Safety Tracking System provided by the Organiser. The instruction for the use of the Tracking System is in Appendix 5 of these SR.

Tracking devices shall be collected during the Administrative Checks as per Article 3 Programme. The Tracking Officer will collect the devices from the vehicles at the finish Parc Fermé or service park for retired competitors.

10.3.2 Navigation System (2023 FIA CCRSR Article 12.2)

Competitors are obliged to be equipped with one or two Navigation Systems (NAV-GPS) downloaded with the waypoints given by the Organiser. When a crew uses two NAV-GPS, it must indicate in writing, at scrutineering, which of the two will be considered as the official one. If the primary NAV-GPS is inoperative, the second NAV-GPS automatically becomes the primary one.

10.3.3 Connection of the systems (2023 FIA CCRSR Article 12.3)

The specifications for the standard power connector are laid down in the 2023 FIA CCRSR Appendix VI.

It is the competitor's responsibility to ensure that the Safety Tracking System(s) and the NAV-GPS always remain permanently connected and switched on with the antenna connected throughout the duration of the competition. Any crew that fails to do so, or if it is noted that the any of the systems is not in operation through the fault of the crew, will be reported to the Clerk of the Course and will incur a penalty as per Article 12.3.2 of Appendix I of the 2023 FIA CCRSR.

10.3.4 FIA GPS Data Logger

Vehicle selected by the FIA after the publication of the entry list may be equipped with an FIA GPS Data Logger to monitor their performances during the event. See the 2023 FIA CCRSR Article 13.1.





10.3.5 FIA Accident Data Recorder (ADR)

Competitors equipped with a FIA data logger, according to Appendix J Art. 285, 286 and 287, must make sure to be able:

- To recover the data
- To transmit the recovered data to the FIA by the means at their disposal. It must be transmitted no later than:
- 2 hours after the arrival of the vehicle at the Bivouac/Service Park.
- 1 hour after the entry of the vehicle in the final Parc Fermé of the event. If no service is allowed between the finish of the last Selective Section of the event, and the Final Parc Fermé, a team member will be allowed to enter the Final Parc Fermé to recover the data, with the permission of the FIA Technical Delegate/Chief Scrutineer and in the presence of a scrutineer.
- To update the FIA data logger according to the files provided by the FIA technical department.

The usage of the data transmitted on the CAN line by the FIA data logging system is done under the sole and entire responsibility of the competitor.

In accordance with Article 13.1.3 of Appendix I of the 2023 FIA CCRSR, any finding of non-functioning of the performance monitoring tools through the fault or negligence of the competitor will be penalised in accordance with Appendix I.

10.3.6 FIA On-Board Surveillance Camera (FIA OBSC) (2023 FIA CCRSR Article 13.3) Vehicles selected by the FIA may be equipped with an FIA OBSC to monitor all activities inside the vehicle during the event. Refusal to comply will be reported to the Stewards who may impose a penalty.

10.4 On-Board Cameras

- 10.4.1 Competitors wishing to use a camera must complete the form available on Sportity and email it to the organiser (<u>info@jordanbaja.com</u>) no later than Tuesday, November 14th, 2023.
- 10.4.2 The FIA officials may recover and use the footage at any time.
- 10.4.3 All authorised cameras will be identified by an adhesive decal and must be mounted in the vehicle at the time of scrutineering and shall comply with Appendix J Article 283-2.
- 10.4.4 For further information please refer to Article 11 of the 2023 FIA CCRSR.

10.5 Electronic Equipment

- 10.5.1 Any radio or electronic means of communication, or any other device not expressly permitted in the 2023 FIA CCRSR, or these regulations is forbidden on board the vehicles.
- 10.5.2 Any numbers of telephones, mobile phones or satellite phones carried on board must be given to the Organiser during the administrative checks.
- 10.5.3 During Selective Sections telephones may only be used from outside the vehicle and must be switched off at other times.
- 10.5.4 The use of the telephone on road sections or public roads is not permitted while driving according to Jordanian Traffic Laws.
- 10.5.5 It is optional for the competitors to use a GPS-based Trip Meter. No functions other than measuring (kilometres, times, speeds, course) may be integrated into the GPS Trip Meter as per article 12.4 of the 2023 FIA CCRSR.





10.6 Special national requirements (if any)

10.7 Vehicle Windscreen

In case the windscreen is absent due to an accident, at the start of a Stage, the wearing of a full-face helmet with a visor or goggles of motocross type, or an open face helmet with motocross type of goggles is compulsory for all members of the crew, otherwise the vehicle will not be permitted to start the Stage.

11 Other Procedures

11.1 Drivers' Briefing

- The drivers' briefing will take place in Aqaba Service Park as per Article 3 Programme, we will provide further information about selective sections and answer any questions the crews may have.
- The presence of at least one crew member is compulsory, a penalty of €100 will be imposed for not attending the briefing.
- Team managers are allowed to attend the briefing.

11.2 Pre-Start Areas for Agaba Prologue & Ceremonial Start

- Holding Area will be setup on-site, competitors MUST enter the Holding Area as per Article 3 of these regulations.
- The holding area will be secured. Access is limited to Crew members and Media representatives carrying the appropriate identification\accreditation.
- Vehicles must be driven by one of the drivers or any team member representative to the Pre-Start Holding area where refuelling is strictly forbidden, any kind of other service will be reported to the Stewards who may impose a penalty.
- Entering the pre-start holding area outside the indicated time window according to Article 3 of these regulations up to a maximum 30 minutes, will incur a penalty of €150, any lateness over 30 minutes the competitor involved will be reported to the Stewards who may apply penalties at their discretion.

11.3 Ceremonial Start Procedures & Order

- The Ceremonial Start will take place in the "Arab Revolt Plaza" according to Article 0 Programme of these regulations. It is mandatory for both Crew members to attend.
- The Ceremonial start will be in descending car number order, starting from the last competitor to the first.
- Vehicles will start at one "1" minute interval. Then they will return to the Service Park.
- It is mandatory for all crew members to wear their racing overalls, boots during the Ceremonial Start. Crews not complying with this will be reported to the Stewards who may impose a penalty.
- If a crew is unable to participate in the ceremonial start with its vehicle, it shall be permitted to start the event at its allocated start time, subject to passing the necessary scrutineering checks. The crew concerned must still attend the ceremonial start wearing overalls and at their due time.
- No Time cards will be used in the ceremonial start, once the crew arrives to the preceremonial start holding area they must follow the marshals instructions.

11.4 Electronic Start Procedures

- We will be using Chronomoto timing system with their beams and timing equipment.
- Please refer to Appendix 7 of these regulations for the Start Light procedure in the Selective Sections.





11.5 Prologue

As per Art. 33 and 34.3.3 of the 2023 FIA CCRSR, the points below will be applied ONLY for the Prologue:

- The official itinerary of the Aqaba Prologue is that shown in the road book/navigation device. To assist the competitors, directions and features of the route may be indicated by means of arrows and/or tape and/or on the navigation device. Should a competitor accidentally leave the route he must retrace his tracks and return to that point before continuing.
- There will be several points on the track that (for penalty purposes), will be as WPP (Precise Waypoint) validation radius of 20 meters (the track will be open on the navigation system, but validation will be only 20 meters).
- The penalty for each missing waypoint is the one defined in Article 43 of Appendix I of the 2023 FIA CCRSR.
- Start order will be in descending order, last Car first (after last motorbike) (FIA waiver requested).
- A minimum gap of 10 minutes after the last bike will be given to the first car at DSS P (FIA waiver requested).
- A start interval of at least 1 minute between the competitors will be applied in the Aqaba Prologue stage in accordance with Article 33.1.3 of the 2023 FIA CCRSR.
- A Separate start list will be issued for the Agaba Prologue Stage (DSS P).
- Penalties in accordance with Article 33 of Appendix I of 2023 FIA CCRSR:
 - o Competitor not having started the Prologue: 200% of the maximum time for the Prologue, with a minimum of one hour.
 - o Competitor having started the Prologue and failing to complete it as required: 150% of the maximum time for the Prologue.
 - Non-attendance to the start position selection: 5-minute penalty and start position of the absent driver chosen by the fastest competitor in the Prologue driving a different make of vehicle.

11.6 Finish Procedure

- The crew or a team member must drive their vehicle from the Service Park after opening the Parc Fermé to the Finish Holding Area in the "Arab Revolt Plaza" within the open/close time mentioned in Article 3.
- Holding Area will be setup on-site, competitors MUST enter the Finish Holding Area and follow marshal's instructions.
- The holding area will be secured. Access is limited to Crew members and Media representatives carrying the appropriate identification\accreditation.
- The Podium & Prize Giving will take place according to Article 03 Programme of these regulations. It is mandatory for both Crew members to attend.
- The prize giving/trophies will be given in descending order according to classification.
- It is mandatory for all crew members to wear their racing overalls, boots during the Finish Podium. Crews not complying with this will be reported to the Stewards who may impose a penalty.

11.7 Permitted Early Check In

Early check in is permitted in the following TC's:

- TC 1A Agaba Service Park Service IN
- TC 2A Agaba Service Park Technical Zone IN
- TC 3A Agaba Service Park Service OUT Parc Fermé IN

11.8 Official time used during the Baja

The official time will be according to the GPS (Jordan time = GMT + 3).





11.9 Road books delivery

11.10 Servicing of Vehicles

Refer to Article 49 of the 2023 FIA CCRSR for further information.

11.10.1 Service Areas

- There will be one Service Park for the duration of the 2023 Jordan Baja.
- The Service Park located in Aqaba City Old Port as per Article 2.8.6 of these regulations.
- Servicing the vehicle in the Transfer Zone is allowed only by the Crew using solely the equipment on board and with no external physical assistance except by crews with FIA groups vehicles still in the competition for the current Stage may assist each other.
- Servicing the vehicle by the Service Team is restricted to be done only inside the Service Park, except for retired vehicles intending to re-start may be repaired outside of the Service Park. Obtaining a permission from the CoC is a MUST if the repair will take place inside a selective section.
- Servicing in a closed and/or private place is not authorised. If a car is serviced inside a closed tent, the Clerk of the Course must be informed and any official of the event must be allowed to enter the tent at any time.
- For more details refer to Article 50 of the 2023 FIA CCRSR.

11.10.2 Identification of Team Personnel

• In the service area, only three team personnel may work on a competing vehicle. They will be identified by a distinctive armband supplied by the organizer. The crew may work freely during this period.

11.10.3 Service allowed in Selective Section

- During Selective Sections any service, except that expressly allowed in these regulations, is forbidden. Only crews with FIA groups vehicles still in the competition for the current Selective Section may assist each other.
- To recover a retired or damaged vehicle, service vehicles may enter a Selective Section after the closing of the relevant time controls if permitted to do so by the Clerk of the Course. Such vehicles must travel only in the direction of the Selective Section unless authorised otherwise by the Clerk of the Course.

11.10.4 Flexi Service: N/A

11.10.5 Fuel & Refuelling Zone

In accordance with Articles 51, 54 & 55 of the 2023 FIA CCRSR.

11.10.5.1 Fuel/Refuel

- In the Service Park it is forbidden to refuel.
- Refuelling is permitted only in the designated commercial fuel stations, or in the designated refuel zones. The fuel stations authorized will be indicated in the Road Book with "FUEL STATION".
- Solely for the purpose of assisting with the refuelling procedure of their vehicle, three team members of each crew may access the RZ, one of them being present with a fire extinguisher.





- To access the RZ, all personnel involved in refuelling operations must wear clothing that provides adequate protection against fire and includes at least: long trousers, long-sleeved top, closed shoes, gloves, and a balaclava.
- Engines must be switched off throughout the refuelling operation and the crew must remain outside the vehicle during refuelling.
- It's forbidden to use mobile phones and radio communications while in the RZ.
- If electrical refuelling equipment is used, it must be spark-proof and it and the vehicle must be earthed.
- A vehicle may be pushed out of the RZ by the crew, officials and/or the three team members without incurring a penalty. An external battery may be used immediately after leaving the zone.

11.10.6 Tyre Fitting Zone: N/A

11.10.7 Access times for service vehicles

- The service park will open for logistics operations only as per Articles 2.8.2 & 3 of these regulations, the service vehicles will be allowed to enter the service park on that date only to off-load and setup their service area.
- The service park will be operational as per Articles 2.8.2 & 3 of these regulations.

11.10.8 Service Space

- Service space is included in the entry fee, space allocated for each entrant is 150sqm (15x10m). If the entrant requires more space, he can purchase extra space in 50sqm (5x10) increments at €100/50sqm (5x10m).
- If two or more competitors share the same service area or if the competitor wish to add extra space, the organiser must be informed of this request as per Article 3 of these regulations.

11.10.9 Service plates

• One "Service" plate will be provided to each competitor for free, which can be used for any vehicle, including a truck. Extra plates are available with the following fees:



- "TRUCK" Plate:
 - o Vehicles over 3500kg
 - o These vehicles can enter the service park ONLY as per Articles 2.8.2 & 3 of these regulations they must be parked there until the end of the event.
- "SERVICE" Plate:
 - o Vehicles less than 3,500 kg (van) used as service assistance.
 - o These vehicles can enter in the service park every day of the event.
- "AUXILIARY" Plate:
 - o Vehicles less than 3,500 kg for the transfer of the team staff.
 - o These vehicles can enter in the service park every day of the event.
- 11.10.10 All these vehicles must affix their plate on the top centre of the front windshield.
- 11.10.11 The "SERVICE" / "AUXILIARY" / "TRUCK" Plates must be affixed to the authorized vehicles. During the Baja, no vehicle will be permitted to enter the Service Park unless these plates are affixed. Inside the Service Park the staff in charge for servicing the





competitor's vehicle must wear their armband supplied by the Organizers during administrative checks in a very visible way.



11.10.12 Environmental Mat

Inside the service park and the Parc Fermé competitors are obliged to lay a groundsheet (a minimum of 1 metre longer and 1 metre wider than the vehicle in running order), under their vehicles to avoid the discharge of liquids on the ground (2023 FIA CCRSR 50.2.2).

11.10.13 Garbage Bins

Inside the service park, the organiser will place garbage bins. Competitors must ensure their service location is clean before, during and after the Baja, the Clerk of the Course will report any infringement to the Stewards.

- 11.10.14 All the infringements of the Service and Refuelling rules will be reported to the Stewards who may impose a penalty.
- 11.11 Any special procedures / activities including Organiser promotional activities
 - 11.11.1 Availability of Participants





After parking their vehicles in the Parc Fermé upon passing the finish line, participants must remain available by phone (mobile) until the final classification have been posted.

11.11.2 Classification

The final classification will NOT be distributed after the event. It will be published on the website www.jordanbaja.com and on the Digital Notice Board – Sportity.

11.11.3 Start of the Baja

11.11.3.1 Publication list of crews authorised to start and start list:

- This event is twinned motorcycle event, motorcycles and FIA vehicles are using the same itinerary, the motorcycles will start before the FIA vehicles, no car will start less than 30 minutes after the start of the last motorcycle except for the Prologue as per article 11.5 of these regulations.
- This event is coupled with a national event, the start of the first national car will be given at least 30 minutes after the last vehicle in the international event(s) has started except for the Prologue where the gap between the last vehicle in the international event and the first vehicle in the national event will be 10 minutes only (FIA Waiver requested).
- The starting list for STAGE 1 Section 1, established according to Article 32.1 of the 2023 FIA CCRSR will be published on the Digital Notice Board (see the Programme in Article 3 of these regulations).
- The starting list for STAGE 1 Section 2, established according to Article 33.5 of the 2023 FIA CCRSR will be published on the Digital Notice Board (see the Programme in Article 3 of these regulations).
- The starting list for STAGE 2, established according to Article 32.2 of the 2023 FIA CCRSR will be published on the Digital Notice Board (see the Programme in Article 3 of these regulations).
- 11.11.3.2 Official start of competition: the official competition start of the Baja will take place from TC P0.

11.11.4 Running of the Baja

11.11.4.1 Attention

Whilst the route generally avoids being in proximity of farms and inhabited areas, competitors are advised when driving in the vicinity their speed should be restricted. Crews must always take every precaution to minimize the nuisance and disturbance to all forms of livestock.

11.11.4.2 Road Sections and Selective Sections

- The itinerary of the Baja is made up of Road Sections with a scheduled time and roads open to traffic.
- In accordance with Article 27.1.7 of the 2023 FIA CCRSR, it is forbidden to transport a vehicle by any means (truck, trailer, etc.), except in the case of a retirement in a Stage with regard of Art. 49.1.6.
- The Selective Section on Stage 1 will be run in two parts separated by a Transfer Zone according to Art. 2.43 of the 2023 FIA CCRSR. For service in the transfer zone refer to Article 11.10.1 of these regulations.
- For safety reasons a system of Red Flags deployed by marshals will be positioned to signal competitors to stop or slow down, all competitors must abide by this procedure.
- Any crew which has failed to complete a Stage will be assumed to re-start the event from the start of the next Stage a Section Penalty will be applied.

11.11.4.3 Start Interval



- For Prologue Stage a start interval of at least 1 minute shall be given to all vehicles on the starting list in accordance with Article 33.1.3 of the 2023 FIA CCRSR.
- For SS1 & SS2 a start interval of at least 3 minutes shall be given to at least the first ten vehicles on the starting list in accordance with Article 34.2.1 of the 2023 FIA CCRSR.

11.11.4.4 Speed Control Zone

- In accordance with Article 37 of the 2023 FIA CCRSR.
- The exact speed will be monitored by: Anube Sport.
- Penalties will be applied as per Article 37 of Appendix I of the 2023 FIA CCRSR.

11.11.4.5 Retirement

- Any crew which has failed to complete a Stage will be assumed to re-start the event from the start of the next Stage unless they confirm otherwise to the Clerk of the Course in writing.
- Any crew retiring from Jordan Baja must report such final retirement to the Clerk of the Course as soon as possible, save in a case of force majeure. Failing to abide to this rule will entail a fine of €100.
- Any crew which has retired from a selective section on the last day of the Baja will not be classified.
- In a Selective Section, it is always forbidden to use a surfaced (asphalt, concrete) road other than those indicated in the Road book. If a crew follows a surfaced road and rejoins the route of the Selective Section at a different point, it is deemed to have retired from the Stage, in accordance with Article 14.2.8 of the 2023 FIA CCRSR.

11.11.4.6 Maximum Permitted Lateness

- At Start: Any crew reporting more than 30 minutes late at the start of a Stage shall not be allowed to start that Stage and will be deemed to have retired from the Stage.
- At TC: Any lateness exceeding 30 minutes of any allotted time or an accumulative lateness exceeding 30 minutes at the end of each section or of a Stage will result in the competitor concerned being considered to have retired at that control, and the competitor will receive a Time Control (TC) penalty for each missed TC and, if applicable, a Section Penalty for each Selective Section not started or not completed.

11.11.4.7 Section Penalties

Section Penalties will be applied in Jordan Baja in accordance with Articles 48.1 – V2 of the 2023 FIA CCRSR.

11.11.4.8 Waypoint Penalty

- Each missed Waypoint will be penalised in accordance with Article 43 of Appendix I of the 2023 FIA CCRSR.
- As per Article 43.1.4 if the 2023 FIA CCRSR, the total number of waypoints which may be missed during a Stage is 40% of the total number of waypoints of the Stage concerned. If a crew has less than the required number of waypoints it is deemed to





have retired from the Stage and will be given a Penalty as per Article 43 of Appendix I of the 2023 FIA CCRSR.

11.11.4.9 Maximum Time allowed in the Selective Sections

The Maximum Time allowed in the Selective Sections are:

If Transfer Zone is applicable during the Baja, any competitor who misses to pass through the Transfer Zone (DT) the way point used to define the beginning of the Transfer Zone within a selective section, cannot complete the second part of the selective section.



19 Appendix 4 – FIA ISC Appendix L Extracts

All competitors are reminded of Appendix L of the FIA ISC, in particular its Chapter III - Drivers' Equipment.

- Helmets (Appendix L, Chapter III, Art. 1)
 - All crews must wear crash helmets homologated to one of the FIA standards listed in Appendix L.
- Frontal Head Restraint (FHR, Appendix L, Chapter III, Art. 3)
 - All crews must use FIA approved FHR systems homologated to FIA standard 8858.
 - Approved FHRs, anchorages and tethers are listed in Technical List N° 29.
 - See also helmet compatibility chart in Appendix L, Chapter III, Art. 3.3.
- Flame-resistant clothing (Appendix L, Chapter III, Art. 2)
 - All drivers and co-drivers must wear overalls as well as gloves (optional for co-drivers), long underwear, a balaclava, socks, and shoes homologated to the FIA 8856-2000 (Technical List N° 27) or FIA 8856-2018 (Technical List N° 74). Please pay special attention to the prescriptions of Art. 2 concerning the correct wearing of the clothing elements! See also FIA Cross-Country Rally Sporting Regulations Article 47.1.
 - Any FIA-approved 8856-2018 garment customised using printing or transfers must be accompanied by a certificate from the manufacturer.
 - FIA Priority drivers (and accompanying co-drivers) must wear overalls as well as gloves (optional for co-drivers), long underwear, a balaclava, socks, and shoes homologated to the FIA 8856-2018 standard (Technical List No 74).
- Biometric Devices (Appendix L, Chapter III, Art. 2.1)

 Drivers may wear a device to collect biometric data during racing.
 - If the biometric device is integrated into a protective garment homologated to FIA Standard 8856, the garment shall be homologated to FIA Standards 8856 and 8868-2018.
 - If the biometric device is a stand-alone device, then the device must be homologated to FIA Standard 8868-2018 only. This device must be worn in addition to the garment homologated to FIA Standard 8856.
- Wearing of jewellery (Appendix L, Chapter III, Art. 5)
 The wearing of jewellery in the form of body piercing or metal neck chains is prohibited during the competition and may therefore be checked before the start.
- MEDICAL AND SURVIVAL KIT (Appendix IV of the Cross-County Rally Sporting Regulations)
 A sealed and valid medical kit in accordance with the Specification for Cross Country Rallies and
 Bajas (Technical List n°83) must be placed inside the cockpit. The minimum weight must comply
 with Technical List n°83.
