The Stewards, having received a report from Clerk of the Course (document No. 3.6), having examined track from tracking system, summoned and heard the driver Catherine RADULESCU and co – driver Bogdan MINEA (summons No.2, Doc No. 4.2), have considered the following matter, determine the following:

**Fact:** Car no 35 missed refuel zone

**Time:** 24 September 2022. 11:42 hrs

**Offence:** Breach of Article 19.2 of the FIA Regional Rally Sporting regulations

**Decision:** To levy a fine EUR 250

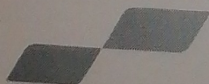
In accordance with Article 12.8 FIA International Sporting code the payment of the fines must be done online, within 48 hours of their notification, at the following address: <https://fiafines.fia.com>. Any delay in making payment may entrap Suspension during the period a fine remains unpaid.

**Reason:** Clerk of the Course reported that car no. 35 deviated from the route defined in the Road Book. The tracking system log shows that on 24 September 2022 at 11:42 hrs car no 35 left defined route between SS2 and TC2A missing a stop on refuel zone (RZ2).

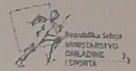
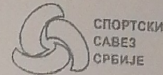
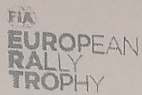
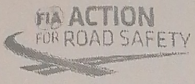
After communication from the Clerk of the Course the proof was given as by the GPS tracking for this crew.

When the drivers arrived in the Stewards room, they explained that they were not aware that it is mandatory to enter to the refuel zone and follow the Road Book. They explained that they didn't need a refuelling, and that is why they didn't stop to the refuel zone.

According to Art. 19.2 of the FIA Regional Rally Sporting Regulations all crews must follow the detailed description of the compulsory itinerary.







The refuel zone was in the road book, but crew no. 35 deviated from rally route.

The Stewards concluded that leaving the defined route is an infringement of the sporting regulation. The Stewards in application of Art. 11.9.1; 11.9.3.a; 12.3.1 and 12.4.1.c of the 2022 International Sporting Code, decided to levy a fine, since the deviation was only missing the part of the road to refuel and back.


