

The Stewards, having received a report from Chief Scrutineer with photo evidence, have considered the following matter, determine the following:

**Fact:** During routine checks at the Shakedown start, car No. 18 was found with the control unit of the extinguishing system not in operating condition.

Offence: Breach of Article 253-7.2 of Appendix J to the 2025 FIA International Sporting Code.

Decision: To impose a fine of 250 € on Competitor.

In accordance with Article 12.8 of the FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification on the <a href="https://fiafines.fia.com">https://fiafines.fia.com</a>. Any delay in making payment may entail Suspension during the period a fine remains unpaid.]

## Reason:

As stipulated in Art. 253-7.2.4 of Appendix J to the 2025 FIA International Sporting Code, the system must work in all positions. Art. 253-7.2 of Appendix J to the 2025 FIA International Sporting Code does not specify when the system can be switched on or switched off. For this reason, it must always be active during the rally.

The fire extinguishing system is a major safety item to protect the crew in case of fire in the car and it is essential for the crews' safety.

Safety remains a key challenge and the FIA is committed to do everything possible to protect, among others, the crew.

The team announced via the CRO that they won't make any representations and apologized for the lapse. The Stewards therefore conclude that this is a breach of Art. 253-7.2 of Appendix J to the 2025 FIA International Sporting Code.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Art. 15 of the 2025 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.
