The Stewards, having received a report from Clerk of the Course and from Reconnaissance Tracker Provider RDS, heard the co-driver YEVHEN CHERVONENKO, have considered the following matter, determine the following:

**Fact:** Crew of the car No 4 entered SS 10/12 Santopadre on Thursday, 27<sup>th</sup> July at 11:00.

**Offence:** Breach of Art 35.4.1 of the 2023 FIA Regional Rally Sporting Regulations and Appendix

2 of the Supplementary Regulations.

Decision: Driver Alexey Lukyanuk, and co-driver Yevhen Chervonenko shall be jointly and

severally liable to pay a fine of € 500.

In accordance with Article 12.8 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: <a href="https://fiafines.fia.com">https://fiafines.fia.com</a>. Any delay in making payment may entail Suspension during the

period a fine remains unpaid.

Reason: The Stewards received a report from Clerk of the Course on Thursday, 27<sup>th</sup> July at 18:30

concerning reconnaissance car of competitor No 4 being seen by marshal on SS 10/12 Santopadre (post 23 – km 3,65) on Thursday, 27<sup>th</sup> July at 11:24. Further on according to the report from Reconnaissance Tracker Recorder provider RDS, the reconnaissance car of competitor No 4 was on Special Stage 10/12 Santopadre from 11:00:06 until

11:50:59.

Considering that according to Appendix 2 of the Supplementary Regulations the reconnaissance on Special Stage 10/12 Santopadre was only allowed on Thursday, 27<sup>th</sup> July starting from 12:00 hrs, this is the breach of FIA Regional Rally Sporting Regulations and Supplementary Regulations of the rally.

Article 35.4.1 states that the reconnaissance must take place according to a timetable set by the organiser. Therefore, the driver of car No. 4 was duly warned about his future conduct.

Under the above circumstances and considerations, the Stewards concluded that the above penalty as imposed is proportional.





Competitors are reminded of their right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
