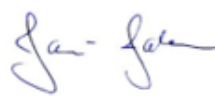
The Stewards, having received a report from FIA Technical Delegate (Document 6.3.4.), have considered the following matter, determine the following:

Fact: Late Tyre Registration.
Offence: Breach of the FIA European Rallycross Championship Supplementary Regulations Part-2, Article 10.1.
Decision: Fine 250 €
 [In accordance with Article 12.8 of the FIA International Sporting Code, fines shall be paid within 48 hours of their notification. Any delay in making payment may entail Suspension during the period a fine remains unpaid]
Reason: The Competitor was late submitting their tyre registration. Supplementary Regulation's Part 2 Scrutineering (Article 10.1). Registration was to be no later than 17:00 on Friday 22nd August. The Registration was received at 19:53.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
