The Stewards, having received a report from Race Director, regarding an incident between Car 96 and Car 12 at Turn 3, have considered the following matter and determine the following:

No / Driver:	World RX - 96 – Ole Christian Veiby
Competitor:	Kristofferson Motorsport
Time (fact):	16:25 – 20 September 2025
Session:	World RX Final
Fact:	Car 96 allegedly contacted with car 12 in final lap at Turn 3 gaining advantage.
Infringement:	Alleged breach of Article 2.b - Chapter V - Appendix L of the ISC and Article 6.5 of the applicable Sporting Regulations.
Decision:	No further action.
Reason:	The Stewards summoned and heard the Competitor Representatives and drivers of Car 96 and Car 12. The Stewards reviewed the host streaming, the CCTV and the on board cameras from both cars. Driver of Car 12 stated that she was doing Turn 3 and at the finish of the turn she was pushed and in Turn 4 she was overtaken by the inside. Driver of Car 96 said that car in front made a mistake and was wide and he tried to overtake by the inside being side by side from Turn 3 to Turn 4. Having examined the matter extensively, the Stewards considered that approaching Turn 3 Car 96 was just behind Car 12 which by mistake was wide in the turn and Car 96 took advantage to try an inside overtake while Car 12 tried to drive again to find the racing line, resulting a racing side by side contact In the light of this specific case the Stewards considered that no driver was wholly or predominately at fault, therefore the Stewards determined that the appropriate action is to take no further action.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
