The Stewards, having received a report from FIA Technical Delegate, have considered the following matter and determine the following:

Time (fact): 14:30

Session: After Free Practice 2

Fact: The VCU data of Car #68 was not offloaded on FIA NAS within one hour after the end of the run (Free Practice 2).

Infringement: Breach of Article 279E of the Appendix J of the International Sporting Code (Battery and Powertrain kit Art. 1.1) in conjunction with the Kreisel Instruction Manual.

Decision: A fine of 3.000 Euros to the Competitor, which is suspended, subject to no repeat of a similar infraction between now and the end of the season.

Reason: The Stewards received a FIA Technical Delegate report (report n° 4). The FIA Technical Delegate stated that the VCU data of Car #68 was not uploaded within the one-hour timeframe after the end of the run of Free Practice 2, as it is stipulated in the applicable regulations. After reminder to the Team, VCU data was uploaded by the team at 14:30h.

The Stewards summoned and heard the team representative (Summons n° 2). The Team Representative admitted the fact, because the team personnel in charge had connected to the wrong network, instead of the FIA network with connection to the internal NAS, therefore it was a human mistake. He pointed out that, as soon they received the reminder from FIA staff they immediately connected to the correct FIA network and data was uploaded.

Even though a human mistake happened, the Stewards determined that the Competitor personnel failed to follow the applicable regulations therefore a breach of the regulations have been committed.

The Stewards, taking into account that particularity of the case, regarding team personnel did not follow the formalities provided in the regulations, elect to impose 3,000 Euro fine applied with suspension of sentence, subject to no repeat of a similar infraction between now and the end of the 2025 FIA World Rallycross Season.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
