The Stewards, having received a report from FIA Technical Delegate, have considered the following matter and determine the following:

Fact: Car #21 World RX has been changed the rear MGU (electric motor).

Offence: Alleged breach of Article 9.3.2 of the FIA World RX Sporting Regulations 2025.

Decision: Joker granted in accordance with Article 9.3.2 of the FIA World RX Sporting Regulations 2025.

Reason: The referred Article 9.3.2 states as follows:
 9.3.2 Electric motors, RESS and inverters will be sealed. A Driver may use up to 2 (two) electric motors (or sets of seals), 1 (one) battery pack (or set of seals) and 2 (two) inverters (or sets of seals) in a Championship season. Electric motors, RESS and inverters will be sealed.

The penalty for any breach of this rule, the use of more components than allowed in the Championship year, will be the deduction of 15 (fifteen) Championship points for each offence. These points will be deducted from the Championship point total scored by the Driver and Team. In exceptional circumstances (accident generating serious damage to the components or technical problem not imputable to the Competitor), jokers may be granted at the discretion of the FIA stewards following the technical report from the appointed supplier and the FIA technical delegate.

The stewards reviewed the report from the FIA Technical Delegate in addition to the report from the supplier Kreisel who explained Motor was exchanged on Car #21 Timmy Hansen because of a significant gearbox oil leakage from the gearbox into the electric motor. To avoid errors and damage the motor was exchanged to the spare rental motor from Kreisel. Also, the seal on the gearbox was opened to repair the sealing on the input shaft. (RX1E235)

The Stewards therefore agreed that a joker is granted in accordance with Article 9.3.2 of the FIA World RX Sporting regulations 2025.


