The Stewards, having received reports (6.3.3) from FIA Technical Delegate, have considered the following matter and determine the following:

Time (fact): 22.8.2025, report 6.3.3 17.00

Session: Scrutineering

Fact: To the RX1e car number 21 (driver: Timmy HANSEN) the seals of front and rear motors have been opened.

Infringement: Alleged breach of Article 9.3.2 of the FIA World RX Sporting Regulations.

Decision: Joker granted in accordance with Article 9.3.2 of the FIA World RX Sporting Regulations.

Reason: The referred Article 9.3.2 states as follows:

9.3.2 Electric motors, RESS and inverters will be sealed. A Driver may use up to 2 (two) electric motors (or sets of seals), 1 (one) battery pack (or set of seals) and 2 (two) inverters (or sets of seals) in a Championship season. Electric motors, RESS and inverters will be sealed.

The penalty for any breach of this rule, the use of more components than allowed in the Championship year, will be the deduction of 15 (fifteen) Championship points for each offence. These points will be deducted from the Championship point total scored by the Driver and Team. In exceptional circumstances (accident generating serious damage to the components or technical problem not imputable to the Competitor), jokers may be granted at the discretion of the FIA stewards following the technical report from the appointed supplier and the FIA technical delegate.

Seals of motors have been opened to check possible gearbox oil leak to avoid major damage on the motor.

The Stewards therefore agreed that a joker is granted in accordance with Article 9.3.2 of the FIA World RX Sporting regulations.

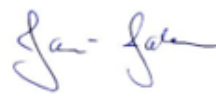
