The Stewards, having received a report with photo evidence from the FIA Safety Delegate, after inviting and oral hearing of the representative of the Organiser (the position of the Organiser was presented by the Clerk of the Course Manuel Vidal), have considered the following matter, and determine the following:

**Fact:** Car No "0", nominated by the Organiser, filled the fuel in an unauthorized place - in the service park; did not stop at the SS stop points even after the warning of the FIA Safety Delegate, performed via radio communications.

Offence: Breach of Article 61.1 of 2023 FIA Regional Rally Sporting Regulations.

Decision: Reprimand to the Organiser CLUB DEPORTIVO TODO SPORT.

## Reason:

The crew of the car No "0", nominated by the Organiser, did not comply with the established requirements, procedures, rules, created a dangerous situation.

The Clerk of the Course explained during the hearing that he was ready to instruct the members of the crew of the "0" car, but did not do this, because when the event began, there was a lot of work, and the said briefing remained unfinished, in the hope that the crew members with officially issued competition licences would not do something unusual. He assured that he really had with him all the material that was prepared for the coaching of the members of the crew of the "0" car.

During the hearing, the Organiser, represented by the Clerk of the Course, assumed responsibility for selecting the appropriate persons to perform the tasks assigned to them and for their proper training.

Since the representative of the Organiser acknowledged the violation committed, the lenient penalty to be imposed on the Organiser – a Reprimand.

The decision is based on the FIA International Sporting Code Art. 11.9.1, art.11.9.2.a, Art. 11.9.3.a, Art. 11.9.3.f and Art 12.4.1.b.

The Organiser is reminded of his right to appeal certain decision of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
