To operationally facilitate the pre-race management of the various categories involved, Mr. Competitors / Drivers are strongly requested to scrupulously follow the current F.I.A. / A.C.I. sporting rules, as well as the provisions of this circular, regarding:

A. EVENT REGISTRATION

REGISTRATIONS FOR INDIVIDUAL SCHEDULED RACES

All entries must **imperatively** be received by MUGELLO CIRCUIT S.p.A. by Friday 5th July 2024 and must be accompanied by the appropriate entry fees. Registration must be made as follows:

Competitors with an Italian license

1. Mandatory:

By means of the on-line "pre-registration" procedure on the ACI website (information on how to use this procedure can be found on the Aci Sport website).

<u>Please note that pre-registrations, once taken in charge by the organizer will no longer be visible</u> nor editable by the competitor.

N.B. A competitor with an Italian license may enter drivers with foreign licenses in the race.

The pre-registration, even if accepted, to be validated must be followed by attaching the copy of the payment on "Circuit Enter".

2. Mandatory registration on the Circuitenter.it website

Documents to upload to the platform:

- Valid Competitor License and Driver License(s) (front/back)
- Copy of medical certificate (if not present on the licence)
- Driver(s) qualification (if not present on the licence)
- ASN authorization in the case of foreign driver(s) (mandatory if it is not shown on the license itself)
- Payment statement
- Copy of renewal of any expired documents (medical certificate and/or ACI association)
- Copy of free practice liability release
- In the case of a minor driver, self-certification of parental authority, and a copy of the identity documents of the minor and his parents.
- Clothing statement

Competitors/Conductors with foreign licenses

1. Mandatory registration on the Circuitenter.it website

Documents to upload to the portal:

- Valid Competitor License and Driver License(s) (front/back)
- Medical fiche (if it is not shown on the license itself);
- ASN authorization of belonging in the case of foreign driver(s) (mandatory if it is not shown on the license itself)
- Payment statement
- Copy of free practice liability release
- In the case of a minor pilot, self-certification of parental authority, and a copy of the identity documents of the minor and his parents
- Clothing statement

The entry in any case is considered valid and finalized ONLY when the relevant entry fee is paid.

The liability release (M-126 and M-127) must be filled in all its parts, signed and uploaded on "Circuit Enter".

FOR FREE PRACTICES WILL BE DELIVERED A STICKER TO BE APPLIED TO THE CAR (WINDSHIELD ON THE UPPER LEFT SIDE OF THE DRIVER'S SIDE FOR TURISMO AND GT CARS AND ON THE NOSE ABOVE THE NUMBER FOR FORMULA AND PROTOTYPE CARS) THAT WILL ALLOW ENTRY TO THE TRACK FOR THEM.

C. BOX

1. BOX RESERVATIONS

The box reservation request should be done on "Circuit Enter" website no later than day 7th July 2024 (M-121). The assignment of the boxes will be made by ACI Sport and the confirmation of the assignment of the pit garage will be done by e-mail directly from "Circuit Enter" portal, with the payment request.

The reservation request should indicate:

- a) Name of the requesting Team with telephone, fax, and e-mail contact details
- b) Number of boxes needed
- c) Number of cars entered and their respective category
- d) Name, Surname, and cell phone number of a responsible person

Box reservations will not be considered unless at the same time as registration.

2. COSTS

The cost for the entire Weekend (Friday, Saturday, and Sunday) of each box is as follows:

3. PAYMENT

Payments can only be made in advance by Bank Transfer immediately after receipt of the assignment confirmation to the same bank details as the registration payment above. The copy of the payment must be uploaded to "Circuit Enter" portal.

4. KEY PICKUP AND RETURN

The boxes will be made available as of 09.00 on Thursday 11th July 2024.

Delivery of the keys will be made at the main entrance (red helmet) who will arrange for the relevant forms to be signed and collect a deposit of 100.00 euros as security for any damage, that will be returned when the keys are handed back, at the Circuit main entrance (red helmet).

5. SECURITY PROVISIONS WITHIN THE BOX

- ✓ Smoking or the use of open flames is prohibited inside the boxes
- ✓ Inside the boxes it is forbidden to deposit flammable materials (gasoline, etc.), which should be stored outdoors;
- ✓ Leave fire hydrants, fire extinguishers and any other fire-fighting equipment visible and accessible;
- ✓ Ensure that emergency exits, transit areas and escape routes are fully accessible, avoiding any obstruction;
- ✓ Deposit waste oils in the appropriate containers located at different points inside the Circuit;
- ✓ In case of accidental spills of flammable liquids, oils or substances that may make the pavements slippery, promptly remove and clean them;

6. BOX CLEANING

Reminder to all participants that both paddocks and boxes must be returned free of any tyre, which should be disposed by the participants. In case of non-compliance the costs for the disposal will be charged to the offender.

- ✓ It is forbidden to apply stickers of any kind to the pit floor.
- ✓ The boxes shall be sanitized daily by the occupants using cleaning chemicals.
- ✓ Before the keys are returned, they must be cleared of any material not present at the time of delivery





✓ At the end of the event, any tape placed on the floor from the pit lane must be removed to have a clean surface. A fine of €150 will be applied if the tape is not removed properly.

2. CIRCUIT ENTRANCE

Access to the Paddock is in compliance with the economic and legislative provisions in force at the time

Entry to the circuit is permitted:

- Wednesday 10 th July 2024	from 15.00	to 20.00 (only IF4C e PCCI)
- Thursday 11 th July 2024	from 09.00	to 20.00 (only box)
	from 14.00	to 20.00 (paddock)
- Friday 12 th July 2024	from 08.00	to 20.00
- Saturday 13 th July 2024	from 08.00	to 20.00
- Sunday 14 th July 2024	from 08.00	to 14.00

Please strictly observe these times.

Transportation of materials and/or movement of heavy vehicles are not allowed during night hours unless specifically authorized by the Circuit Management.

During the weekend, access to the main paddock for loading and unloading of materials will only be allowed for a maximum duration of 45 minutes.

3. ADMINISTRATIVE CHECKS

COMPETITORS AND DRIVERS WITH ITALIAN LICENSES

ONLY AND EXCLUSIVELY competitors/drivers who are not in good standing with the documents sent with the registration or with documents that have expired in validity must present themselves.

COMPETITORS AND DRIVERS WITH LICENSES OTHER THAN ACI LICENSES

WILL HAVE TO COMPULSORILY PRESENT THEMSELVES TO CARRY OUT THE SPORTING VERIFICATIONS (DOCUMENT CONTROL AND SIGNATURE VERIFICATION FORM).

The Verifications will be held at Race Secretariat (1st floor – Stair B):

- Thursday 11th July 2024 from 14.00 to 16.00 (only IF4C)

- Friday 12th July 2024 from 09.00 to 11.00

4. TECHNICAL SCRUTINEERS

As per regulations, pre-race scrutineering will be conducted in attendance at pit garage nr. 19-20 at the times set on the timetable.

ATTENTION:

The "Declaration of safety clothing conformity" duly completed must be uploaded on "Circuit Enter" and must be presented in original form to the scrutineering.

The competitors may use the equipment located in the scrutineers garage, always respecting the Circuit Regulations.

5. TEAM MANAGERS AND DRIVERS BRIEFING

Briefings will be held at the BRIEFING ROOM located 2nd floor Stair A.





6. EXIT BILGES DISMANTLING STRUCTURES

We remind all participants that the dismantling of structures and the movement of vehicles may take place - for safety reasons - only at the end of the last scheduled race.

Any failure to comply with this provision will be reported to the Stewards for the measures provided for in the Regulations.

F. CIRCUIT LOGISTIC

1. MINORS

Minors (except for those holding an ACI Sport/FIA driver's license) are not allowed access to sensitive areas (Paddock, Box, Pit-Lane, Press Room, Race Direction, and related offices). Access to the Paddock is allowed only to reach the Team hospitality area.





2. TELEVISION SIGNAL DISTRIBUTION

Please note that the distribution of television signals inside the boxes and paddock of the Circuit is in digital terrestrial HD. You are requested to tune your equipment to receive the TV signal distributed inside the Circuit.

3. AUDIO-VIDEO BROADCASTS

We remind you all those who during the event will use within their hospitality / tensile structures etc. audio and / or video equipment there is an obligation to pay SIAE rights, which must be made in advance at:
