The Stewards, having received a report from the FIA Deputy Technical Delegate with photo evidence attached, summoned the above crew members as well as a competitor's representative, have considered the following matter and determine the following:

Facts On Sunday 3rd August 2025, during routine checks at TC18D, car No. 49 was found with an onboard camera fitted between the seats, its support protruding further from the rearmost plane of the backrest.

Offence Breach of Article 253-2 of the Appendix J to the 2025 FIA International Sporting Code

Decision **Fine of € 500 on the Competitor of car No. 49**

In accordance with Art. 12.8 of the 2025 FIA International Sporting Code, fines shall be paid within 48 hours of their notification. Any delay in making payment may entail Suspension during the period a fine remains unpaid..

Reason The Competitor was informed accordingly by the Stewards and was given the possibility, if he wished, to bring forward any representations other than having forgotten to install the camera correctly.


The Competitor Representative of Car No. 49 Ms. Alexia Desnoyer, the Team Principal Mr. Antony Desnoyer, the driver Mattéo Chatillon and the co-driver Maxence Cornuau appeared in front of the Stewards on Sunday 3rd August 2025 at 16.30 hrs.

The crew stated that when they fitted the camera on its arm, they forgot to check the compliance with Article 253-2 of the Appendix J to the 2025 FIA International Sporting Code and they apologised for their lapse.

The Stewards reminded them that safety remains a key challenge and the FIA is committed to do everything possible to protect, among others, the crew.

The Stewards therefore conclude that this is a breach of the above-mentioned article and the above fine penalty is appropriate in this case.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2025 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.
