The Stewards, having received a report from FIA Technical Delegate (Doc No 6.2), with photo evidence attached, summoned and heard the Team manager, Mr. Efren Llarena, Team coordinator, Ms. Sara Fernandez, have considered the following matter, determined the following:

Fact: During the qualifying stage, the Crew of Competitor Car No. 17 used four tyres that were not authorised.

Offence: Breach of Art. 13.3.1 of the FIA 2025 RRSR V1A

Decision: to impose a disqualification from the Qualifying stage on the Competitor Car No. 17

Reason: The Stewards have received a report from the FIA Technical Delegate (Doc No 6.2) with photo evidence that the Competitor car No. 17 used four tyres that were not authorised during the qualifying stage.
Art. 13.3.1 of the FIA 2025 RRSR V1A states:
Only the types of tyres specified in the list published by the FIA are authorised.
Competitors must confirm with their supplier that the barcode numbers of the tyres they wish to use are included on the list submitted to the FIA Technical Delegate.

During the hearing, the competitor's representatives acknowledged the violation and explained that it was due to a mistake made by the team.

The regulations concerning tyres are designed to ensure that all competitors have access to identical equipment in terms of specification and performance. By using tyres that fall outside the authorised list, even if unintentionally, the competitor introduces a variable that could affect performance, durability, or behaviour in ways not available to other competitors.

For this reason, and in line with the principles of fairness, the Stewards have decided to apply the penalty above.

The decision is based on the FIA International Sporting Code Art. 11.9.1, Art.11.9.2.a, Art. 11.9.3.a, Art.11.9.3.f, 12.4.1.m.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
