Crew GRÉGOIRE MUNSTER / LOUIS LOUKA

The Stewards, having received through the Clerk of the Course a report from an official, summoned the above crew members as well as a competitor's representative, have considered the following matter and determine the following:

Facts The above addressed Crew were warming tyres on a road section and crossed the

traffic lane demarcation line (yellow continuous line) on 10th November 2022 at 10:39

hrs.

Offence Breach of Article 34.3.1 of the 2022 FIA WRC Sporting Regulations and Article 12.5

of the Supplementary Regulations.

Decision Fine of € 450 on Competitor No. 24 (GRÉGOIRE MUNSTER) as per Article 34.3.4 a)

of the 2022 FIA WRC Sporting Regulations (1st traffic infringement other than

speeding during the competition element of the rally).

In accordance with Art. 12.8 of the 2022 FIA International Sporting Code, fines shall be paid within 48 hours of their notification. Any delay in making payment may entail

Suspension during the period a fine remains unpaid.

Reason The Stewards heard the driver/co-driver of car No. 24 on 10th November 2022 at 13:30

hrs in the presence of Team Co-ordinator LAURA BORGES and played the video of the recorded evidence submitted by the Officials. The video showed the Crew weaving across the road twice where the car's tyres crossed the lane demarcation line (yellow centreline). The video also showed the car speeding up and braking

heavily in a manner to warm up tyres.

The Crew stated admittingly that they recognised the offence that occurred and in

hindsight such driving behaviour was incorrect.

The Stewards decide to levy a fine for this 1st infringement as they recognised two violations, the act of warming up tyres in a forbidden location and crossing the yellow centreline. The act of warming tyres and driving erratically, in the manner seen in the video, does endanger or inconvenience other traffic or people living near these traffic routes. Moreover, crossing of the yellow centreline is also accounted for as a violation

of local traffic regulations.

Competitors and Crews are reminded of the importance of abiding by traffic regulations while driving on roads as stipulated in the 2022 FIA WRC Sporting Regulations and the Supplementary Regulations, which forbids the warming of tyres outside of tyre warming zones. Moreover, the COC had issued multiple Communications regarding Japanese Traffic Regulations.
