4. ENTRIES

4.1. Closing date for entries

The closing date and time for entries is Tuesday, 12 August at 23:59 hrs Central European Time (17:59 CLT).

4.2. Entry procedure

WRC Manufacturers / Teams, WRC2 and WRC3 competitors who wish to score points, must make their entries by using the electronic standard rally entry form for their championships available in the FIA application at https://registrations.fia.com/rally.

Any driver in the WRC2 championship wishing to enter WRC Rally Chile BIOBÍO 2025 as a Priority 2 driver, but not wishing to collect points for their championship, must also use the standard FIA entry form but shall not nominate to score points.

Any driver in the WRC3 Championship wishing to enter WRC Rally Chile BIOBÍO 2025 without scoring WRC3 Championship points shall enter as a non-priority driver using the non-priority entry form as detailed below.















Any non-priority competitors wishing to take part in WRC Rally Chile BIOBÍO 2025 must register and fill in the electronic entry form published at https://registrations.fia.com/wrcchl duly completed before the closing date for entries.

Please note that as the FIA system requires a username and a password to access the entry system, leave time for the FIA to open your user account. The user account application can be found through a link from the registration page as given above.

The entry application will be accepted only if accompanied by:

- The payment of the total amount of the entry fee.
- Photocopies of:
 - International competition licenses of the competitor and both crew members
 - Valid driving licenses of both crew members
 - First page of the car homologation form with the number, group, and cylinder capacity
 - Scanned pdf copy of a Signed Entry Form
 - Insurance cover (third parties for the rally car)
- Foreign drivers must submit an approval from their ASN

Referring to Art 6.2.1 and Art 6.3.1 of the 2025 FIA WRC Sporting Regulations, the drivers willing to score points in WRC2 or WRC3 Championship must register with the FIA before the closing date of entries of the first rally entered.

By submitting an electronic form, the competitor undertakes to abide by the rules and regulations of the competition, as well as the prescriptions of the 2025 FIA WRC Sporting Regulations Art. 22.5 and allows to publish the information mentioned in this entry application in the media.

If a competitor cannot make the entry on the internet, he must contact the rally secretariat before closing of entries for further instructions.

Duly completed, PRINTED entry form signed by both crew members and the competitor must be presented at the administrative checks by the representative of the team.

4.4. Entry fees / Entry packages

4.4.1 Entry Fees















Manufacturers, other WRC cars and competitors in the Support Championships

Entry fees for Manufacturers, WRC Teams and competitors in all WRC Support Championships (i.e. WRC2, WRC3 as defined in the 2025 FIA WRC Sporting Regulations) are waived from the WRC Rally Chile BIOBÍO 2025.

Entry fees for non-priority competitors are also waived from the WRC Rally Chile BIOBÍO 2025.

Drivers registered in the COPEC RallyMobil Championship the entry fee will be UF 9 + VAT.

If a competitor wishes to decline Organiser's optional advertising, a charge of €3,000 applies. This applies also to any competitor entered in class RC1 if not Manufacturer or WRC Team.

4.6. Refunds

The entry fee will be refunded in full:

- To candidates whose entry has not been accepted
- In case of the rally not taking place

The Organiser may partially refund entry fees if a competitor cannot take part in the event due to a duly proved case of force majeure. This must be applied for in writing (eberrios@rallychilebiobio.com), giving the reason of withdrawal before Monday, 08 September 2025 (start of administrative checks), including competitor's bank details.

5. INSURANCE

5.1. Traffic insurance

All cars participating in the rally must have a valid obligatory traffic insurance towards third parties for Chile. A local insurance for foreign recce cars must be taken in Chile. Traffic insurance guarantees competitor's cover for civil responsibility towards third parties on road sections. All competitors must be able to show their insurance cover at administrative checks. The burden of proof for a valid insurance rest solely on the competitor.

5.2. Organiser's liability insurance

The Organiser provides a public and products liability insurance with the cover of € 25.000.000 per any one occurrence for the duration of the rally.

5.3. Damage caused to the third party















Competitors are reminded that only damage caused to third parties by the Organisers and the entered drivers is covered by the insurance policy taken by the Organisation. Injury to the drivers themselves or damage to participating cars is not covered by this insurance. By submitting their entries, the competitors, drivers and car owners waive any claims or rights to pursue action for damages in connection with the event against the Organiser.

5.4. Damage reporting in case of an accident

The competitor or their representative must notify Rally Control phone (TBC) as quickly as possible. The circumstances under which the accident occurred, eventual causes and consequences must be explained. Likewise, the names and addresses of any witnesses and any eventual injured people must be given.

5.5. Limitation of indemnity

The Organiser declines any liability concerning the consequences caused by any fraudulent action taken by the competitor, may this be against the rules and regulations of the rally or against the laws of the country. Any service vehicles or reconnaissance cars, even those bearing the official identification of the WRC Rally Chile BIOBÍO 2025 Supplementary Regulations, may under no circumstances be considered as official participants of the rally, hence their insurance policies remain the sole responsibility of the owner.

6. ADVERTISING AND IDENTIFICATION

6.1. Advertising Restrictions

In Chile advertising for tobacco and alcohol (with some restrictions) is forbidden. These laws apply to competition cars, service cars, team equipment and/or clothing.

6.2. Organiser's advertising

The Organiser's obligatory and optional advertising on the doors, roof and rear window plates are BIOBÍO, COPEC and ARAUCO.

6.3. Identification

Competition numbers are according to the 2025 FIA WRC Sporting Regulations, Art. 27. and Appendix IV of these Supplementary Regulations. These must be visible through the whole duration of the rally.

Numbers and plates must be affixed on the rally car before the car is brought to scrutineering.

Pay attention to Art. 29.5 of the 2025 FIA WRC Sporting Regulations: Championship Identification and Advertising

All 4WD cars must use tyres from the FIA nominated tyre company **HANKOOK**.

For all 2WD cars the make and type of tyre is free However, competitors are reminded to comply with:

- 2025 FIA WRC Sporting Regulations, Art. 13.1.4; Each tyre must have barcode numbers supplied by the 2025 FIA-approved barcode supplier.
- 2025 FIA WRC Sporting Regulations, Art. 13.3.1.
 - At pre-rally scrutineering, the tyre manufacturer will be recorded by the FIA.
 - During the whole rally, all tyres must come from the same tyre supplier.

7.2. Tyre quantities for use during the rally

The maximum number of tyres for the rally (including shakedown) is **28** for Rally1 cars and **26** for all other cars. In accordance with Art. 13.2.5 of the 2025 FIA WRC Sporting Regulations the maximum number of tyres of the alternative choice for all 4WD cars is either 8 or 12.

The FIA must be notified at wrc-technical@fia.com before the start of the Shakedown of the number of tyres of the alternative choice that the competitor wishes to use (P1 competitors must notify of their choice by Tuesday, 09 September 2025, 18:00 hrs). Alternative compound tyres are not required to be used in the Shakedown.

This choice neither increases nor decreases the maximum number of tyres for the rally. If the competitor wishes to have 12 alternative compound tyres for use in the rally instead of 8, the number of tyres of the first choice will automatically be reduced by 4 tyres.

7.3. Tyre orders

Tyre orders must be placed no later than on Thursday,03 July 2025 using the Order Hankook Form available on www.rallychilebiobio.com.

7.4. Tyres for use on reconnaissance

Free tyres for gravel (2025 FIA WRC Sporting Regulations, Art. 35.2).















7.5. Tyre marking zones

The Tyre Marking Zone for Shakedown is in the Technical Zone before Shakedown start.

Tyres are marked also after these time controls: TC0, 3C, 6C, 9C, 12C

7.6. National laws or special requirements

The use of studded tyres is not allowed.

8. FUEL

All priority drivers must use FIA fuel as provided by the FIA appointed supplier. See Art. 61 and 62 of the 2025 FIA WRC Sporting Regulations. The supplier appointed by the FIA for 2025 is TotalEnergies. Supply, refuelling services and fuel orders will be handled by Sodifuel.

Non-priority competitors may either use:

- FIA fuel, following the same conditions as priority competitors
- 2025 COPEC Rallymobil Championship fuel (see Art. 8.4 below)

8.1. Ordering procedure for the FIA fuel

The fuel order form, available at www.rallychilebiobio.com, must be sent by email to wrc@sodifuel.com by Thursday 3 July 2025.

The cost of the FIA fuel is €8,75 + VAT per litre. Only credit card payment or pre-payment by bank transfer is accepted. A copy of the transfer must be sent to Sodifuel before the deadline of the orders.

In case of questions related to fuel ordering procedures, please contact directly wrc@sodifuel.com or by telephone to Faiza Maillard on +33 6 14 66 12 90.

8.2. Closing date for ordering the FIA fuel

Closing date for fuel orders is Thursday, 03 July 2025.

8.3. Refuelling during the rally

For environmental and safety reasons refuelling is forbidden in the Service Park (no refuel from cans, drums or similar) except as detailed in Art. 58 of the 2025 FIA WRC Sporting Regulations).

As required by Art. 61.2.8 of the 2025 FIA WRC Sporting Regulations, both crew members must remain outside of the car during refuelling. A member of the crew will open the vehicle to allow an operative to attach the pipework.

The crew will be responsible to indicate to the refueller the amount of fuel required. The crew shall close the vehicle and secure the opening once the requested amount of fuel has been added. Use of mobile phones is prohibited in the refuelling zone.















Location of the main refuelling zone: INACAP Parking,

Additional remote refuel zones according to the Itinerary.

8.4. Distribution for Non-priority drivers

Non-priority drivers may use fuel provided by the supplier of the 2025 COPEC Rallymobil Championship. The supplier appointed by the Organizer is COPEC, which will carry out fuel ordering, supply and refuel services at distribution point which are marked in the road book. The fuel order must be sent by email to cpizarro@hortaproducciones.cl and cpizarro@hortaproducciones.cl and cristian.alcalde.ex@copec.cl.

Supplied fuel: 97.

The cost of the fuel is CLP 1.500 included VAT per litre. Addition of any complements to the fuel is strictly forbidden.

9. RECONNAISSANCE

See also Art. 35 in the 2025 FIA WRC Sporting Regulations. The reconnaissance schedule is published in Appendix 2 of these supplementary regulations. The reconnaissance will take place in two groups which are announced in a Bulletin after the Entry List is published.

9.1. Procedure for registration

A reconnaissance registration form, duly completed, including details of the reconnaissance car, driver and co-driver names and contact phone numbers must be sent by e-mail to eberrios@rallychilebiobio.com latest by Wednesday, 03 September 2025. The form is available in the Competitors section on www.rallychilebiobio.com.

Identification numbers distributed during the Collection of Materials and Documents shall be affixed on the car (top corner of the windscreen on co-driver's side and both rear side windows) and must be kept visible for the duration of the reconnaissance period.

9.2. Collection of recce materials

When a competitor wishes to collect recce materials apart from Administrative Checks and Material Collection, an appointment should be made by e-mail to eberrios@rallychilebiobio.com

9.3. Participation in reconnaissance only

Any driver holding an appropriate international competition license but not entered in the rally may apply to take part in the reconnaissance. The regulations on reconnaissance must be respected in their entirety. A registration form for this purpose will be sent on request. Closing date for submitting the registration form is Wednesday, 03 September 2025. The final permission for taking part in reconnaissance is left to the discretion of the















Organiser. An administrative fee of € 1.500 will be charged.

9.4. Tracking system for reconnaissance

With reference to Art. 35.4.4 of the 2025 FIA WRC Sporting Regulations, all competitors must make one iOS or Android smartphone available and equip their reconnaissance cars with a smartphone-based application RS Lite developed by the FIA official supplier STATUS AWARNESS SYSTEM (SAS). SAS will distribute individual event access codes during the reconnaissance registration.

Rental of smartphones is also available from SAS, to be requested when completing the access code purchase on the SAS website and collected during the reconnaissance registration.

9.5. Specific and national restrictions

9.5.1 Passages

Competitors carrying out reconnaissance must do so in accordance with the recce schedule and according to the identification.

Crews are authorised to drive a maximum of 2 times through each special stage in accordance with the schedule provided in Appendix 2 of these supplementary regulations. The special stages must be driven in the same direction as the rally, at a reduced speed and fully respecting the Traffic Laws. Reconnaissance route will be displayed on separate reconnaissance maps published in the road book. There will be no signing of a recce timecard. All passages through the Special Stages will be recorded by the reconnaissance trackers and recorded by the marshals. The crew members, however, must ensure that their recce number is recorded on the marshal's check sheet at the special stage starts and finishes and at other checkpoints, if any.

All reconnaissance operations for all crews, may only be carried out using cars complying with the 2025 FIA WRC Sporting Regulations, Art. 35.1.

Service during reconnaissance may only be carried out according to 2025 FIA WRC Sporting Regulations, Art 35.4.7.

9.5.2 Speed limits

During reconnaissance, all national traffic regulation must be followed on special stages unless another speed limit is indicated by traffic signs or by written instructions in the Road Book or in Bulletins. The maximum speed limit on special stages during reconnaissance is 70 km/h, except in areas where a lower limit is set by a sign or as stipulated in the Road Book or in a Bulletin.















The competitors must drive in a manner that does not endanger or inconvenience other traffic or people living near the stages. The Organiser will control speeds used as well as the manner of driving during reconnaissance.

The police will penalize traffic infringements according to the Chilean Traffic Law. The fitting or carrying of radar detection equipment is not permitted.

All crews are reminded of Art. 34.2 in the 2025 FIA WRC Sporting Regulations.

9.5.3 Tyres

For reconnaissance tyre regulations see Art. 7.4 of these Supplementary Regulations.

10. ADMINISTRATIVE CHECKS

10.1. Procedure

Administrative checks will be done online before the event. All competitors must send all required documents as per these regulations to the organiser.

The FIA entry form must be signed by **both crew members and the competitor** and presented in printed format by the representative of the team during the administrative checks.

10.2. Documents to be presented

All the documents listed below must be scanned/photographed and sent by email to eberrios@rallychilebiobio.com latest by Wednesday, 03 September 2025.

- Valid competitor license
- Valid driver's and co-driver's competition and driving licenses
- Drivers' and co-drivers' identification or passport
- ASN authorization for all foreign competitors and/or drivers
- Driver Declaration and undertakings duly signed by the Driver and Co-driver
- Completion of all details on the entry form including the signatures of all parties (competitor, driver, and co-driver)
- Rally car's registration papers
- Rally car's insurance cover towards the third parties

All original documents must be brought to the administrative checks in case they need to be checked.

11. SCRUTINEERING, SEALING & MARKING

11.1. Scrutineering venue and timetable <u>Sealing for Rally1 cars</u>

11.2. Preparations

The homologation form of the rally car and certificates on roll cage must be brought to scrutineering. The bodyshell and engine will be marked with a special device and the competitor must prepare their car (on a visible place) in order to fit a wire, a plate and a seal on the engine block.

At scrutineering, all competitors must present their car together with the extra headlights, which they will use during the rally.

11.3. Mud flaps (Appendix J Article 252.7.7)

Fitting of transversal mud flaps (all wheels) in conformity with Appendix J, Art. 252.7.7 is mandatory.

11.4. Windows / Nets (Appendix J Article 253.11)

The use of silvered or tinted films on the rear side windows, on the rear window and on the sunroof, in accordance with Appendix J, Art. 253.11 is authorised in Chile. Silvered or tinted films fitted on rear side windows must have an opening equivalent to the surface of a circle of 70 mm in diameter so that the driver as well as the contents of the car may be seen from the outside.

11.5. Drivers' safety equipment

Drivers' safety equipment will be checked at scrutineering. For specification, see Appendix L Chapter III and Appendix 5 of these supplementary regulations.

11.6. Noise level

At any time on the road sections, the noise level must be in conformity with Appendix J. See also 2025 FIA WRC Sporting Regulations, Art. 18.4.

11.7. Special national requirements

Each car must be equipped with one red reflective triangle, first aid kit and two















reflective tabards in conformity with Chilean traffic regulations.

- Competitors are reminded that two belt cutters must be always carried on board. They must be easily accessible to driver and co-driver when seated with fastened seat belts (Appendix J, Art. 253.6.1.2).
- Each competing car must carry a red "SOS" sign and on the reverse a green "OK" sign measuring at least 42 cm x 29.7 cm (A3), in conformity to 2025 FIA WRC Sporting Regulations, Art. 53.2.2.

11.8. Installation of Safety Tracking System

In accordance with FIA WRC Sporting Regulations, 53.2.1 all competitors must make provisions in their rally cars for the installation of the FIA Safety Emergency Console System and the system must be installed before the car is brought to scrutineering.

Installation and operating instructions are available at the rally website as stipulated in the Appendix 6. The functioning of the equipment will be checked at the scrutineering.

Systems may be collected either by a crew member or a representative.

No deposit will be collected for the rally safety tracking equipment, but all the damage caused will be invoiced afterwards.

11.8.1 Returning the Safety Tracking System

With the permission of the marshals and under their control, the FIA Safety tracking devices can be removed in the final Parc Fermé. They must be returned no later than 18:00 hrs on Sunday, 14 September to SAS truck at the Service Park.

11.9. Onboard cameras

The competitor of any car which carries an on-board camera must have the prior agreement of the Promoter. The fixings of the camera and camera recorder must comply with the 2025 FIA International Sporting Code, Appendix J, Art. 253.2.

Competitors wishing to use an on-board camera must apply via the WRC Accreditation Portal at the latest by Monday,

02 September 2025. Any requests presented after this date will not be considered and the competitor will not be authorized

to install an OBC on their car.

An authorization sticker, which must be affixed to the car in the vicinity of the authorized camera prior to Scrutineering,

12. OTHER PROCEDURES AND REGULATIONS

12.1. Drivers' safety briefing

All drivers / co-drivers who have not yet participated at a WRC event in 2025 must complete the FIA e-learning course and pass the assessment for FIA Safety Tracking Device by Tuesday 09 September, 21:00 hrs and are required to attend the briefing on Wednesday, 10 September at 19:30 hrs at the "Teatro María" next to the Media Centre. Instructions for the eLearning course will be sent to the competitors by email once the Entry List has been published.

All P1 and invited drivers are required to complete a passage of Shakedown according to the start list which will be published on Wednesday, 10 September 2025 at 17.00. At the conclusion of these fixed passages, P1 and other invited drivers will be able to continue their Shakedown runs.

Tyres will be marked between the TC and the start of the Shakedown.

- Refuelling during Shakedown will only be allowed in the Refuelling Zone at INACAP
- There will be a technical zone between the TC and the start of the Shakedown.
- Notwithstanding WRC Art. 36.4, any passenger on board the car during Shakedown who is not entered for the rally, must have signed a disclaimer provided by the organiser or by the WRC Promoter.
- Registration form is required for the Shakedown available at www.rallychilebiobio.com

12.3. Ceremonial start

The Ceremonial start takes place on Thursday, 11 September in Concepción.















12.4. Start procedure and order

The competition element of the rally starts at TC 0 (Service OUT) on Friday, 12 September 2025 at 07:10 according to the Start list published on Thursday, 11 September 2025 at 14:00.

The Clerk of the Course may for safety reasons and with the knowledge of the Stewards, reposition drivers or change the starting interval between the cars.

12.5. Power Stage

With reference to Art. 50 in the 2025 FIA WRC Sporting Regulations SS16 Wolf Power Stage Biobío will be run as the "Power Stage". If determined by the FIA in conjunction with the WRC promoter, crews will contest SS 16 with different start intervals and in a different order than those on Section 5 (2025 FIA WRC Sporting Regulations, Art. 50.3).

All crews must be at Organiser's disposal in the regrouping area after SS 15, to be able to receive information of their starting time for Section 6, should this information deviate from that available at their time of arrival to Regrouping IN. For the purpose of Live TV there will be interviews and podium ceremony after the STOP control of the stage (FIA WRC, Art. 50.5).

12.6. Permitted early check-in

Early check-in is allowed without incurring a penalty at the time controls mentioned in the itinerary.

12.7. Control procedures and time card handling

The complete set of time cards for the whole Rally (including the Shakedown time cards) will be delivered with the rally materials at the administrative checks. It is imperative for all crews to carry at least all the time card sets for the whole day inside the car.

12.8. Running of Flexi Services

12.8.1 Running of 40-minute Services

P1 crews

At TC Technical Zone & Regroup IN (3A / 9A) all P1 crews are shown their due time at TC Service OUT (3C / 9C). After having completed the checks at the Technical Zone, P1 crews will pass TC 3B / 9B without stopping and immediately drive their cars into their service bays where they are isolated by rope / tape installed by the team. Upon start of flexi servicing, the rope / tape is removed by the team and a rally official records the start time (HH:MM) on the timecard in the box provided for TC 3B / 9B. Servicing cannot be interrupted and when it ends a rally official records the end time in the time card and the car is again isolated by rope / tape installed by the team, until it is driven to TC 3C / 9C by the crew. Any service in excess of the single, uninterrupted, 40' will be reported to the Stewards, who will apply time penalties even if the crew checks in at TC 3C / 9C on their due time.















All other crews

At TC Technical Zone & Regroup IN (3A / 9A) all other crews are shown their due time at TC Regroup OUT / Service IN (3B / 9B). After having completed the checks at the Technical Zone, crews shall leave their car in the Regroup/Flexi Parc Fermé area to be collected for service at their due time. At any time, the car may only be driven by the crew entered. Time entry recorded at TC 3B / 9B is the service start time.

12.8.2 Running of 45-minute Flexi Service

The flexi-service parc fermé at the end of Sections 2 and 4 include a 10-minute Technical Zone. The procedures described in 2025 FIA WRC Sporting Regulations, Art. 59 apply for all crews.

12.9. Promotional activities

Promotional activity for P1 drivers will be announced in Rally Guide 2

12.10.FIA WRC Media Pen

An FIA WRC Media Pen will be organised on Thursday, 11 September 2025 at 12:00 – 13:30in the Service Park in Concepción. The FIA WRC Media Pen is mandatory for all P1 drivers and P2 drivers, as well as P1 manufacturer team representatives, and upon request by the media to the FIA Media Delegate or National Press Officer for all other priority drivers or co-drivers. Attending competitors are required to be present for a duration of 30 min. minimum, or until dismissed by the FIA Media Delegate. P2 drivers are recommended to come from 12:30onwards.

12.11. Autograph signing session

Some drivers will be required to attend an autograph signing session before ceremonial start in Concepción, starting at 17:30 for a duration of 30 min.

12.12.FIA WRC Meet the Crews

An FIA WRC Meet the Crews live interview session will be organised on Thursday, 11 September 2025 during the Ceremonial start.

12.13. Environmental prescriptions

The Organiser's environmental policy will be published in Rally Guide 2. It is considered as integral part of these Supplementary Regulations and all competitors must comply with it.

12.14. Official time used during the Rally

Official time throughout the rally is that of the GPS. Time zone is (UTC-4 hrs)

12.15. Restart after retirement / Final retirement















With reference to Art. 54 in the 2025 FIA WRC Sporting Regulations any crews which fails to complete a section will be assumed to re-start the rally from the start of the next section following the overnight regroup. If a crew does not wish to re-start, they must confirm with the Clerk of the Course by completion of the final retirement form published in the Road Book and lodging it with the organiser and informing the CRO by WhatsApp as soon as possible.

All crews re-starting the rally must present their car at the overnight parc fermé at least 4 hours before the start of the next section following the overnight regroup.

For all retired and restarting cars Art. 55 of the 2025 FIA WRC Sporting Regulations will apply:

- **P1 cars** may be taken directly to their service bays where they will be checked by the scrutineers before the repairs. The start of the 4-hour service time is recordered by an official at the service bay. End of this service time is recorded at the Parc Fermé IN time control.
- **P2 and P3 cars** must be brought first to parc fermé where they are checked by the scrutineers before the repairs. The 3-hour service time starts once the car is taken from the parc fermé to the service. End of this service time is recorded at the Parc Fermé IN time control.
- **Non-priority cars** there are not restrictions on service, but these cars must be returned to the overnight parc fermé at least 4 hours before the start of the next section after an overnight regroup.

12.16. Exhibition Driving

Exhibition driving ("doughnuts") is strictly forbidden everywhere due to lack of suitable place. All infringements will be penalised with a minimum of a 5-minute time penalty, applied by the Stewards.

15. FINAL CHECKS AND PROTESTS

15.1. Final checks

The final checks will take place at INACAP on Sunday, 14 September 2025 immediately after the Podium ceremony. An individual communication from the Clerk of the Course will be sent to those competitors, whose cars are selected for final checks. The cars will be taken after the podium ceremonies to the scrutineering by the driver or a competitor's representative, accompanied by a representative of the organiser. A sufficient number of mechanics with tools must follow each chosen car, should the scrutineers wish to dismantle the car.

15.2. Protest deposit fees

The protest deposit in WRC is: € 1.000 (2025 FIA WRC Sporting Regulations, Art. 65.2).

If a protest requires the dismantling and reassembly of a clearly defined part of the car (engine, transmission, steering, braking system, electrical installation, bodywork, etc.), an additional deposit may be specified by the Stewards in accordance with Art. 13.4.3 of the Code.

The expenses incurred in the work and in the transport of the car shall be borne by the claimant if the protest is unfounded, or by the competitor against whom the protest is lodged if it is upheld.

If the protest is unfounded, and if the expenses incurred by the protest (scrutineering, transport, etc.) are higher than the amount of the (additional) deposit, the difference shall be borne by the claimant. Conversely, if the expenses are less, the difference shall be returned.

15.2.1. Additional fees

In the case of protests referring to the alleged non-compliance of an automobile, an additional deposit may be specified by the stewards in accordance with Art. 13.4.3 of the 2025 FIA International Sporting Code.

15.3. Appeal deposit

The international appeal deposit is: € 6.000 (2025 FIA WRC Sporting

Regulations, Art. 65.5)










APPENDIX 4 – Decals and positioning of supplementary advertising



1 – Front door panels with competition number, 2 / car 67 x 17 cm Two rectangular panels placed on both front doors of the car (7 to 10 cm of the bottom line of the side window) with the number to the front of the car. No other signage shall be placed within 10 cm of the plate.

2 - Rear window panel, 1 / car

30 x 10 cm

One panel for the rear window, to be placed at the bottom in the centre of the rear window.

3 – Rear window competition number, 1 / carOne competition number for the rear window, to be placed on the right side of the rear window, next to rear window panel.

4 - Side windows competition number, 2 / car 20 cm high















These numbers shall be placed on the rear side windows adjacent to the crew's name. The first initial(s) and surname of both driver and the co-driver, followed by the national flags of their passport nationalities. For further details see 2025 FIA WRC Sporting Regulations.

5 - Roof panel with competition number, 1 / car 50 x 52 cm

One rectangular panel placed on the roof with the top towards the front of the car.

6 – Front plate with competition number, 1 / car 43 x 21.5 cm One plate placed on the bonnet of the car

7 - Windscreen Identification (1/car) full width of the windscreen

Championship Identification

Each priority car entered in the Manufacturers', WRC2 and/or WRC3 Championships must use the appropriate sticker sets provided by the Promoter (FIA 2025 WRC Sporting Regulations, Art. 29.5.1)

8 - Championship door plates (2/car)

APPENDIX 5 – Drivers' Safety Equipment

All competitors are reminded of Appendix L of the 2025 FIA International Sporting Code (ISC), in particular its Chapter III - Drivers' Equipment. These regulations apply to Shakedown as well.

Helmets (2025 FIA ISC, Appendix L, Chapter III, Art. 1)

Priority 1 drivers and their co-drivers must wear helmets according to the FIA standard 8860-2018 or 8860-2018-ABP. This also applies to all Priority 2 crews competing with a World Rally Car.

All other crews must wear crash helmets homologated to one of the following FIA standards:

- 8859-2015 (Technical List № 49),
- 8859-2024 or 8859-2024 ABP (Technical List № 107),
- 8860-2010 (Technical List № 33) or
- 8860-2018 or 8860-2018-ABP (Technical List № 69)
- see also Technical List № 25

Drivers and co-drivers who wear full-face helmets must contact the FIA Medical Delegate or the Chief Medical Officer in order to carry out a test before the start of the event. This test is described in Appendix L. Chapter III. Art. 1.3

Frontal Head Restraint (FHR, Appendix L, Chapter III, Art. 3)

All crews must use FIA approved FHR systems homologated to FIA standard 8858. Approved FHRs, anchorages and tethers are listed in Technical List N° 29. See also helmet compatibility chart in Appendix L, Chapter III, Art. 3.3.

Flame-resistant clothing (Appendix L, Chapter III, Art. 2)

All drivers and co-drivers must wear overalls as well as gloves (optional for co-drivers), long underwear, a balaclava, socks and shoes homologated to the FIA 8856-2018 standard (Technical List N° 74).

Please pay special attention to the prescriptions of Art. 2 concerning embroidery and printing on flame-resistant clothing (manufacturer certificates etc.) <u>as well as concerning the correct wearing of the clothing elements! See also Regional Rally Sporting Regulations, Article 53.1.</u>

Biometric Devices (Appendix L, Chapter III, Art. 2.1)

Drivers may wear a device to collect biometric data during racing.

- If the biometric device is integrated into a protective garment homologated to FIA Standard 8856, the garment shall be homologated to FIA Standards 8856 and 8868-2018.
- If the biometric device is a stand-alone device, then the device must be homologated to FIA Standard 8868-2018 only. This device must be worn in addition to the garment homologated to FIA Standard 8856.















Wearing of jewellery (Appendix L, Chapter III, Art. 5)

The wearing of any type of jewellery, such as but not limited to, neck chains, bracelets or watches is prohibited during the competition. Exceptions to this rule, providing the CMO and/or Medical Delegate do not consider that due to size or location they may delay rescue or hinder emergency care, are:

- i. the wearing of watch(es) by co-drivers, on the condition that the watch(es) is worn over the overall,
- ii. the wearing of a single band-style ring providing it does not restrict the natural range of motion of the hand, and
- iii. the wearing of body piercing(s) providing they are not worn in and/or around the oral cavity.
