nakon zaprimljene prijave od Direktora rally-a / Having received a report from Clerk of the Course:

**Činjenice/Facts:** Tijekom pristupa Shakedown-u SB 10 uslijed neprimjerene brzine kretanja vozila uzrokovana je materijalna šteta posadi Sbr 92.

During the approach to the Shakedown crew SNo 10 due to the inappropriate speed of the vehicle caused a material damage to the crew of Sbr 92.

**Prekršaj/Offence:** Kršenje Članka 34.1.3. FIA RRSR 2024

Breach of Article 34.1.3. of the FIA Regional Rally Sporting Regulations 2024

**Odluka/Decision:** **Upozorenje sukladno Čl. 12.4.1.a. FIA 2024 ISC**

**Warning in accordance with Art. 12.4.1.a of FIA 2024 ISC**

**Razlog/Reason:** Nakon obavljenog razgovora sa Sbr 10 i 92 te pregleda nastale štete od strane službene osobe Sportska komisija ustvrdila je kako je zbog nedovoljne pozornosti i pažnje pri kretanju Servisnim parkom Sbr 10 došlo do oštećenja na opremi u box-u trećih osoba. Slijedom navedenog Sbr 10 izriče se pisano upozorenje.

After the hearing the crews of Sno 10 and 92 and the inspection of the damage caused by an official The Stewards stated that due to insufficient attention when moving through the Service Parc Sno 10 damaged the equipment of the third-party. Having taken into account all the circumstances a written warning is issued to Sno 10.

Posada se podsjeća kako ima pravo na apel na Odluku Sportske komisije u skladu sa Čl. 15 2024 FIA International Sporting Code i poglavlja 4. FIA Judicial and Disciplinary Rules.
