During the SS 3 crew SNo 102 after RP5 changed the direction of driving and continued driving in the opposite direction of the special stage.

Prekršaj/Offence: Kršenje Članka 34.1.4. FIA RRSR 2024

Breach of Article 34.1.4. of the FIA Regional Rally Sporting Regulations 2024

Odluka/Decision: **Diskvalifikacija za natjecatelja Sbr 102 radi kršenja Čl. 34.1.4. FIA RRSR 2024**

Disqualification for competitor Sno 102 for breach of Art. 34.1.4. FIA RRSR 2024

Razlog/Reason: Kako je propisano čl. 34.1.4. FIA RRSR 2024 posada se uvijek mora kretati u zadanom smjeru brzinskog ispita. Sportska komisija stoga zaključuje da je ovo kršenje čl. čl. 34.1.4. FIA RRSR 2024.

As stipulated in Art. 34.1.4. FIA RRSR 2024 crews must always drive in the direction of the special stage.

The Stewards therefore conclude that this is a breach of Art. 34.1.4. of the FIA Regional Rally Sporting Regulations 2024.
