ANNOUNCEMENT

The National Federation FMP will promote the 1st round of the 2025 Enduro European Championship.

The event will be held in accordance with the Sporting Code of the FIM Europe together with the relevant Appendices, these Supplementary Regulations and any final instructions approved by the Jury.

The event will be named “Enduro European Championship Santiago do Cacém – Terra Única 2025” and will be in Santiago do Cacém, Portugal, from 28th to 30th of march.

1. ENTRIES

All entries must be made on <https://fim-europe.com/enduro> All other information relating to the riders, team, sponsor and the brand of the machine shall be completed.

The entry fee can be payable by bank transfer. The entry form will be valid once the payment has been made and the proof of transfer sent to c.mestre@motorsportsantoandre.pt

Entry fees will be 200 EUR for all riders. All Entries must be received until 10th of march, 20 days before the event. After this deadline a fine of 50 EUR per entry will be charged.

The local organizer is the only responsible for the National race entries.

2. ADMINISTRATIVE AND TECHNICAL CONTROL

Each machine must be road legal for the country in which it is registered and comply with all requirements of the FIM Sporting Code and relevant Appendices.

Intrinsic parts will be marked, and a sound test will be carried out in accordance with the Technical Rules.

When public highways / roads are used then it is the sole responsibility of the rider to ensure that their machine is roadworthy and that they and their machine comply with all legal requirements including their Driver's License and a valid liability insurance for the motorcycle.

At the Technical Inspection the rider must submit his motorcycling with the original registration certificate of the bike (with frame number) and the vehicle registration plate, together with his helmet and body protector.

3. PADDOCK

The paddock will be open from 26th of march on 12:00h and will close on 31st of march at 12:00h. There will be a waiting area before entrance in the paddock.

4. **STARTING ORDER**

The Super Test will be driven as a parallel race in 8-shape, two riders riding at the same time.

On the race, the riders will start two by two, each minute.

The starting order will be Youth, Junior 1, Junior 2, Enduro 1, Enduro 2, Enduro 3, Senior and women's.

The national riders will start immediately after the European riders.

5. **COURSE**

It will be a regular race, marked with red signs, with two Time Checks per lap. (plus, pre-finish on the last lap of Saturday)

TC1 is without service.

TC2 is with service (in paddock)

Day 1: Super Test - The first riders will start at 19:00h.

6. **SUPER TEST**

The Super Test will be driven as a parallel race in 8-shape, two riders riding at the same time.

The Time achieved in the Super Test will count in the classification of Day 2 (Saturday), but the maximum registered time will be the leading time in each category plus 25% of each category.

If a rider cannot finish the Super Test following a fall or a mechanical problem, he/she, or an assistant can bring his bike back to the Paddock.

The rider will have to enter his bike into the Parc Fermé according to the usual procedure. He/she will get the worst recorded time of his category plus 30 seconds extra penalty which will be added to his total time of Day 2 (Saturday).

If a rider followed the start procedure of Day 1 (Friday) but does not arrive to the Super Test before last rider started at the Super Test, he/she will not start the Super Test and he/she will get the worst recorded time of his category plus 60 seconds extra penalty which will be added to his total time of Day 2 (Saturday).

If a rider decides not to take part or fails to take part, he will get the worst recorded time of his category plus 80 seconds extra penalty which will be added to his total time of Day 2 (Saturday).

7. TIME KEEPING

The service will be provided by an outsourcing company, TT Cronometragens. Photoelectric cells linked to the chronometer will be used to activate the start and finish of the special test and time check.

8. PENALTIES

Penalties to be in accordance with RT 01.47 of the FIM EUROPE Enduro Rules.

9. FIM EUROPE JURY MEETINGS

The FIM EUROPE Jury meetings will be held at Auditório Municipal Antonio Chainho, in Santiago do Cacém according to the standard schedule.

The first jury meeting will be held at 9:00h AM, 28th of march.

10. OPENING CEREMONY

There will be an opening ceremony on 28th of march, so all riders must be in the entrance of the Parc Fermé, dressed in riding gear, at 17:30h ready to go on their motorcycles for a parade, in front of the Municipality.

11. PRACTICE AREA

The practice area located 200m away from the paddock will be opened on 27th of march from 14:00h to 18:00h, and, on 28th of march from 8:00h to 10:00h.

12. PRIZE-GIVING CEREMONY

The Prize-Giving Ceremony will take place each day in the starting area immediately after the final classified rider of the day has arrived at the end.

Awards will be given to the top three riders in each category.

Riders must present themselves with their racing equipment.

13. INSURANCE

By endorsing the application form for entry, the FNM of the rider certifies that the rider is insured in accordance with the FIM Europe requirements.

The organizer has contacted third party insurance in accordance with Art. 110.1 of the FIM Europe Sporting Code. This insurance includes a guarantee of the minimum amount as stipulated by the FIM Europe Management Council. The Insurance comes in effect 2 days before and finish 2 days after the race.

The organizer disclaims all responsibility for damage to a motorcycle, its accessories and components arising out of an accident, fire or other incident-

14. PROTEST AND APPEALS

Protests should be submitted in accordance with the Disciplinary and Arbitration Code of FIM Europe and the Supplementary Regulations. They must also be accompanied by the fee as published by FIM Europe.

15. INTERPRETATION OF THE SUPPLEMENTARY REGULATIONS

The interpretation of this regulation rests entirely with the Jury. In case of dispute, regarding the interpretation or if there is any difference between the two official texts, the English text will prevail.

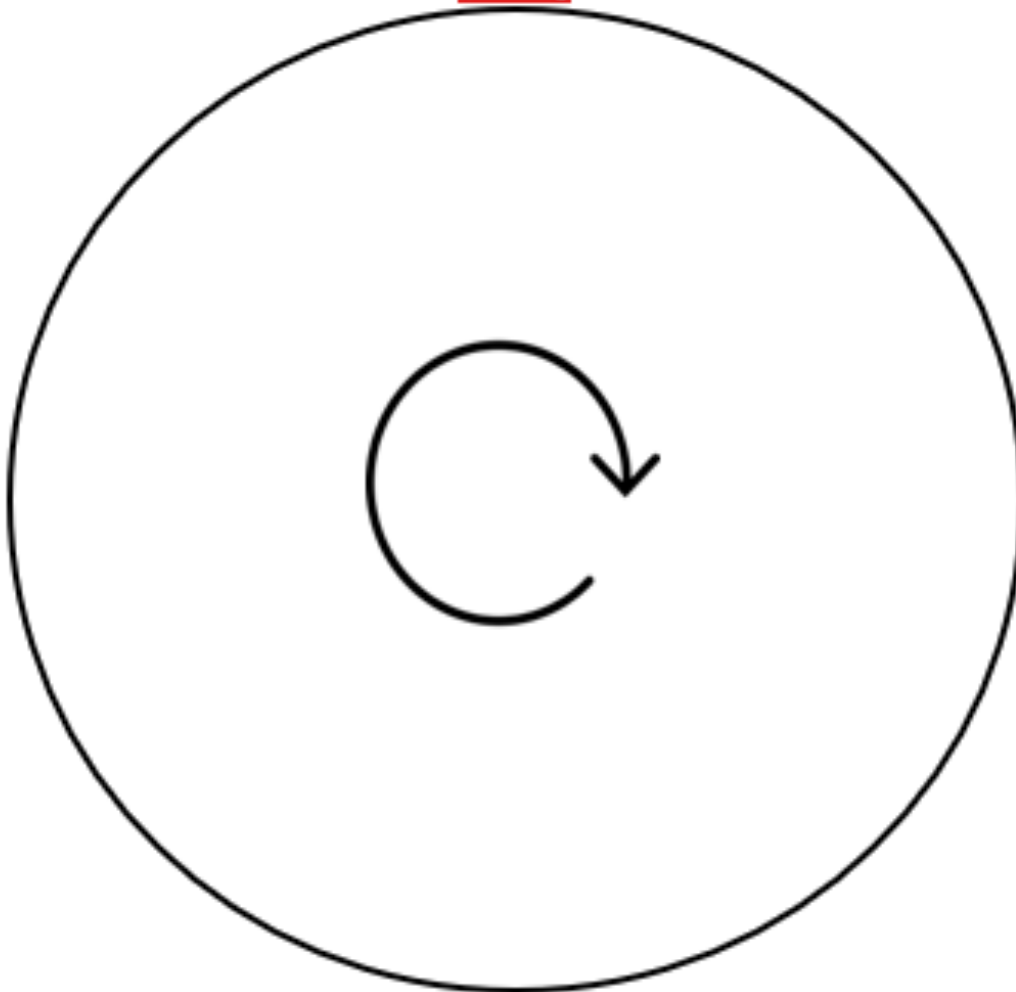

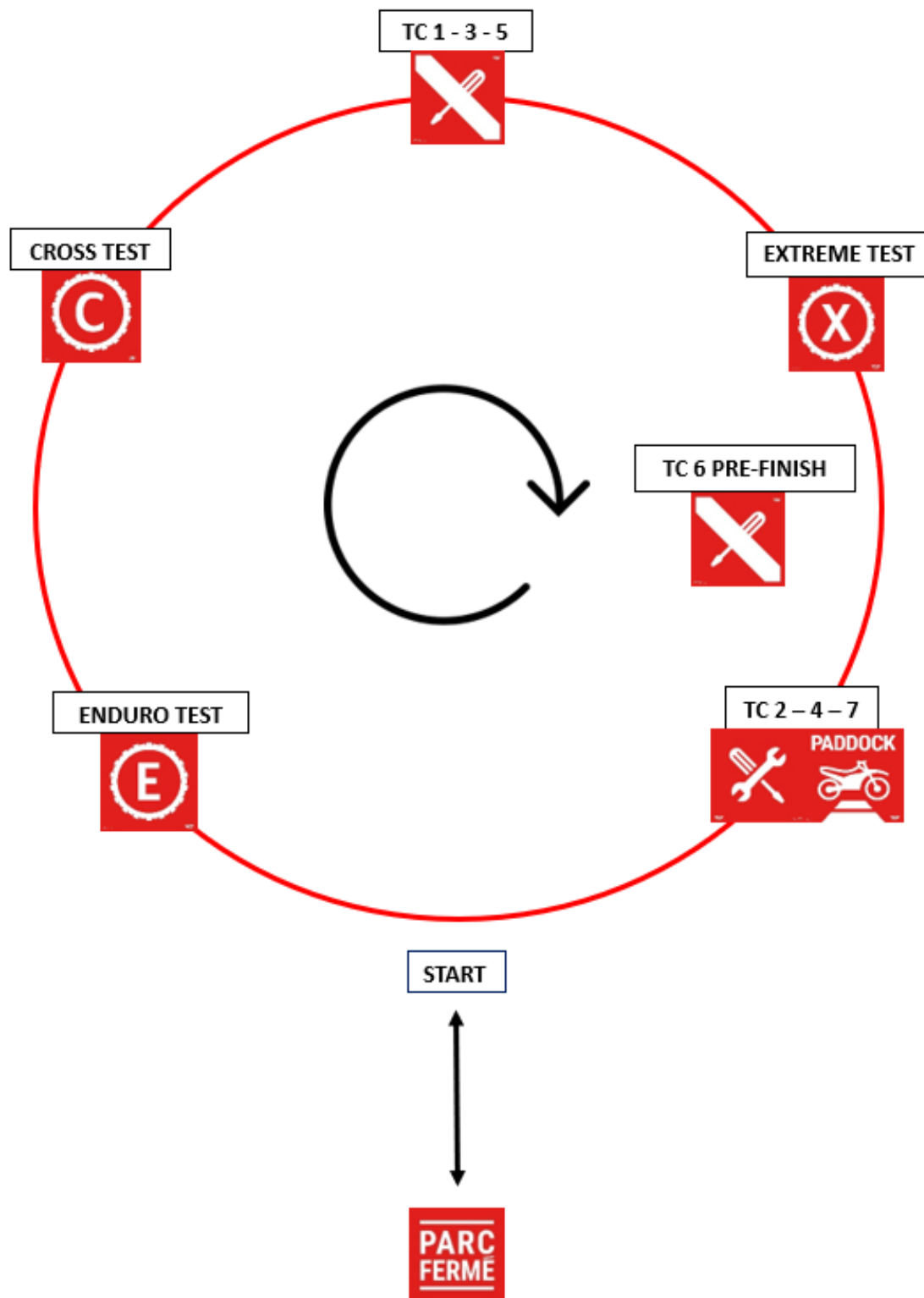

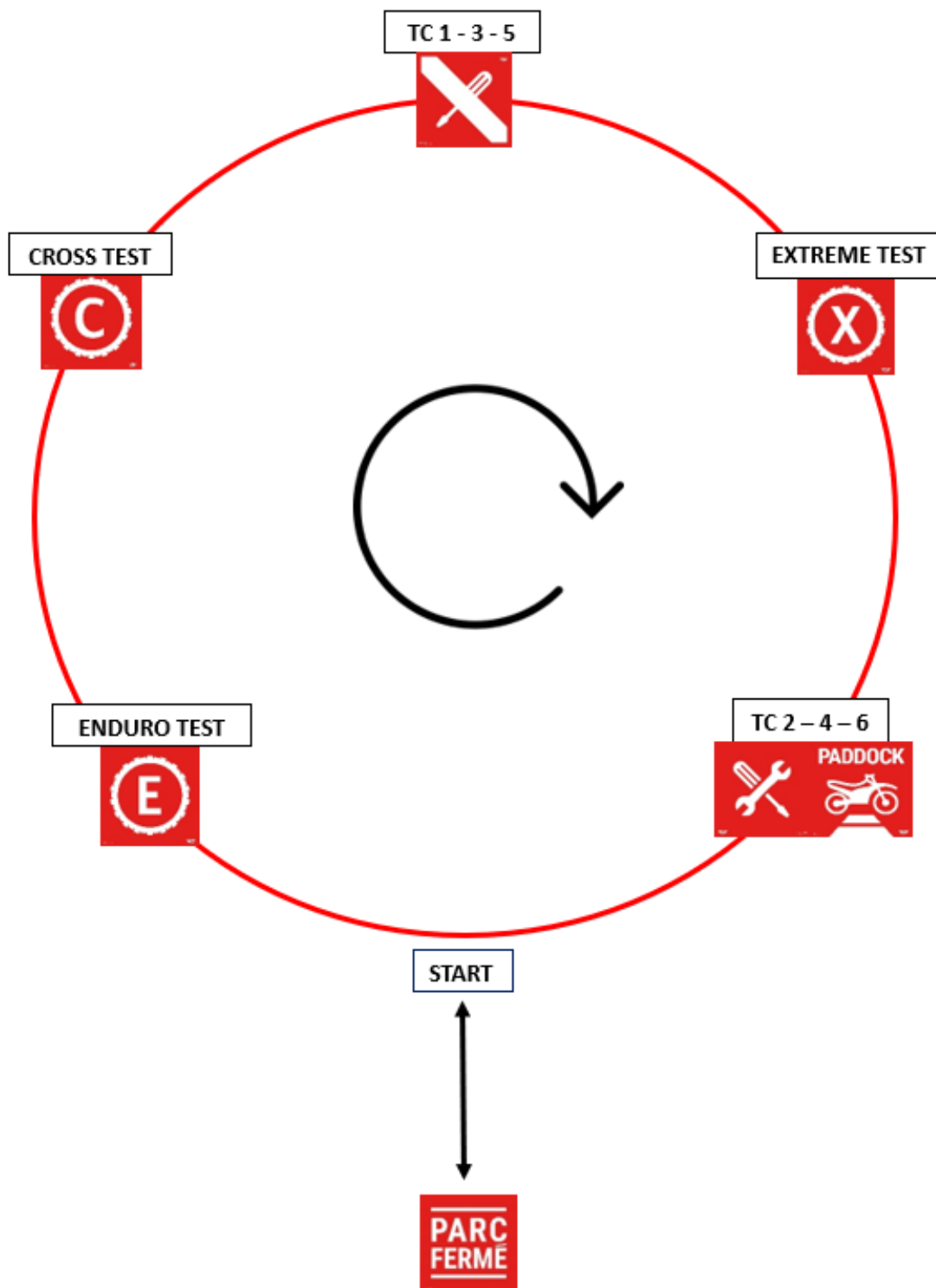
