SR Art. 12.5 REMOVAL OF CARS FROM THE FINAL PARC FERMÉ

Participants who park their vehicles in the Parc Fermé upon passing the final time control, must remain available by mobile phone until the final classification has been posted.

Cars may be removed from final Parc Fermé once the Stewards authorise its opening, or the time for protests to be received after the publication of the final results has expired. ~~Provided that the above takes place as scheduled, all cars must be removed no later than 18:00 on Sunday 6th September.~~

SR Art. 12.11. USE OF ANTI-CUT MECHANISMS ON SPECIAL STAGES

The organiser will be using anti-cut mechanisms in special stages to prevent excessive cutting of corners in 2026. Anti-cut mechanisms will be in place for the recce and rally duration but will not be marked in the road book. All anti-cut measures will be clearly visible. The purpose is to prevent competition cars from taking deep or excessive cuts on corners, bringing additional costs of repair to the organising team due to road damage.

Any competitor observed to be excessively cutting corners by any official of the event (including a Judge of Fact) may be reported to the Stewards. ~~and penalised with a fine of up to £250 GBP for an offence.~~

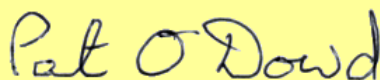
