MEDIA / PRESS REPRESENTATIVE CONFIRMATION AND UNDERTAKING

1. By submitting this media / press accreditation application, I confirm and warrant that all information provided by me is true, accurate and complete. I undertake to immediately inform the Organiser if any of the information provided changes or proves to be inaccurate.
2. I confirm that I have familiarised myself with the increased risks inherent in motor sport competitions, the safety rules of “NEO Rally Žemaitija 2026”, the media / press safety requirements, the accreditation conditions, the requirements of the Event Safety Plan, the official information channels specified by the Organiser and other Event documents provided to me. I understand that rallying is a high-risk event in which competition cars may unexpectedly leave the road, suddenly change direction, suffer a technical failure, collide with an obstacle or create another dangerous situation; therefore, being in an unsuitable or prohibited location may pose a risk to health, life, property and persons nearby.
3. I undertake to comply throughout the Event with the safety rules approved by the Organiser, accreditation conditions, media / press briefing, STOP tapes, signs, prohibited and restricted areas, and to follow all instructions of the Organiser, official rally officials, marshals, safety personnel, police, security, medical personnel, the Fire and Rescue Service and other persons servicing the Event.
4. I understand and agree that media accreditation does not grant the right to freely access any Event territory, special stage, hazardous area, service area, start, finish, STOP area, parc ferme, scrutineering area, refuelling area, marshal, medical, rescue or other restricted-access areas. I undertake to be present only in locations where this is permitted by the Organiser, the Event safety rules, the Safety Plan, on-site safety personnel or other officials.
5. I undertake to use during the Event only official information received from the Organiser, official rally officials, Event documents and the official information sources specified in the safety rules. I understand that it is prohibited to disseminate unverified, misleading or safety-compromising information, to encourage spectators to go to prohibited or hazardous locations, to publish hazardous viewing locations as recommended, or otherwise to interfere with the safety assurance of the Event.
6. I confirm that, while working at the Event, I assume responsibility for my actions, selected working locations, equipment and devices used, filming, photography, broadcasting or any other media activity. I undertake to act carefully and not to endanger myself, other persons, competitors, spectators, officials, the Organiser’s personnel, emergency services or the conduct of the Event.
7. To the extent not contrary to mandatory provisions of the laws of the Republic of Lithuania, I understand and agree that LASF, the Organiser, Event officials, partners and persons servicing the Event shall not be liable for damage to my health, life, property or equipment if such damage arises from my own assumption of risk, unsuitable choice of location, failure to comply with safety rules, accreditation conditions, STOP tapes, signs, prohibited areas or instructions of officials, as well as from the actions of third parties, movement of competition cars, technical failures, road conditions, weather conditions or other circumstances beyond the Organiser’s control.
8. I undertake not to make any claims against LASF, the Organiser, Event officials, partners or persons servicing the Event in respect of consequences arising from risks assumed by me, my improper conduct, or my failure to comply with the safety rules or official instructions, to the extent that such undertaking does not conflict with mandatory legal provisions.
9. I understand that if I breach the safety rules, accreditation conditions, media briefing requirements or instructions of officials, or if I endanger myself, other persons or the safety of the Event, my accreditation may be restricted or withdrawn without separate warning, I may be removed from the Event territory, and I will be obliged to compensate, in accordance with applicable law, any damage caused by my actions or omissions to the Organiser, LASF, third parties or their property.
10. I confirm that I have read and understood this confirmation, agree to it and undertake to comply with it throughout “NEO Rally Žemaitija 2026”.
