Art. 4. Entries

Art. 4.1 Closing date for entries

Entries Close at 18:00 hrs on 19/04/2024

An electronic entry application must be confirmed by way of personal signature by the competitor by the latest at administrative checks. The entry form must be accompanied by a copy of the valid competitor's licence. A change of competitor is permitted up to the close of entries. Only the competitor entered in the event will be allowed to make this request.

Motorsport Ireland accepts an equivalence between National and International Licences issued by Motorsport Ireland (and Motorsport UK) for drivers and co-drivers. Competitors with licences issued by ASNs other than Motorsport Ireland and Motorsport UK, must hold an International licence of the appropriate grade.

An entry application (also made electronically) will be accepted only if accompanied by the total entry fees. According to the International Sporting Code Art. 3.8.1 an entry compels the competitor to take part in the Competition in which they have been accepted to run, except in case of duly established Force Majeure.

Art. 4.3 Number of competitors accepted and vehicle classes.

Art. 4.3.1 The number of competitors shall be limited to 160 (excluding juniors)

Should the number of applications exceed 160 a selection Committee acting on behalf of the Organisers will choose entries using the following criteria.

If more than 160 entry applications are received the organisers will nominate reserve entries. Such reserves may replace withdrawn entries up to a maximum of 160 starters. Reserve entries will be taken in numerical order for this purpose. No more than 25 junior cars will start at the beginning of Leg 2.

Competitors are reminded that FIA ISC 2.7.1.c permits Groups A, N, R & RGT cars (unless there is an indication to the contrary on the homologation form excluding certain evolutions) to participate in international rallies for a period of eight (8) years following the expiry of their homologation, provided homologation papers are presented at scrutiny and the car complies with them.





Art. 4.3.3 Eligible National Cars

Nationally homologated cars may participate in this rally when they fit into a national group/class as of the following list.

Cars in classes 9-15, class 20 and class 23 will compete for the International Rally of the Lakes National Rally.

Cars in classes 17-19 will compete for the International Rally of the Lakes Historic Rally.

Cars in class 16 will compete for the International Rally of the Lakes Junior Rally.

Cars in classes 22, 24 and 25 will only be included in overall classification and are eligible for overall awards.

Class 9. Modified cars up to 1450cc - 2 wheel drive.

Class 10. Modified cars 1451cc to 1650cc not more than 2 valves per cylinder, 2 wheel drive.

Class 11F. Modified FWD cars 1451cc to 1650cc more than 2 valves per cylinder.

Class 11R. Modified RWD cars 1451cc to 1650cc more than 2 valves per cylinder.

Class 12. Modified cars 1651cc to 2100cc not more than 2 valves per cylinder, 2 wheel drive.

Class 13. Modified cars 1651cc to 2100cc more than 2 valves per cylinder, 2 wheel drive.

Class 14. Modified cars 2101cc to 3500cc, 2 wheel drive. (Max 2 valves per cylinder over 3000cc actual capacity).

Class 15. Four-wheel drive cars whose homologation has expired.

Class 16. For cars complying to the Class 16 technical regulations published on the Motorsport Ireland website where the driver is under 26 years of age on Jan 1st of the year in which the event takes place.

Class 17. Historic cars up to 1600cc. See Appendix 29.1, Article 18.2. of current Motorsport Ireland Yearbook.

Class 18. Historic cars over 1600cc. See Appendix 29.1, Article 18.2. of current Motorsport Ireland Yearbook.

Class 19. FIA Appendix K.

Class 20. Modified 4 Wheel Drive Cars.

Class 22. For cars whose homologation expired on or after Dec 31st, 2004, and do not meet the criteria laid out in

Art. 2.7.1.c of the FIA International Sporting Code. WRC cars are not eligible for this class. See Appendix

29.1, Article 13 of current Motorsport Ireland Yearbook.





Class 23. Novice Class See Appendix 29.1, Article 23 As per the technical regulations published on the Motorsport

Ireland website.

Class 24. R5/Rally2 cars converted from left hand drive to right hand drive. All other components must comply with

the car's homologation.

Class 25. WRC Cars (1.6T & 2.0T), including those converted from left hand drive to right hand drive. All other

components must comply with the car's homologation. Cars in this class must meet the criteria laid out in

Art. 2.7.1.c of the FIA International Sporting Code.

Historic competitors will participate in the full schedule.

Class 16 Juniors competitors will start the event at the start of Leg 2 TC K Parc Fermé Out.

NOTES ON CLASSES: See Appendix 29.1 RALLY CAR CLASSES AND SPECIFICATIONS of the current Motorsport

Ireland Yearbook. Historic cars in classes 17, 18 & 19 must have an HRVIF or HTP (as

appropriate) which must be produced at scrutineering. Cars without a valid HRVIF or HTP will not

be permitted to start the event.

Art. 4.6 Entry fee refunds

The entry fee shall be refunded in full.

- if the event does not take place
- to teams whose entry application is rejected.

The organiser may partially refund entry fees if a competitor cannot take part in the event due to a duly proved case of force majeure.

Entries withdrawn more than 7 days before the event will receive a full refund. Entries withdrawn between 7 and 4 days before the event will receive a 50% refund less €50 administration fee. Entries withdrawn less than 4 days before the event may not receive a refund. All refunds will be made after the event. Withdrawal of entry will only be accepted from entrants by email. The Clerk of the Course decision is final on all refunds.

Art. 5. Insurance Cover

Motorsport Ireland licence holders MUST hold current IRDS cover, valid for 2024, in order to be permitted to start the event. All other licence holders MUST hold current BRDS Insurance Cover, valid for 2024 in order to be permitted to start the event. Remember, **NO IRDS/BRDS, NO START.**

The Motorsport Ireland Insurance Database Listing published and updated weekly on www.motorsportireland.com is the ONLY proof that valid IRDS/BRDS is held by a competitor.

Each Co-Driver not in possession of their own IRDS/BRDS must sign a declaration stating that at no time during the event, will he/she drive the competing car.

IRDS/BRDS Cover will commence on arrival at Scrutiny Out Control before Parc Fermé In control on 03/05/2024.

- a) Cover only exists while travelling the Official Route, i.e., via the Road Book during the course of the competition and while under the control of the Organisers.
- b) Cover will cease on arrival at the Final Parc Fermé in Control TC 'M' or at the point where the competitor(s) retire from the Event.

The Organisers decline liability in any accident caused by or to competitors and the competing cars during the whole of the event. The Organisers also decline any liability for breach of the laws and regulations of the countries covered by the rally. Competitors shall be held entirely responsible for any accident or breach of laws in which they may be involved and shall declare to the Organisers particulars from any accident from which liability may arise and shall indemnify the organisers regarding any liability. An entrant or driver(s) shall have no claims against the Organisers arising out of any action of the Organisers, their servants, or officials, during the course of the rally.





Art. 6. Advertising and Identification

Art 6.1 Obligatory organiser's advertising

Rally plate: Number and Event/Sponsor Logo

Competition number size: 50 x 50 cm including Sponsor Advertising.

The organiser will provide each crew with the number identification (50x50cm), which must be affixed to their car in the stated positions prior to scrutineering. Each panel shall be placed horizontally at the leading edge of each front door, with the number at the front. The top of the plate shall be between 7 cm and 10 cm below the lower limit of the window.

It is not allowed to cut the panel.

Art. 6.2 Additional organiser's advertising

Art. 7. Tyres

Art. 7.1 Regulations regarding tyres which may be used during the rally.

All cars must comply with Motorsport Ireland tyre regulations. The hand cutting of tyres is permitted but must be in accordance with the patterns submitted by the tyre manufacturer to the FIA.

Art. 8. Fuel

All types of fuel must be in compliance with Appendix 2 Section 28.2 of the current Motorsport Ireland Yearbook (Petrol Max 102 Octane).

See Art 12.7 regarding Refuelling Zone.

Art. 9. Reconnaissance of Special Stages

Reconnaissance will be according to Motorsport Ireland Yearbook Appendix 25, Article 3.13 and Appendix 29, Article 4. Please have both drivers and co drivers licences on the day of recce sign on, and you will be also asked to phone the clubs emergency number to ensure we have the correct telephone number for both driver and co-driver.

Pace notes will be allowed on the event. They will be available for sale by third parties. The club has no involvement in their preparation and accepts no responsibility or liability for their accuracy or otherwise.





Art. 9.1 Registration procedure

Details of the reconnaissance car and occupants, including telephone numbers at which they can be contacted during the reconnaissance period, must be submitted to the organisers at recce registration at the Rally Office. All details of the recce car will need to be completed by all competitors on the online system. If the crew making a reconnaissance wish to change the car or vary the occupants a new Recce Registration form will need to be completed.

While engaged in reconnaissance the Reconnaissance Car Plates must be displayed one on the <u>outside top left corner</u> of the windscreen of the car and one on the rear window. Failure to do so will be deemed to be a breach of the reconnaissance regulations. Rally cars used in the event may not be used for reconnaissance, only standard cars or car derived vans are allowed to complete Recce.

Art. 9.2 Specific regulations

During reconnaissance, all national traffic regulation must be followed, including but not limited to the speed limits. Please note that the Special Stages will not be closed to public traffic during reconnaissance. The organiser may reduce the allowed speed individually by marking the areas in the road book and along the route. Any competitor deemed to be in breach of reconnaissance regulations will be reported to the Stewards where the penalties imposed may be start refused and/or a fine imposed and/or disqualification and reported to the competitors ASN Motorsport Ireland who may convene a Court of Inquiry. Your attention is drawn to Appendix 29, Article 4 of the current Motorsport Ireland Yearbook.

Competitors are only permitted a maximum of THREE passes through each stage (special stages run more than once are considered to be one stage). Penalty for breach of this rule: Exclusion (Appendix 29), Regulation 4.6.3, current MI Yearbook.

Each crew may drive the special stages <u>only</u> in the direction of the rally and must always enter and leave the special stages through the start and stop control locations.

Judges of Fact will be appointed to enforce this regulation and will carry special identification. The organisers will also have the co-operation and assistance of the Garda and Officials of local authorities.

Judges of Fact will also monitor competitors driving during recce: e.g. falling into this category is use of handbrake to negotiate acute turns etc. Your attention is drawn to Appendix 29, Regulation 4.6.1 and 4.6.2 of the current MI Yearbook. The decision of a Judge of Fact is final. Judges of Fact may sign your road book.

A list of Judges of Fact will be posted on the Digital Notice Board.

Your attention is also drawn to Appendix 29, Regulation 4.8.1 - 4.8.4 of the current MI Yearbook referring to a competitor found on a stage outside of the 'Recce' period, also refer to 4.9 and 4.10. Reports of breaches of this regulation will be submitted to the President of Motorsport Ireland who may convene a Tribunal of Inquiry.





During Recce competitors must only enter the stage at the start location and exit the stage at the finish location. Traversing the stage in the wrong direction is expressly forbidden.

If you are not sure of being clear of any stage by 17:00 you should not start the stage.

Art. 9.3 Number of Passages

The maximum number of passages authorised for each crew on each special stage is three.

Art. 10. Administrative checks

Art. 10.1 Documents to be presented:

To keep the time required for the administrative checks to the necessary minimum, make sure to bring and present the following documents:

- Competitors' licence
- Driver's and co-driver's competition licences
- Driver's and co-driver's ID cards/passports
- Driver's and co-driver's valid driving licences
- ASN authorisation for foreign competitors (if required)
- Completion of all details on the entry form
- Completed Scrutineering Sheet or Electronic Equivalent if in Operation.
- Car registration papers

Art. 10.2 Timetable

See programme (SR Art. 3)

Final individual administrative checks to be completed at Rally HQ, by 11:00 on 03/05/2024 before vehicle scrutineering.

Art.10.3 Competitors Safety Briefing:

Competitor safety briefing is compulsory for all events. The briefing must highlight safety requirements particularly the procedure dealing with SOS & OK. <u>Timecards will be issued to all competitors at entrance to drivers briefing</u>, Attendance is mandatory for both crew members. Please add; Penalties will be applied as per Appendix 23 Art. 3.2 of the current Motorsport Ireland Yearbook.

Art. 11. Scrutineering, Sealing and Marking

Art. 11.1 Scrutineering, venue, and time.

Cars may be presented at scrutineering by a representative of the team. Max of 2 crew members per car. See programme (SR Art. 3)

Scrutineering: TBC on 03/05/2024 13:00 to 19.30.

Art. 11.2 Scrutineering, mandatory documents

- Cars complete certified homologation (RC2 RC5, Class 22, Class 24, and Class 25)
- SOS/OK board (DIN A3 format)

The installation of the safety tracking system will be checked at scrutineering.

Art. 11.3 Windows

Use of tinted windows is not authorised in accordance with Article 253.11 "Windows/nets" of Appendix J of the FIA International Sporting Code. ASN rules apply to National Cars.

Art. 11.4 Drivers' safety equipment

All items of clothing including helmets and FHR (Front Head Restraint) intended to be used, e.g., HANS devices, must be presented for scrutineering. They shall be checked for compliance with Appendix L, Chapter III.

Art. 11.5 Noise Level.

Cars must comply with Motorsport Ireland regulations - Appendix 2. Art 9

Art. 11.6 Special National Requirements

Competitors in the National classes 9 to 25 must comply with the technical regulations contained in Appendix 2 and Appendix 29.1 of the current Motorsport Ireland Yearbook.

Art. 11.7 Installation of the Safety Tracking System

Safety Tracker System equipment will be distributed prior to scrutineering – details of distribution and fitting instructions will be detailed in a Bulletin via the Sportity App. The safety tracking System must be installed in the car prior to scrutineering and the fitting will be checked at scrutineering.

Please be advised that early arrival will not be accommodated as these are working locations prior to handover to the event. Please don't cause an obstruction to traffic flow on arrival to service parks. Please respect and follow the instructions of the service park marshals.

The service crews have a duty of care to the service park providers. Leave as you find.

Ground sheets are compulsory for each crew and must be used at all times, minimum of 2 overlapping sheets. Ground sheets are not to be swept onto tarmac / concrete.

Each crew will be provided with a personal oil absorbent kit. If you have a spill, please report it immediately to the Service Area Manager (phone number will be provided to each crew).

Separate bins will be located in service to safely dispose of oil-stained cardboard, rags and / or paper towels.

Refuse bins are provided throughout the service area and all crews are asked to keep their area clean and tidy. Please do not leave any empty drums, cans or used tyres behind.

A JUDGE OF FACT will be monitoring the service area and any crew not complying with the above will be immediately excluded from the event.

Services passes will be provided to each crew at recce sign on. Only one service vehicle per car and **no pass = no entry**.

In the Service Park Area's all competitors are required to have 2 fire extinguishers visible with displayed signage. The minimum requirement for the extinguishers is: 1 x 6 kg ABC Dry Powder Fire Extinguisher (for each car serviced) and 1 x 6 litre AFFFF (Foam) Fire Extinguisher (for each car serviced).

Smoking by competitors or service crews is prohibited in Service Areas.

Crews will be allocated a designated area by the service area marshals.

Art. 12.1: Shakedown

Art. 12.3: Ceremonial start procedures and order

Details will be available on First Bulletin.

Art. 12.4: Permitted early check-in.

Early check-in is allowed at TC MC 'F' and TC MC 'M'

Art. 12.5: Start procedure on Special Stages

The starting for special stages will be given by means of Large Clock with start lights which will work as follows:

- 20 to 5 seconds a RED light will be displayed.
- Countdown 5, 4, 3, 2,1 AMBER lights will be displayed.
- START TIME Green light goes ON.

The system is electronically coupled to a start line detection device that records any situation where a car leaves the start line ahead of the correct signal.

In the event of failure of the electronic system the timekeeper will count down aloud 30" - 15" - 10" and the last five seconds one by one and then raise a flag or hand.

The starting official at a special stage shall rule as to whether or not a competitor has made a false start, where penalties will be applied.

Finish procedures.

The time taken for a special stage will be to 0.1 second using timing equipment triggered by a light beam positioned at the Flying Finish line.

Art. 12.6 Super Special Stage, regulations, and order

There will be NO Super Special Stage.

Art. 12.7 Tyre Warming Zone (TWZ)

There will be NO Tyre Warming Zones.





Art. 12.8 Refuelling

Art. 12.8.1 It is mandatory to re-fuel in the designated re-fuel zones or at commercial filling stations, with the exception of the TROA International Registered Competitors who are required to use the TROA appointed fuel provider. It is mandatory to refuel in the designated refuel areas. Penalties may apply.

All other Competitors will be allowed to use their own refuelling systems but using plastic canisters is forbidden. **ONLY METAL DRUMS OR METAL CONTAINERS MAY BE USED**.

The fuel and fuel pump system is to be placed in the re-fuel zone at the beginning of the event and is to remain there for the duration of the crew's participation in the event.

Under no circumstances are fuel drums and or pumps to be transported around the service area at any time. If you have a fuel spill please report immediately to the service area manager or environmental officer in charge.

TROA crews can arrange their fuel through Euro M-Sport.

Art. 12.8.2 TROA International Competitors and any other competitors wishing to utilise the fuel provided by the official TROA provider will need to use the refuel area designated for the same and follow the instructions of the fuel supplier.

Art. 12.8.3 When necessary, as part of a service (i.e., changing a fuel tank or pump), emptying and/or refilling is permitted in the designated service area provided that:

- a) The work is carried out under the supervision of a marshal
- b) No other work is carried out on a car during the emptying and/or refilling operation
- c) A suitable safety perimeter is established around the car
- d) Only sufficient fuel is added to reach the next refuel zone
- e) Scrutineer Present

Art. 12.8.4 Penalties:

Art. 12.8.4.1 Failure to comply with these refuelling regulations will be reported to the stewards and penalties may apply.

Art. 12.8.4.2 Each crew is responsible for the actions of their service crew and any breach of these regulations.

Art. 12.8.5 No access to the Refuelling Zone, with the exception of the Competitors availing of the refuel rig. These Competitors must exit the car whilst refuelling is carried out and follow the instruction of the refuelling operator.

Art. 12.9 Finish procedures and other activities after the finish of the rally

Art. 12.9.1 Finish Ramp will be in the Rally HQ, Gleneagle Hotel. All finishing cars will attend the ramp and proceed to parc ferme thereafter.

Attending cars may be held at a holding control at Parc Ferme. Details in the Road book.





Art. 12.9.2 Availability of participants

Participants, who park their vehicles in the Parc Fermé upon passing the finish line, must remain available by phone (mobile) until the final classification has been posted.

Art. 12.9.3 Classification

The final classification will not be distributed after the event. The final classification will be published on the event website and on the Digital Notice Board via the Sportity App.

Art. 12.10 Official time used during the rally.

Official Time throughout the Rally is that of GPS. Time Zone is GMT+1.

Art. 12.11 Rights of Organisers

The organisers may at their discretion: -

- a) Refuse any entry without giving a reason.
- b) Offer an applicant whose entry is refused, a reserve entry.
- c) Refund any entry fee or excuse a competitor payment of an entry fee in circumstances other than those defined in Article 4.6.
- d) Abandon, cancel, or postpone the competition in the case of unforeseen circumstances.
- e) Delete or amend any part of the route, competition, or time requirements in the case of unforeseen circumstances.
- f) Distribute the awards at their discretion, if through unforeseen circumstances the competition is stopped before its scheduled completion.
- g) Reduce the number of awards in any class.
- h) Exclude any person or car appearing on examination to be ineligible for the competition or the class therein, to which the entry refers.
- i) Before the start of the competition offer the entrant of any person or car liable to exclusion under Paragraph (h) above the option to transfer to the appropriate class.
- j) Exclude a competitor from the rally and refuse their application for entry for the following 3 years for contravention of Article 9.
- k) Appoint Judges of Fact to determine whether or not the requirements of these regulations have been complied with. In particular, these judges will be empowered to determine whether a competitor has followed the correct route, and /or travelled at an excessive speed, and or caused an excessive noise and /or obeyed instructions concerning servicing and service areas. Art. 12.12 Super Rally

Art. 12.12.1: General

The rally will operate Super Rally in accordance with Art 13, Appendix 29 of the current Motorsport Ireland Yearbook. Note SRC is Super Rally Co-Ordinator.

RE-START AFTER RETIRING ON LEG 1:

Art. 12.12.2

A crew retiring from the rally between Parc Fermé Out and Arrival Control SS2, may restart the rally from Service Out Control after 2 stages, from Service Out Control after 5 stages or from Overnight Parc Fermé Out Control on Sunday morning (subject to compliance with 12.11.9.1 below).

Cars retiring from the rally on Special Stages 2, 3, or 4 the following road sections, may restart from Service Out Control after 5 stages, or from Overnight Parc Fermé Out Control on Sunday morning (subject to compliance with 12.11.9.1 below). Cars retiring from the rally on Special Stages 5, 6, 7 or 8 or the following road sections, may restart from Overnight Parc Fermé Out Control on Sunday morning (subject to compliance with 12.11.9.1 below).

RE-START AFTER RETIRING ON LEG 2:

Art. 12.12.3

A crew retiring from the rally between Parc Fermé Out (Sunday morning) and Arrival Control SS11, may only restart the rally from Service Out Control after 11 stages (subject to compliance with 12.11.9.1 below).

No restart will be permitted for crews retiring on Stages 11, 12, 13 or 14.

The above re-start procedure on Leg 2 will also be made available as appropriate to the Junior Class with the following relevant sections applying to all classes throughout the event.

A restart will not be permitted where a crew has been excluded for non-compliance with eligibility requirements, traffic violations or a decision of the COC / Super Rally Co-Ordinator.

On retirement the crew must hand in their time cards to Car Accountability or the marshal/timekeeper at the next available location/Time Control. Crews must retain the duplicate copy of the time card, to present to SRC as proof of stages completed.

Art. 12.12.4

Competitors must register for Super Rally if they wish to restart by contacting the SRC prior to a time that will be specified in Final Instructions. Service Vehicles will not be permitted to access the Stage or any closed road between runs. The organisers will, where possible, endeavour to remove any car to the nearest location where it can exit the stage. The transport of the car from that location is the responsibility of the competitor. The car must return by direct route to the Service Area.





Art. 12.12.5

Competitors availing of the Super Rally must present themselves at the appropriate Out Control, with their car, for rescrutiny. Due time is 10 minutes before their original due time at that Control, and 15 Minutes maximum lateness will apply.

Art. 12.12.6

The SRC, once satisfied that the crew meets the conditions for a restart, will issue new time cards which will have a restart time and restart Control Number.

The restart position within the field shall be at the discretion of the COC / SRC.

Art. 12.12.7

The organisers reserve the right to disallow restart on safety grounds or if the restart would interfere with the running of the rally.

Art 12.12.8 Penalties:

Art 12.12.8.1

Super Rally Penalties will be applied as per Article 13.5, Appendix 29 of the current Motorsport Ireland Yearbook.

Art. 12.12.9 Award Eligibility:

Art. 12.12.9.1

In order to be classified as a finisher the crew must complete a minimum of 7 special stages (or 50% of the total number of stages for Historic and Junior Classes), which must include the final loop of stages and the finish control.

Art. 12.12.9.2

Crews completing the rally under Super Rally regulations will be eligible to score points in Championships.

Art 12.12.10 Award Eligibility:

Art. 12.12.10.1

In order to be classified as a finisher the crew must complete a minimum of 8 special stages (or 50% of the total number of stages to be completed by Juniors).

12.12.10.2 Crews completing the rally under Super Rally regulations will be eligible to score points in Championships.

Art. 12.13 Bogey Times

Bogey times will be enforced as per Motorsport Ireland GCR 22.2.1 The maximum required average speed for loose surface stages shall not be more than 113 kph and for tarmac stages 130kph, as per GCR Chapter 2, Rule 22.2.1.

Art 14. Prizes

CLASSIFICATION BY NATIONALITY

Best Cross Channel Crew Award for Driver & Co-Driver (Both Crew Members Eligible).

LADIES AWARD

Highest placed ladies crew Award for Driver & Co-Driver (Both Crew Members Female).

ADDITIONAL AWARDS

Rally of the Lakes Diamond Award – to qualify Driver must be 60 years since the 1st Jan 2024. Co-Driver can be any age & will receive the same award as the winner of the Rally of the Lakes Diamond Award.

The Toastal Perpetual Cup – awarded to the overall winner of the International Rally.

The Bertie Fisher Cup – Awarded to the driver setting the fastest time on Molls Gap each year. Open to all sections of the rally. Time may be recorded on any run on the stage unless the start and finish locations are altered between runs, in which case the first run will count.

The Maurice O'Donoghue Perpetual Cup – overall Historic.

Jimmy Coakley Cup – awarded to the overall winner of the National Rally.

Timmie Sullivan Cup – awarded to the highest placed co-driver who is a member of KDMC. Open to National & International Sections.

Sean Conlon Cup – awarded to the highest placed crew overall, from Class 12, if there is no finished in Class 12 the award goes to the highest placed crew in Class 10 and then Class 9.

Jason Barry Cup – awarded to the highest placed crew overall, from Class 13, if there is no finisher in Class 13 the award goes to the highest placed crew in Class 11 combined.





John Mullane Cup – awarded to the highest placed crew both of who are residents of Co. Kerry. Open to both national & international sections.

John Sweeney Memorial Cup – awarded to the best placed Kenmare / Kilgarvan driver.

Bridie Roberts Award – awarded to the best female competitor overall.

Tom Nynan Cup – awarded to the best Co. Cork crew.

Gerard Horgan Trophy – awarded to the overall winner of the Junior Category.

Spirit of the Rally Award – to be awarded at the discretion of the club.

Silver Wheel Award – awarded annually since 1980, the Silver Wheel Award, goes to the person, who, in the opinion of the nominators, has made a significant contribution to the development of the Rally of the Lakes, to the promotion of Rallying in Ireland or to Irish Motorsport generally. Nominations may be submitted by anybody, but the ultimate winner is always decided by the Clerk of the Course.

Art 15. Final checks / Protests / Appeals

Art. 15.1 Final Checks

Time and location: see programme (SR. Art. 3)

Any teams required to undergo final scrutineering must immediately follow the instruction of the marshals in charge, even if this prevents them from proceeding to one or more-time controls (TC). The complete original FIA homologation form and other necessary certifications must be available for final scrutineering. A representative of the competitor as well as mechanics with the appropriate tools (in case of dismantling) must be present at the final scrutineering.

Art.15.2 Protest deposit

The protest deposit is:

EUR 1,000

If a protest requires the dismantling and re-assembly of a clearly defined part of the car, any additional deposit will be specified by the Stewards upon a proposal of the Chief Scrutineer.

Art. 15.3 Appeal deposit

The appeal deposit for an international appeal is: EUR 4,000

All protests and/or appeals must be lodged in accordance with Motorsport Ireland GCR's Articles 13 and 15 of the Code and, where applicable, with the FIA Judicial and Disciplinary Rules.





Art. 16. Provision Regarding Postponement, Abandonment or Cancellation of the event.

The organisers reserve the right to postpone, cancel or abandon the event in circumstances such as:

- Insufficient entries received at the closing date for entries.
- On safety grounds (upon consultation with the MI Stewards reference GCR 129.11).
- Force Majeure (upon consultation with the MI Stewards reference GCR 129.11).

If a decision to postpone, cancel or abandon the event is made, the organisers will communicate this decision using one of or a combination of the following:

- Final instruction posted on event Sportity App.
- Final instruction posted on official notice board Foyer, Rally HQ.
- Final instruction posted or emailed directly to the crew member nominated as official contact on entry form.
- Direct instruction to at least one of the crew from an official of the event.

Every effort will be made by the organisers to communicate such a decision in a timely manner, however, in circumstances of force majeure or on safety grounds, it may be necessary to make such a decision during the running of an event. In such cases, this decision will be communicated via direct instruction from an official of the event.

In the event of cancellation or postponement for more than 24 hours, entry fee shall be refunded in accordance with GCR 51.2.

- This post is entrusted to an official who has a knowledge of the regulations and the GCR's, and the CRO may be invited to attend meetings of the panel of the Stewards in order to keep informed of all decisions taken.
- 3 He/she must be easily identifiable to the competitors. To this end it is advisable that he/she be introduced to the competitors at the competitor's safety briefing.
- 4 The Competitor Relations Officer shall refrain from saying anything or taking any action which may give rise to a protest.
