Comisarii Sportivi au primit dosarul arbitrilor din Zona de Alimentare RA 3, au analizat faptele si au decis urmatoarele:

Fapta: Mecanicii echipajului nr. 566 au alimentat fara a purta cagula, folosind canistra si palnie

Ofensa: Incalcare a art. 61.2.3 din Regulamentul CNR 2024

Decizia: Amenda 500 lei, de achitat in contul FRAS pana Marti, 04.06.2024, ora 12:00

Motiv: Comisarii Sportivi au primit dosarul arbitrilor din Zona de Alimentare RA 3, in care este mentionat faptul ca mecanicii echipajului nr. 566 - Matej KNAPEK/Zuzana STEFFKOVA nu au avut cagula in timpul procedurii de alimentare, iar in fotografia atasata acestia alimentau din canistra si palnie.

Conform art. 61.2.3 din Regulamentul CNR 2024, "toti membrii implicati in operatiunile de alimentare trebuie sa poarte imbracaminte care sa asigure o protectie adecvata impotriva incendiilor si care sa includa cel putin: pantaloni lungi, bluza cu maneca lunga, incaltaminte inchisa, manusi si cagula. Mai mult, art. 61.2.10 din Regulamentul CNR 2024 prevede faptul ca "in Zonele de Alimentare este obligatorie utilizarea pompelor manuale corespunzatoare pentru alimentarea automobilului, iar canistarele sau alte recipiente sunt strict interzise." Prin urmare, Colegiul Comisarilor Sportivi considera ca aplicarea unei amenzi in valoare de 500 lei este o decizie corecta si echitabila.

Se reaminteste tuturor concurentilor faptul ca procedura de alimentare reprezinta o procedura periculoasa, iar masurile de Securitate trebuie respectate si implementate de catre toti participantii la eveniment.

Concurentilor li se reaminteste ca au dreptul de protest impotriva deciziei Comisarilor in concordanta cu Art. 15 din Codul Sportiv International.

The Stewards have received the file from the Marshal in Refueling Zone RA 3, analyzed the facts, and decided the following:

Facts: The mechanics of crew no. 566 refueled without wearing balaclavas, using a canister and funnel

Offense: Violation of Art. 61.2.3 of the CNR 2024 Regulations

Decision: A fine of 500 lei, to be paid into the FRAS account by Tuesday, 04.06.2024, at 12:00 PM.

Reasoning: The Stewards received the file from the Marshal in Refueling Zone RA 2, which mentioned that the mechanics of crew no. 566 - Matej KNAPEK/Zuzana STEFFKOVA did not wear balaclavas during the refueling procedure, while the picture attached shows they were using a canister and funnel to refuel the competition car.

According to Art. 61.2.3 of the CNR 2024 Regulations, "all personnel involved in refuelling operations must wear clothing that provides adequate protection against fire and includes at least: long trousers, long-sleeved top, closed shoes, gloves and a balaclava. In addition, article 61.2.10 mentions that „in the Refuelling Areas it is mandatory to use the proper manual pumps for refuelling the car and canisters or other containers are strictly forbidden.” Therefore, the Stewards consider that imposing a fine of 500 lei is a fair and equitable decision.

All competitors are reminded that the refueling procedure is hazardous, and safety measures must be respected and implemented by all participants in the event.

Competitors are reminded of their right to protest the Stewards' decision in accordance with Art. 15 of the International Sporting Code.
