## REGULATIONS

The final text of these Supplementary Regulations shall be the English version, which shall be used should any dispute arise as to their interpretation. Headings in this document are for ease of reference only and do not form part of these Supplementary Regulations.

### Article 1 – Organisation

The Competition, which has the status of an International Competition, shall be run in conformity with:

- the International Sporting Code ("the Code") and its Appendices
- the National Sporting Code (SAMŠ, ACCR, AMF)
- the General Prescriptions applicable to International Hill Climb Competitions
- the List of Requirements for Organisers of the FIA CEZ Championship and FIA CEZ Championship historic
- national sporting regulations for Hill Climb
- these Supplementary Regulations

#### Characteristics of the Competition:

- Number of official practice heats: **3 - Saturday**
- Number of official race heats: **2 - Sunday**
- Any Driver must mandatorily complete at least one practice heat in order to be allowed to start the race. Special cases shall be submitted to the stewards.
- Driver classifications shall be established by combining the times of each Driver's two best race heats.

#### Licence requirements:

Drivers must have a car driving licence (except for drivers under 18 years of age) and must hold valid licence for current year:

**CEZ** – National or International licence issued by an ASN that is a member of CEZ

**CEZ H** – National or International licence issued by an ASN that is a member of CEZ

**MMSR** – According to National Sporting Code SAMŠ chapter V. section 10.2.1



**MSR HA** – According to National Sporting Code SAMŠ chapter V. section 13.2

**SKP** - According to National Sporting Code SAMŠ chapter V. section 11.1

**GR CUP** - According to National Sporting Code SAMŠ chapter V. section 12.1.1

**ST HP** - According to National Sporting Code SAMŠ chapter V. section 14.1

**MČR** – national (NTD-R, or NTC-R), or international (ITD-R, or ITC-R) licence issued by ACCR and SAMŠ

**MČR HA** - national, international, or licence “H” licence issued by ACCR

- National or International driver licence and a competitor's license issued by an ASN of another country and at the same time a permission to start abroad

- A competitor's license is not mandatory, it can be replaced by a driver's license.

**ČT** - national (NTF-R, or NTD-R), licence issued by ACCR

**AMF** – In category 1 licence issued by AMF, in category 2 licence by an ASN that is a member of FIA

**AMF H** - licence issued by AMF

For drivers with SAMŠ licence in the 1st year from the issue of the 1st driver's license, in MMSR, MSR HA, SKP is the entry fee 180€.

Entry fee will be increased by 20 € if it is paid in cash on competition.

#### Rejections, Withdrawals:

In the event of rejection of the application or cancellation of the event, the entry fee will be refunded in full.

In case of withdrawal for reasons of Force Majeure (no-show for administrative checking and scrutineering) after the publication of the entry list, 60% of the base entry fees shall be reimbursed to the Competitor(s), subject to receipt of a written request.

## Article 6 – Insurance

In accordance with legal regulations, the race is insured by Generali Poistovňa, a branch of an insurance company from another member state, policy number is 2409816689.

- General Liability for Damage to Life and Health

€ 6.450.000

- General Liability for Property Damage € 1.300.000

The organiser's third party insurance is valid for the entire duration of the Competition, not only during official practice and race heats but also for travelling from the parking area to the course of the Competition and back.

## Article 7 – Protests and appeals

Protest fee: €500 (SKP €165)

National appeal fee: €1340 (SKP €670)

The protest must be made in accordance with the ISC regulations. The protest must be in writing and delivered to the chairman of the stewards, in his absence to one of the stewards, or in their absence to clerk of the course or his assistant, together with the protest deposit. If the protest requires the dismantling and reassembly of various parts of the vehicle, the protester must pay a deposit to be determined by the stewards.
