The Stewards, having received a report from the Clerk of the Course, summoned and heard the driver Mr. Herbert Lösch and Co-Driver Mrs. Lara Quast (Summons No 2, Doc. No. 2.4), have considered the following matter, determine the following:

- **Fact:** Car no 9 did not follow the Road Book and not pass through the refueling and tyre marking zone (Road Book 1, page 15, Box 2)
- **Offence:** Breach of the Art. 13.8, Art. 19.2 of the FIA 2024 Regional Rally Sporting Regulations (RRSR)

## Decision: To impose a fine of € 200 on the Competitor Car No 9 Herbert Lösch

In accordance with Article 12.8 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: <u>https://fiafines.fia.com</u>. Any delay in making payment may entail Suspension during the period a fine remains unpaid.

**Reason:** The Crew admitted the offence and regretted it, explaining that it was a mistake by the crew due to lack of experience.

According to the Art. 19.2 of the FIA 2024 RRSR, the compulsory itinerary of the rally is defined in the Road Book by the road direction diagrams and, between the road direction diagrams, by the defined roadway.

For checking and marking the tyres, the crew has to pass through the tyre marking zone and has to stop its car and wait for the instructions of the scrutineers and/or marshal (Art. 13.8 of the FIA 2024 RRSR).

The Stewards therefore concluded that the crew of car no 9 was in breach of the above regulations and the penalty imposed is proportional under the abovementioned circumstances.

The decision is based on FIA 2024 ISC Art. 11.9.1, Art. 11.9.3.a, Art. 11.9.3.f, Art. 12.4.1.c



Competitors are reminded of their right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
