The Stewards, having received a report from the Clerk of the Course (Doc 3.11), based on a police report, summoned and heard the driver Mr. Stig Andervang and Co-Driver Mr. Aaron Jungnickel (Summons No 3, Doc. No. 4.3), Mrs. Hanzig (Police Superintendent) and Mr. Reissmann (Police Constable) have considered the following matter, determine the following:

Fact: During the administrative checks, the competitor presented the registration

documents of the car, which were found by the police during the event to be invalid

for public traffic in Germany.

Offence: Breach of the FIA 2024 International Sporting Code Art. 3.4.2, Art. 3.13.1, Art.

12.2.1.b, Art. 12.2.1.c, FIA 2024 Regional Rally Sporting Regulations Art. 30.2,

German National Road Traffic Regulations in Germany

Decision: To disqualify Competitor Car No 8 from 27th International ADMV-Lausitz-Rally

To impose a fine of 10.000 € on the Competitor

In accordance with Article 12.8 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: https://fiafines.fia.com. Any delay in making payment may entail Suspension during the period a fine remains unpaid.

Reason:

The Competitor was summoned and was given the possibility, to bring forward any statements. Mr. Stig Andervang attended the hearing an explained.

During the hearing, the representatives explained that they plan to register the car in Sweden. They have not yet done so, as the purchase contract has not yet been paid in full. They have car insurance, as well as confirmation that the car is roadworthy. They also pointed out that they have already participated in a number of rallies with the same car, including in 2024, including also in Germany.

The Stewards point out that they are only investigating whether the car is currently able to take part in public traffic in Germany during this particular event.

The representatives of the police explained during the hearing that the documents submitted by the competitor do not meet the requirements for vehicle registration and do not entitle to drive in public traffic in Germany.

It is understood and undisputed that participation in the rally discipline implies the need to drive legally in public traffic (e. g. on the road sections).

The stewards decide that the absence of a vehicle registration document and of a public traffic permit constitutes a serious offence. In the absence of documents confirming the proper registration of the car and allowing it to participate in public traffic, the competitor was not entitled to register for the event. To do otherwise is contrary to the fundamental principles of motorsport and causes great damage,

including but not limited to the FIA, the DMSB, the Organiser and the motorsport community as a whole.

The decision is based on FIA 2024 ISC Art. 11.9.1, Art. 11.9.3.a, Art. 11.9.3.f, Art. 12.4.1.m, Art. 12.4.1.c

Competitors are reminded of their right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.

According to Art. 12.3.3.b of the FIA 2024 international Sporting Code, this decision becomes immediately binding even in the event of an appeal as it concerns a question of irregularity of Entry by a Competitor entering a Competition and a breach of Art. 12.2.1.b, Art. 12.2.1.c of the FIA 2024 ISC.
