All Competitors / crew members

The Stewards, having received a report from the Clerk of the Course, summoned and heard the above-mentioned crew, have considered the following matter and determine the following:

Fact The Competitor of Car No.112 did not collect the recce code on Wednesday, 2nd July

and therefore his recce app has not been activated during recce.

Offence Breach of Article 35.4.4 of the 2025 FIA Regional Rally Sporting Regulations and

Article 9.3 of the Supplementary Regulations.

Decision Driver Pierluigi MAURINO and Co-driver Samuele PERINO shall be jointly and

severally liable to pay a fine of € 500.

In accordance with Art. 12.8 of the 2025 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: https://fiafines.fia.com. Any delay in payment may entail Suspension during

the period a fine remains unpaid.

Reason The Stewards received a report from the Clerk of the Course on Thursday, 3rd July

stating that the recce code for Car No. 112 has not been collected during Admin checks on Wednesday, 2nd July and therefore the recce app has not been activated

during recce.

The Stewards then summoned and heard from the driver Mr. Pierluigi MAURINO, the Co-driver Mr. Samuele PERINO, of car No. 112 on Thursday, 3rd July, at 19:00 hrs.

The Driver of Car No. 112 explained that on Wednesday they faced some problems during the day which caused them to arrive late to Rally HQ to collect their rally materials. Due to their lateness, they were not able to collect the recce code.

Article 35.4.4 of the 2025 FIA Regional Rally Sporting Regulations clearly stipulates that to monitor the speed during reconnaissance, it is mandatory that each reconnaissance car should be equipped with a tracking system. Additionally, Article 9.3 of the Supplementary Regulations stipulates the procedure concerning the mandatory use of this tracking system for reconnaissance.

Having considered all the above, the Stewards conclude that imposing the above-mentioned fine is appropriate in this case.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2025 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.
