The Stewards, having received a report from the FIA Technical Delegate with documentary evidence attached, summoned the above crew members as well as a competitor's representative, have considered the following matter and determine the following:

Facts During the scrutineering of repaired cars on Sunday, 6th July 2026, the car of

Competitor No. 93 was found completely locked (doors, bonnet and rear boot).

Offence Breach of Article 253.5 of Appendix J to the 2025 FIA International Sporting Code

Decision Fine of 500 € on the Competitor/Driver of Car No. 93 MAURO PORZIA

In accordance with Art. 12.8 of the 2025 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: https://fiafines.fia.com. Any delay in payment may entail Suspension during

the period a fine remains unpaid.

Reason A hearing was held on Sunday, 6th July 2025 at 14:00 with the Driver Mauro PORZIA

and Co-Driver Arianna GENARO.

The Crew stated that after their retirement on Saturday, 5th July 2025, the repaired car was brought into Parc fermé by a mechanic who was not well aware of the rules and felt that he could not leave the car unlocked. Therefore, he closed doors, bonnet and rear boot of the car.

As stipulated in Art. 253.5 of Appendix J to the 2025 FIA International Sporting Code – Additional Fasteners, *The original locking mechanisms must be rendered inoperative or removed.* Art. 253.5 of Appendix J to the 2025 FIA International Sporting Code does not specify when it must be rendered inoperative or removed. For this reason, it must always be inoperative during the rally, even when the car is in Parc fermé.

The Stewards therefore conclude that this is a breach of Art. 253.5 of Appendix J to the 2025 FIA International Sporting Code and levy the above-mentioned fine.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2025 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.
