All Competitors / crew members

The Stewards, having received a report from the Clerk of the Course, summoned and heard the above-mentioned crew members, have considered the following matter and determine the following:

Fact The recce app of Competitor of Car No. 94 has not been activated during recce.

Offence Breach of Article 35.4.4 of the 2025 FIA Regional Rally Sporting Regulations and

Article 9.3 of the Supplementary Regulations.

Decision Driver Giuseppe PIUMATTI and Co-driver Sonia PIUMATTI shall be jointly and

severally liable to pay a fine of € 500.

In accordance with Art. 12.8 of the 2025 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: https://fiafines.fia.com. Any delay in payment may entail Suspension during

the period a fine remains unpaid.

Reason The Stewards received a report from the Clerk of the Course on Thursday, 3rd July

stating that Competitor 94 collected his recce code, was instructed how to operate the app and was kept open for some time but closed before the recce of the stages.

The Stewards then summoned and heard from the driver Mr. Giuseppe PIUMATTI, the Co-driver Mr. Sonia PIUMATTI, of car No. 94 on Thursday, 3rd July, at 19:15 hrs.

The Co-Driver explained that she had had some problems with the GPS and therefore closed the app by mistake. The Crew apologised for their mistake.

Article 35.4.4 of the 2025 FIA Regional Rally Sporting Regulations clearly stipulates that to monitor the speed during reconnaissance, it is mandatory that each reconnaissance car should be equipped with a tracking system. Additionally, Article 9.3 of the Supplementary Regulations stipulates the procedure concerning the mandatory use of this tracking system for reconnaissance.

Having considered all the above, the Stewards conclude that imposing the abovementioned fine is appropriate in this case.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2025 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.
