The Stewards, having received a report from the FIA Deputy Technical Delegate, summoned the competitor's representative, have considered the following matter and determine the following:

Facts The FIA seal from the rear differential housing, applied at pre-rally scrutineering, was

removed from Car No. 26 before the end of the rally. The rear differential fitted in the

car and the spare rear differential were opened.

Offence Breach of Article 16.3.8 of the 2025 FIA Regional Rally Sporting Regulations

Breach of Article 32.2 of the 2025 FIA Regional Rally Sporting Regulations

Decision Disqualification of Competitor No. 26 from Rally di Roma Capitale 2025

Reason The Stewards heard from the team manager, Mr. Daniele PELLICCIONE along with

the sporting director Mr. Massimiliano BOSI on 6th July 2025 at 16:35 hrs in the presence of the FIA Technical Delegate. The team engineer stated that their car has had an accident on SS10 and they were in a rush to repair it. They had contacted the FIA Technical Delegate by e-mail on 6th July at 12:20hrs to inform him that they would need to change the rear diff, followed by another e-mail at 12:24hrs stating that they will only change the internal part and then would need a new sealing. The FIA Technical Delegate replied at 12:25 hrs that this is not possible. The team manager continued to explain that as they had already started repairing the car, he did not see the reply from the FIA Technical Delegate in time and so they started working on the rear diff. He apologised for their lapse in judgement.

The removal of FIA seals is prohibited in the 2025 FIA Regional Rally Sporting Regulations under Article 16.3.8 which states that "The marking/sealing must remain intact from pre-rally scrutineering until the end of the rally." Subsequently, Article 32.2.2 of the same regulation's mandates that once the FIA seals are affixed, it is the responsibility of the competitor to see that they are preserved intact from pre-rally scrutineering until the end of the rally.

The Stewards conclude that the action of the Competitor in removing the FIA seals before the end of the Competition is considered as technical non-compliance with the 2025 FIA Regional Rally Sporting Regulations. Therefore, under the authority given to them through FIA ISC Art. 11.9.3.i and Art.12.9.1, the Stewards decide to disqualify the Competitor of Car No. 26 from Rally di Roma Capitale 2025.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2025 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.
