The Competition will be run in accordance with the FIA International Sporting Code and its appendices, the Estonian Rallysprint Sporting regulations, the Technical Regulations, the FenixBet Estonian Crosskart and Junior Rallysprint Championship 2026 general regulations, FenixBet Estonian Crosskart Noored and Crosskart Junior Rallysprint Cup general regulations and these Supplementary Regulations and with all amendments of these documents.

3. Competition classes, vehicles and tyres

3.1. Competition classes

3.1.1. Crosskart Xtreme: participants with age of 15 years and older (born 2011)

3.1.2. SEENIOR 50. A separate classification for Crosskart Xtreme participants aged 50 and older (born 1976 or earlier).

3.1.3. Crosskart noored. Additional non-championship class for crosskarts with engine capacity till 400cc. Participants with age of 12 years (incl). Does compete in Cup championship.

3.1.4. SSV: 4WD cross country vehicles, participants with age of 16 years and older

3.1.5. NOORED: Competitor 14 – 17 years old (provided that they do not turn 18 during this season). 2WD cars with an engine capacity of up to 1600 cm³, which meet the Folks Rally and sprint technical regulations in class J16 (only cars with a safety cage are allowed to participate – so- called national R1 cars).

3.1.6. JUUNIOR: Competitor 16 – 21 years old (provided that they do not turn 22 during this season). 2WD cars with an engine capacity of up to 1600 cm³, turbocharged cars with a displacement of up to 999 cm³ that comply with the Estonian Rally Championship technical rules for car racing, classes EMV4 and EMV8.

3.1.7. Crosskart Juunior: Classification for crosskarts with an engine capacity of up to 400cc, 600cc, 750cc, or 850cc, with a maximum permitted engine speed of 10,600 rpm. Participants aged 12–16 (year of birth 2014 or earlier). Does compete in Cup championship.



3.1.8. Crosskart 650. Additional non-championship class for crosskarts with engine capacity till 650cc. Participants with age of 15 years and older (born 2011 or earlier). **Does not compete in Estonian Championship nor Cup standings.**

3.2.1. Class 3.1.1, 3.1.2 and 3.1.7. competition vehicles must comply with the 2026 Estonian Cross Car technical regulations. The rules can be found at <https://autosport.ee/sport/rallikross/>

3.2.1.1. Class 3.1.3. (Crosskart noored) competition vehicles must comply at least with the Crosskart 250 technical regulations.

3.2.2. In class 3.1.4., competition vehicles must comply with the technical regulations of the SSV. The rules can be found at <https://autosport.ee/wp-content/uploads/2026/03/SSV-Tehnilised-tingimused-2026.pdf>

3.2.3. In class 3.1.5. the competition vehicles must meet the technical regulations of the Folks Rally and Sprint for J16 class cars (only cars with a safety rollbar are allowed to participate – so- called national R1 cars). 2WD cars with an engine capacity of up to 1600 cm3.

3.2.4 In class 3.1.6. competition vehicles must meet the technical regulations of Estonian Rally Championship classes EMV4 ja EMV8. 2WD cars with an engine capacity of up to 1600 cm3, turbocharged cars with a displacement of up to 999 cm3.

3.2.5. In class 3.1.8. competition vehicles (also tyres) must comply with the Crosskart 250 and Crosskart 2026 technical regulations. The rules can be found <https://autosport.ee/wp-content/uploads/2026/01/Crosskart-250-ja-650-Tehnilised-tingimused-2026.pdf>

3.3.1. Tyres used in the Crosskart Xtreme, SEENIOR 50, Crosskart Juunior and Crosskart 650 classes must comply with Appendix 1 of the General Regulations.

3.3.2. Tyres used in the Crosskart Noored class must comply with Appendix 2 of the General Regulations.

3.3.3. Tyres used in the NOORED class must comply with Appendix 3 of the General Regulations.

3.3.4. Tyres used in the JUUNIOR class must comply with Appendix 4 of the General Regulations.

3.3.5. Tyres used in the SSV class must comply with Appendix 5 of the General Regulations.

3.3.6. In all classes 3.1.1–3.1.7, any kind of tyre modification (cutting, grinding, milling, etc.) is prohibited. The use of tyre warmers and rolling machines is also prohibited.

3.3.7. The organiser has the right to specify additional restrictions regarding competition tyres in the Supplementary Regulations.

3.3.8. The number and placement of auxiliary lights are free, provided that they do not dazzle the driver and are securely mounted.

4. Competitors

4.1. One (1) competitor may compete with one competition vehicle.

4.2. Each driver can compete in only one car and in one competition class.

4.3. According to the decision of the board of the EASU, athletes with Russian and Belarusian citizenship are not allowed to participate in the competition.

4.4. The driver must sign the entry form pre-filled by the organizer and, if necessary, prove the existence of the driver's license.

4.4.1 All adult drivers (18 years and over) must hold a minimum of an EASU national driver's license or a valid license for another ASN.

4.4.2 Drivers up to 18 years old must have a valid EASU youth license and, in addition, a parent or legal representative's permission form must be filled and signed, the form of which can be found at the following link: <https://uus.autosport.ee/wp->

4.5. By registering for the competition, the participant (or, in the case of minors, their legal guardian) confirms that participation is voluntary and acknowledges that motorsport is dangerous and involves risks to the participant's health and property. In the event of an accident, the participant shall not hold the organisers or the EASU liable.

4.6. **All competitors must have a valid competitor's license.**

4.7. The maximum number of entries is **45**. If more than the maximum number of entries is received, the acceptance of entries will be at the sole discretion of the Organiser.

5. Entry fee

5.1. The entry fee for **all classes is €400**. The above-mentioned amount is the final price limit for the entry fee and no additional charges in the form of national or local taxes are allowed. Entry fee includes meals for the driver and one of his mechanics. **If the competitor wishes to bring an additional person to the catering, the cost is €20. The additional person fee must be paid and must be reported no later than administrative checks.**

6. Running of the event

6.1. Reconnaissance:

6.1.1 The organizer will publish videos of special stages on the official notice board on 21st of August 2026 at 18:00.

6.1.2 Recce passages (on foot or by bicycle) are not limited and can be made once with competition vehicle according to schedule immediately after the drivers briefing.

6.2. Competition is taking place as the individual time trial and the start shall take place with the car stationary and the engine running.

6.3. In the pre-start area, the competitor must be ready **2 minutes before their start time**. In case of delay to the start, a penalty of 20 seconds will be added to the round's stage time.

6.4. It is prohibited to use external assistance in the pre-start area.

6.5. Starting order and the time interval will be decided by the Clerk of the Course after the end of administrative checks.

6.6. Penalty for the false start is 10 seconds, which will be added to the time of the heat.

6.7. Start will be given by traffic lights with the car stationary and the engine running.

6.8. Timing will be to a tenth of a second.

6.9. Clerk of the Course has the right to penalise for touching track barriers and markers with time penalty 5 seconds for each infringement, which will be added to the time of the heat. "Touching" is considered moving the barrier or marker from its original position by at least 1/3 of the bottom diameter of the marker.

6.10. A restart may be granted to a competitor only if his round was stopped by a red flag. In other cases, if the situation is justified (a slow competitor was in front of him on the track, etc.), the competitor will be assigned a fair round time by the decision of the Clerk of the Course or the Stewards. Competitors who have been granted a restart will start in the same round at the end of their competition class in the starting order determined by the Clerk of the Course.

6.11. Competition numbers issued by the Organiser must be fixed to the engine cover.

Drivers with competition numbers according to Estonian Rallycross Technical Regulations must state their number at the administrative checks..



- 6.12. The competition consists of **one special stage**. Each competitor is allowed up to 4 runs for stage.
- 6.13. The Clerk of the Course will determine the starting order for special stage by competition class in accordance with points 6.14 of the supplementary regulations.
- 6.14. Each run will be timed.
- 6.14.1. The ranking of the event in the Crosskart Xtreme, SEENIOR 50, SSV and Crosskart 650 classes is determined by summing the times of all completed rounds of special stage.
- 6.14.2. The ranking of the event in the remaining classes is determined by summing of each competitor's three fastest round times from special stage.
- 6.15. For each special stage's round that is not passed or the competitor is retired, competitor's result will be determined by the best time of its classes round plus 45 seconds
- 6.16. For each round not started, the competitor will receive a DNS (Did Not Start), and the competitor will not receive a result for that round.

7. Classification

- 7.1. The final classification of the round is determined by summing the competition class times according to points 6.14 – 6.16 of the supplementary regulation. The competitor with the lowest time is the best. In the event of a dead heat, the competitor who sets the best time on the last heat will be preferred. If this is not sufficient, the times of the penultimate etc shall be taken into consideration. Only drivers with results from at least two heats from same special stage will be classified.

8. Safety

- 8.1 Safety of the competition vehicles and drivers.
- 8.1.1 A liquid-proof underlay (PVC) of at least 2x3 meters must be used under the competition vehicle (except classes NOORED and JUUNIOR) while servicing in Service Park. In the class NOORED liquid-proof underlay of at least 3 x 5 m must be used under the competition vehicle while servicing in Service Park.
The use of the underlay is compulsory under the threat of the fine of 50 €
- 8.1.2 In classes 3.1.1., 3.1.2., 3.1.7. and 3.1.8. the safety equipment (helmets, fireproof overalls and underwear etc.) of drivers must comply with the Cross Car 2026 technical regulations.
- 8.1.3.1 Depending on weather conditions non-homologated gloves and overcoats is permitted.
- 8.1.4 In class 3.1.4, the safety equipment of drivers (helmets, fireproof overalls and underwear etc.) must meet the technical regulations for SSV (4WD cross country vehicles).
- 8.1.5. In classes 3.1.5 and 3.1.6. the safety equipment of the drivers (helmets, fireproof overalls and underwear etc.) must comply with section 2.9 of the technical regulations for Folks Rally and Sprint in classes J16 and J18.
- 8.1.6 By the proposal of the Scrutineers to Clerk of the Course or the Stewards may not allow to start competition vehicles whose technical condition may become dangerous for the driver and those around them during the competition, and which may disturb the course of the competition.
- 8.1.7 Fire extinguishers minimum 6 kg must be present at each service zone.
- 8.2 All participants and their team members must do everything possible to minimize environmental pollution.

9. Competition area

9.1. The area of the competition is considered to be the streets selected for the Humus Paide Rally 2026 city stage, which are marked on the special stage scheme as the road section selected for the special stage.

9.2. In the territory of the competition, you must follow the orders of Clerk of the Course and the persons authorized by him.

9.3. Only drivers' and organisers' cars are allowed on the competition territory. The maximum speed allowed in the pit area and on the exit road is 10 km/h, failure to do so is punishable. The Clerk of the Course has the right, visually judging, to penalize with fine (€50) or disqualify the driver from the competition for speeding.

10. Protests and appeals.

10.1. According to FenixBet Estonian Crosskart and Junior Rallysprint Championship 2026 and FenixBet Estonian Crosskart Noored and Crosskart Junior Rallysprint Cup 2026 general regulations point 10. Protest fee is 500 €. Appeal fee is 3000 €.

11. Prize-giving

11.1. Three best drivers in each championship class will be awarded with cups.

11.2. Prize-giving is taking place after the competition.
