Comisarii Sportivi au primit raportul arbitrilor din CO 1 si CO 2, au analizat inregistrarile din centrul de calcul, au luat in considerare situatia si au decis urmatoarele:

Fapta: Concurentii 42 si 502 au avut intarzieri in CO1, respectiv 52; 78; 29 si 524 au avut intarzieri in CO 2.

Decizia: Nu se aplica penalizari.

Motiv: Comisarii Sportivi au fost informati despre intarzierea concurentilor 42 si 502 in CO1, respectiv 52; 78; 29 si 524 in CO2 cauzate de traficul aglomerat. In urma analizarii situatiei si a probelor puse la dispozitie de catre concurenti, Comisarii Sportivi au decis sa nu se aplice penalizari concurentilor mentionati mai sus pentru intarzierea in CO1 si CO2.

Concurentilor li se reaminteste ca au dreptul de protest impotriva deciziei Comisarilor, in concordanta cu Art. 15 din Codul Sportiv International si Art. 9.1.1 din Regulamentul Judicial si Disciplinar FIA, in termenul aplicabil.

The Stewards received the report from the TC 1 and TC 2 referees, analysed the timekeeper records, considered the situation and decided the following:

Facts: Competitors 42 and 502 are late in TC1, respectively 52; 78; 29 and 524 are late in TC 2.

Decision: No penalties are applied.

Reason: The Stewards were informed about the delays of competitors 42 and 502 in TC1, respectively 52; 78; 29 and 524 in TC2 caused by heavy traffic. After reviewing the situation and the evidences provided by competitors, the Stewards decided not to apply penalties to the above mentioned competitors for delays in TC1 and TC2.

The competitors are reminded that they have the right to appeal the decision of Stewards, according to Art. 15 of the International Sporting Code and the Art. 9.1.1 in the FIA Judicial and Disciplinary Regulations, within the applicable timeframe.
