TEAM SPEED SLALOM RULES

July 2022



1. COMPETITION AREA

The WSE Champions League - Men is owned and controlled by World Skate Europe (WSE) and all media, commercial, marketing, television, merchandising, sponsorship and advertising rights are exclusively owned by WSE, or an entity designated by WSE.

Therefore, WSE is the sole owner of all international television and internet broadcast.

The Team Speed Slalom competition area is the same as the Speed Slalom competition area. (See Section 7.1 of the World Skate Inline Freestyle Regulations)

2. COMPETITION REGULATIONS

The Team Speed Slalom competition regulations are the same as the Speed Slalom competition regulation. (See Section 7.2 of the World Skate Inline Freestyle Regulations) except for following rules related to specific team competition:

3. TEAM PRINCIPLE

3.1. REGISTRATION

The teams are registered prior to the competition, the name of the team shall be “Club Name-City”.

3.2. COMPOSITION

The teams can be formed by juniors & seniors together in the same team.

Each team is composed of members of the same club (as described in the national federation license).

Each club can present 1 team per gender.

One skater could be registered only in one team.

To be part of the team, each skater shall register in speed slalom and participate at the qualification.

Each team is formed by 3 or 4 skaters.

3.3. REGISTRATION PROCESS

3.3.1. STEP 1: REGISTRATION OF THE TEAM:

The registration of the team is included in the Entry form of the team.

A pre-registration of the skaters is established.

3.3.2. STEP 2: CHECK-IN OF THE COMPETITION:

The Manager shall define the composition of the team.

3.3.3. STEP 3: FINAL PHASE

During the final phase, at each round, the team will choose 3 skaters + 1 substitute (see appendix 1).

Each skater will be ranked as 1, 2, 3, by the team manager for each round before the first run of the round.

In case of injury of one skater during round: The team should advise the following judge and lose the next run of the injured skater. After that they can swap with the substitute skater.

4. QUALIFYING PHASE

The individual Speed Slalom Qualifying phase is also used as Team Speed Slalom Qualifying phase. The best 3 individual skaters times (Best 3 of 4 individual skaters time in the team who have a substitute) of one team will be added up to calculate the team qualification time. Depending on the number of teams and at the head judge's discretion, the top 4 or 8 teams are qualified for the final phase.

Ranking In case of at least one athlete of a team of 3 skaters have no time (DQ) in her/his both qualification runs, the whole team will be DQ.

Ranking In case of at least two athletes of a team of 4 skaters have no time (DQ) in her/his both qualification runs, the whole team will be DQ.

5. FINAL PHASE

The team manager selects 3 skaters per round robin and (see chapter 3.3). Team manager might not be aware of the order of the other team before giving his order when it's requested by the head judge or his delegate without delay.

Each member of each team will have one run against each member of the other team. The first team to win 5 runs, wins the round and goes directly through to the next round, the other team is knocked out (except for the semi-final, goes to 3rd place round). In each round, one team will keep the same line for the whole round. The best team in qualification will be on line 1. The runs order is described in appendix 2.

In one same team, each skater will be ranked as 1, 2, 3, by the team manager for each round before the first run of the round.

If there is no winner for a run, the run is not played again. it skipped the next planned run.

In case of tie after the 9 runs, extra runs with two skaters chosen by team (1 minute to give the name of the skater to the following judge of their line).

Runs will be done until there is a winner without possibility to change the skater.
