Tyre Limits

Competitors Attention is also drawn to R48.5.11 in the Motorsport UK 2024 blue book, Tyre Limits. A copy of the appropriate document can be found on Sportity and the tyre record form is located at the back of the road book. Competitors are reminded that the form must be returned at the same time as the damage declaration form either at the finish or on retirement

The maximum number of tyres to be used on the 2024 Circuit of Ireland Rally is 12.

Road Book Corrections

- 1. The itinerary in the road book and regulations has been superseded; the latest version is available on Sportity.
- 2. The special stages mileages in the road book are recorded from start to stop rather than start to flying finish.

The correct competitive mileage for each of the stages is set out below.

As a result the miles to control (Flying Finish) is also wrong for each stage. Please subtract the intervals below from each mileage in the "miles to control" column to correct the error.

To further highlight these corrections a flying finish board will be placed at the appropriate location on each special stage during reconnaissance.

Reconnaissance

Competitors are reminded of the 30mph speed limit in place during reconnaissance. The roads are not closed residents will be moving about the stages as normal and the school holidays have started so children may be playing in the area.

Please also be aware that stage commanders and their crews will be moving about the stages installing the stage furniture and have been instructed to wear hi viz tabards, and to monitor the activities of those carrying out reconnaissance. They may also annotate the infringement card in the competitor's road book.

As a further hazard one or more tractors may be moving about the stages installing the competitor protection bales, but not the chicanes.

Competitors carrying out reconnaissance on 29th March are warned that there are floods in places on the special stages after the recent rain

False Starts
