- The planning, telephone and schedules will be provided to all participants during the delivery of documentation.













5. NOTES FROM THE COMPETITION

5.1. DESCRIPTION

- SS1 Las Canales 5,34 km There will be no Parc ferme at the end of the stage, the vehicles will remain in the service, taking place on Friday.
- SS2 Caravaca Lorca, 176,88 km taking place on Saturday...
- Regrouping and service in Lorca.
- SS3 Lorca-Caravaca, 176,88 km taking place on Saturday, the section that will be run in the opposite direction to SS2, the start of SS2 coinciding with the finish line of this section, the correct path signage will be on the left to this section being the dangers marked accordingly in the sense of the section.
- End of the rally Avenida Juan Carlos I.

T8 -regularity route:

- SS1, 5,34 km. (There will be no Parc ferme at the end of the stage, the vehicles will remain in the service).

 * The T8 Vehicles will all start grouped according to the SS1 classification.
- SS2 Caravaca-El Pinar, 111 km, the teams will go by road to the regrouping.
- Regrouping and service in Lorca
- SS3 Lorca.- El Pinar, 66,57 km, the section that will be run in the opposite direction to SS2, the start of SS2 coinciding with the finish line of this section, the correct path signage will be on the left to this section being the dangers marked accordingly in the sense of the section.
- End of rally Avenida Juan Carlos I.
- 5.2. During the rally, the official time will be the one provided by the GPS time information of the competition, published by the Clerk of the course.

6. ADMITTED VEHICLES

■ The vehicles described in Annex 9 of the CERTT Loterias Sports Regulations are allowed to participate and score in the competition.



















7. ENTRIES

7.1. DEADLINE DATE AND TIME OF THE ENTRIES:

- Entries will close at 2:00 p.m. on Wednesday of the previous week.
- Entries must be made through the web application enabled for this purpose by the RFEDA, complying with the provisions of Annex 8, before the closing time for registrations, and the registration fee must be paid through the application.
- The maximum number of entries is set at 80 vehicles. If this figure is exceeded, the selection will be made in accordance with the provisions of art. 12.3 of the Sports Regulations of the CERTT Lotterias
- The Organizing Committee reserves the right to refuse a registration in accordance with the provisions of article 3.14. of the C.D.I..
- The final entry list must be published on Friday at 8:00 p.m. the week prior to the rally.

7.2. ENTRY FEES

■ The entry fees would be the following:

CERTT 960 euros.
CERTT T8 560 euros.
CERTT REGU. 410 euros.

Without the advertising proposed by the organizer:

CERTT 1920 euros CERTT T8 1120 euros. CERTT REGU. 820 euros.

- Registration fees will be paid through the web application enabled for registration.
- Other fees:
 - o Additional assistance plates 150 €
- 7.3. Registration fees include GPS device
- 7.4. It will be an essential requirement to validate the registration to complete all the sections required by the web application
- 7.5. Registration fees will be fully refunded:
 - Competitors whose registration has been rejected.
 - In case the competition is not held.
 - The organizer may reimburse up to 50% of the registration fees to competitors who, due to duly verified reasons of force majeure, could not attend the competition.













8. ADVERTISING

- 8.1. The provisions of Appendix 8 of the CERTT Lotteries shall apply.
- 8.2. Competitors who accept the advertising proposed by the organizer must reserve the spaces described below:

- 8.3. Before the technical Scrutineering there will be an Official in charge of reviewing the placement of plates and advertising of the competition. In the event that they were not placed in accordance with the criteria and location contained in the preceding graph, they either correct the noted deficiencies or they will not be authorized to start.
- 8.4. Buggys and/or special prototypes that have different dimensions and do not allow the placement of plates and/or mandatory or optional advertising, must notify the organizer, indicating the available dimensions. Exceptions will only be allowed for vehicle design and bodywork.

9. PENALTIES

The Penalties are those described in Appendix 1 of the Sports Regulations of the CERTT Lotteries

9.1. Súper Rally

- The reincorporation of a vehicle to the race is allowed in accordance with the provisions of article 22.3 of the CERTT Lotteries Sports Regulations, setting the maximum time for communication by the team:
- Departure time from the Service Park of the first participant to the corresponding Section.
- The maximum times of the Selective Sections and the times to be applied in the Super Rally will be the following

- 10.1. The Prize-giving will be in Alameda de la Constitución in accordance with the provisions of article 12 of Annex 8 Rules to be met, of the CERTT Lotteries Sports Regulations
- 10.2. The Prize awarded will be those established in article 31 of the CERTT Lottery Sports Regulations.

11. GPS. OVERTAKING DEVICE

The use of a Vehicle Positioning and Tracking Control system, supplied by ALKAMEL SYSTEMS, is mandatory for all registered teams in the CERTT Lotteries.

Registration fees include the GPS device.
