4. FIA AND OTHER TITLES ELIGIBILITY

4.1. 2024 FIA titles towards which the event counts

As per Article 15 of the FIA Sporting Regulations.

The winner of the Bridgestone FIA ecoRally Cup 2024 will be the crew that has the lowest number of penalty points from the regularity secret controls and the time controls. The related classification will be combined with the results of the performance index. In the event of a tie in total points, the participant with the highest placement in the Energy Performance Competition will be ranked first.

5. VEHICLES ELIGIBLE TO PARTICIPATE

As per Articles 1.1 and 6.1 of the FIA Technical Regulations.

The eligible (admitted) cars are those listed in the FIA "Compatible Cars" List, in accordance with Article 2 of the Sporting Regulations.





6. GENERAL CONDITIONS

- 6.1. The event will be organised in conformity with:
 - the FIA International Sporting Code and its appendices;
 - the Sporting and Technical Regulations of the Bridgestone FIA ecoRally Cup;
 - the applicable prescriptions stated in the National Sporting Regulations; and
 - the present Supplementary Regulations.

The organising committee will ensure that the event complies with all of the above rules and regulations and that it has received all required administrative authorisations.

6.2 Insurance

The organiser has contracted insurance covering the following risks:

Organiser's liability insurance

The organizer has an insurance policy with Zavarovalnica Triglav d.d. organiser's liability insurance covering damage caused to the third party during the competition up to 5.000.000,00 €.

Damage caused to the third party

The rally insurance policy of the organizer guarantees competitors to cover damages towards third parties for property and for individuals, but only with competition cars on special stages. The insurance cover will come into effect from the start and till the end of the rally or at the moment of permanent retirement, disqualification or exclusion. On the other areas the crews cover damages from their own insurance policy. The organizer does not take any responsibility for the losses and the damages in regard to competitors. The competitors take part in the rally at their own risk.

Insurance policy and International Green Card

All crews will have to submit an administrative check an insurance policy with cover for participation in competitions and training, the crew from abroad as well as international green card for their car. Without it, the crews will not be permitted to take the start. Insurance Coverage for the competitors and crews All the competitors are obliged to arrange their own life accident insurance. The proof should be documented on request at administrative check. By the fact of signing the entry form, the competitors accept the terms from the Supplementary Regulations and relinquishes any rights to compensations of any kind which may occur following the incidents during the rally. This relinquishment concerns the FIA, the AŠSLO (ASN of Slovenia), the Organizer, officials and other competitors. Accident Reporting

In case of any accident, the crew or their representative should report this fact to the Clerk of teh Course on his GSM (published in Roadbook) and written report to the Rally HQ as soon as possible, but latest until the publication of provisional results.

7. ITINERARY AND LAYOUT

In this paragraph, the Organiser must provide basic information about the event:

The competition will start at the Trg Evropa in Nova Gorica. Leg 1 will lead true Karst plateu and Vipava valley, and then return to Nova Gorica where there will be a dinner for all competitors. Overnight stay is included in entry fee. The 2. leg will start in Nova Gorica and will lead to Kobarid where we will have brunch and the finish will be at the Trg Evropa in Nova Gorica.

8. RUNNING OF THE EVENT

8.1. Nature of the event

The MAHLE 7. ECO RALLY is an ecoRally that has a combined final classification (regularity + energy performance index), as per Article 3 of the FIA Sporting Regulations.

8.2. Start, Finish, Results

8.2.1. The start signal for the event will be given at Trg Evrope, Kolodvorska pot, Nova Gorica, Slovenia GPS: 45°57′27,6″N 13°38′8,3″E on 1.3.2024.

The first car will start at 12:00.

During the overnight stay and after the finish, the cars will remain in the Parc Fermé, which they will enter as soon as they finish a leg.

The starting sequence will be based on the participation number and the cars will start at one-minute intervals.

8.2.2. The first leg will be made up of 8 Regularity Stages and 1 regrouping, 0 charging stops, etc.

The second leg will be made up of 6 Regularity Stages and 1 regrouping, 0 charging stops, etc.

During the Technical Checks, after installing the FIA devices on the cars, the car must be moved a few kilometres (4 km minimum, e.g. to the calibration zone) and carry out some procedures in order to verify that the FIA metering devices are working properly. The cars must then return to the Parc Fermé as soon as the test course has been completed.

9. DRIVERS' MEETING

The Clerk of the Course will conduct a Drivers' Meeting 1:30h (one hour and thirty minutes) before the first car starting Leg 01.

The Drivers' Meeting should be duly be posted in advance on the Official Notice Board.

The briefing should be also distributed in writing, in English and the language of the event, during the meeting, with the competitors signing an acknowledgement of receipt.

The presence of both competitors (Driver and Co-driver) is compulsory. Absence, except in cases of Force Majeure decided by the Stewards of the event, will be penalised by adding 50 Regularity points to the final Regularity Results of the Race of the relevant competitor(s). This penalty cannot be appealed.





10. CHARGING (BEV/FCEV)

The organising committee will supply for recharging electric power:

- Voltage / Amperage supplied: 230 / to max. 32A
- Type of sockets: IEC 62196-2, IEC 62196-3
- The expected recharging time for Recharging point 2: 01.03.2023 from 18:00 till 2.3.2023 7:30hours



11. PERFORMANCE INDEX CALCULATION

As per Article 3 of the FIA Sporting Regulations and Article 6.2 of the FIA Technical Regulations.

12. ENTRY PROCEDURE AND FEES

The entry fee amount is fixed for each crew comprising two people (driver and co-driver, or driver and navigator):

- a) With the optional advertising proposed by the Organiser: 600 EUR
- b) Without the optional advertising proposed by the Organiser:1200 EUR

12.1 Entry Fee Refund

Entry fees will be refunded in full:

- If the entry is not accepted.
- If the event is cancelled.
- The organiser will refund 50 % of the entry fee to them who excused seven (7) days before start of administrative check.

12.2 Crew documents

A crew is made up of one driver and one co-driver, or one driver and one navigator.

Both must have the following documents:

✓ Driving licence according to the entered vehicles (this does not apply to co_drivers)





- ✓ An IT LSC licence as defined in Article 19 of Appendix L is required. This licence can be obtained for the event, and must be valid for its duration and issued by the ASN or by the organiser's ASN (with the written permission of the competitor's ASN). It must be handed to the participant at the latest during the administrative checks. It will be subject to the payment of a fee 40 EUR.
- ✓ <u>A Competitor licence can be provided by the parent ASN of the entrant. This licence may be combined</u> with the IT LSC licence defined above, but this must be clearly stated on it.
- ✓ Vehicle document permitting its free circulation on public roads.
- ✓ If applicable, the vehicle document required in the Technical Regulations of the Bridgestone FIA ecoRally Cup.
- ✓ Valid vehicle insurance certificate in accordance with the vehicle laws.

12.3. Entry Form

Any person, or legal entity, wishing to participate in the event must submit a completed and signed entry form (see Appendix 1) to the event secretariat, together with all other requested documents, photos, etc. before 16.2.2024 – 24:00.

- 12.4. The field for participation is limited to a total of 30 entries.
 - All entry forms received after the above number of vehicles is reached will be entered on a reserve list.
- 12.5. The minimum number of entries is as per Article 12 of the FIA Sporting Regulations.

13. Advertising Promotion and Publicity

13.1. Official Supporter

The organisation of the event is supported by MAHLE Electric Drives Slovenia, the logos of which must, as a matter of obligation, be displayed on the competition numbers and on any other promotional material intended to be placed on vehicles.  - Invitation to the Prize-Giving Ceremony with dinner

14. PROTESTS / APPEALS

The amount of the protest fee is 400 EUR

Protests against the preliminary official results of the event must be lodged, in writing, in accordance with the prescriptions set in the ISC, with the Clerk of the Course within 30 minutes of the moment of their posting on the official notice board. Upon the expiration of this time period, the preliminary results become final.

Every protest is eligible to be examined by the Stewards of the event only if it is accompanied by the aforementioned protest fee defined in this article, which is not refundable should the protest fail to be upheld.

For the National Court of Appeal, the fees are 1200 EUR

For the FIA International Court of Appeal, the fees are 3000 EUR

The appeal deposit for an international appeal is 3000 EUR

All protests and/or appeals must be lodged in accordance with Articles 13 and 15 of the Code and, where applicable, with the FIA Judicial and Disciplinary Rules.

15. APPLICATION AND INTERPRETATION OF THE REGULATIONS

In case of a dispute over the interpretation of the regulations, the English text will prevail.
