

The Stewards having received a report from FIA technical delegate (Document 6.5), having examined all relevant technical evidence, summoned by CLO and heard the driver Rüdiger Opitz (#321), consider the following matter, determine the following:

**Driver and Car No:** OPITZ, Rüdiger, #321**Competitor:** OPITZ, Rüdiger**Time (fact):** 13/05/2023, 16.45 hrs**Session:** 2<sup>nd</sup> Qualifying Practice Session**Fact:** During technical scrutineering the fuel pressure was not according to the Homologation (2020-01-XCAR-GSXR) for the engine**Offence:** Breach of Article 9.1.4 of the Sporting Regulations of the FIA European Autocross and technical regulation Appendix J Article 279.B-5.1 for Cross Car.**Decision:** **Reprimand** according ISC Article 11.9.3.a and Article 11.9.3.f**Reason:** Having considered the matter extensively, the Stewards determined that there is a breach of Article 9.1.4 FIA European Autocross Sporting Regulations. In the homologation of car # 321 (2020-01-XCAR-GSXR for engine is settled (point 4.402) the maximum pressure for the fuel is 3.6 bar but was measured almost 3.8 bar. The Stewards consider the fact that the used gauge has an internal tolerance by +/- 0,96 bar. Furthermore it was the first infringement for the driver, and it happened during time practice two. Therefore, the Stewards decide to reprimand the competitor.

Competitors are reminded of their right to appeal certain decision of the Stewards in accordance with Article 15 of the FIA International Sporting Code and Article 9.1.1 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
