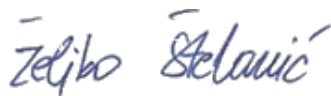
Revizijska Sportska komisija / The appointed Stewards,
u skladu s člankom 93. Pravilnika o autosportovima 2025. primila je prijavu od Tehničke komisije HAKS-a u vezi s pogreškom pri unosu/prijavi SB 37 i razmotrila dobivene informacije te odredila sljedeće / in accordance with Art. 93 of the 2025 CAKF Motorsport Regulations, having received a report from the ASN Scrutineer Commission regarding an error on the entry of car No. 37, have considered the following matter and determine the following:

Činjenice/Facts: Nakon završetka natjecanja Tehnička komisija HAKS-a uočila je pogrešku pri razvrstavanju SB 37 u klasu 2 umjesto klase 3. / After the competition ended, the CAKF Technical Commission noticed an error in classifying the SNo 37 in class 2 instead of class 3.

Odluka/Decision:

1. Potrebno je ispraviti konačne rezultate / Final Classification to be corrected accordingly
2. Potrebno je podijeliti točne nagrade / Prizes to be given to correct crews as appropriate
3. Potrebno je ponovno obračunati bodove za MZPH / MZPH Championship points to be recalculated accordingly
