The Stewards, having received a report from the Clerk of the Course (Doc 3.1), having summoned and heard Mr. Andrey VALERIO (Team Manager) and Mr. Mario FERREIRA (Team Member), have considered the following matter and determined the following:

**Facts** Competitor #415 arrived at pre-event scrutineering 1 hour and 54 minutes after their time schedule.

**Offence:** Breach of Art. 10.1.2 of the Supplementary Regulations of the Event.

**Decision:** To impose a fine of 1.500 EUR on Competitor Car #415, of which the amount of 1.000 EUR is applied with suspension of sentence subject to no further similar infringement during any 2026 FIA Cross-Country Event.  
*In accordance with Article 12.8 of the 2026 FIA International Sporting Code, the payment of the fines must be done 48 hours of their notification. Fines may be paid by means of any mode of payment, electronic included (<https://fiafines.fia.com>). Any delay in making payment may entail suspension during the period the fine remains unpaid.*

**Reason:** During the hearing the Team Manager explained that due to an unexpected issue with their service vehicle in town, they couldn't arrive on time to the Rally HQ – Scrutineering Venue. They declared having sent an email to the Event Secretary explaining the situation.

The Stewards conclude that this is a breach Art. 10.1.2 of the Supplementary Regulations of the event.

When deciding on the penalty to be imposed, the Stewards consider it appropriate to impose a fine in this case.

In suspending a part of the fine, Stewards want to encourage the Competitor to make every possible effort not to breach the established regulations in the future.

The Stewards decision was made based on FIA FIA ISC Art. 11.7.1.a, Art. 11.7.3.a, Art. 11.7.3.f, Art. 12.4.1.c and Art. 12.4.6.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2026 FIA International Sporting Code and Chapter 5 of the FIA Judicial and Disciplinary Rules.
