The Stewards, having received the report from the FIA Technical delegate (doc. No. 4.3 – Annex 1) and after inspecting the situation, summoned and heared the competitor, issued a Decision (doc. No.2.5), determined the following:

After 1st Practice heat

Fact:

During the checks after 1st Practice heat, the front axle width measure results were out of the tolerance. The front and rear axle width declared by the competitor in the PF technical sheet (FIA-PF-ID.Y5C1.316.145) is both 1710 mm. The tolerance is +/- 20 mm. The measured axle width at the

front is: 1743 mm (33 mm more than the declared one).

By recalculating the Performance factor number results, does not change

the classification group.

Offence:

Breach of art.258-1-16.7.9 of the Appendix J.

Decision:

A fine of 250€ which is suspended until the end of the 2024 season, subject to do not further breach of a non-conformity with the PF technical data (outside of tolerance but without changing of group), observed during scrutineering under PF regulations (at any time after the publication of the first "starting order list"), is imposed in accordance with Article 21.1.14 EHC Sporting Regulations — Category 1. It is first time infringement during the

season.

Reason:

Having considered the matter extensively, the Stewards determined that measurement has been carried out complying with the regulations and at no time during the Competition may the car measurements be out of tolerance reported in the PF Technical sheet entered in the Competition and comply with the tolerance established by the technical regulations.
