The Stewards, having received a report from the FIA Technical Delegate with photo evidence, have considered the following matter, determine the following:

Fact: During routine checks after ASS of Stage 3, it was found that the FHR system of the driver was not worn correctly.

Offence: Breach of Article 3.2 – Chapter III of Appendix L of the 2023 FIA International Sporting Code.
Breach of Article 47.1 of the FIA 2023 CCRSR

Decision: **To impose a fine penalty 750 EUR on the Driver**
In accordance with Article 12.8 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: <https://fiafines.fia.com>. Any delay in making payment may entail suspension during the period the fine remains unpaid.

Reason: Whenever the car is in motion on any type of special stage and until the stop control, the crew must wear homologated crash helmets, all required safety clothing and equipment in compliance with Appendix L Chapter III – Driver's Equipment as intended by the equipment manufacturer and their safety belts correctly fastened (Art. 47.1 of the FIA 2023 CCRSR).

The photo clearly shows that the FHR system of the driver was not worn as required by Art. 3.2 – Chapter III of Appendix L of the 2023 ISC and Art. 47.1 of the FIA 2023 CCRSR. FHR is a very important safety item.

The decision is based on the FIA International Sporting Code Art. 11.9.1, Art. 11.9.3.a, Art. 11.9.3.f and Art. 12.4.1.c.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
