The Stewards, having received a request from the Promoter and a waiver given by FIA, having heard the FIA Category Manager, have considered the following matter, determine the following:

#### **Decision:**

The Competitor car No 301 on Wednesday 18 October 2023 is allowed:

- to participate in the promotional operation with young drivers
- to work on the car from 2.30 pm, limited to three people per car and under the supervision of the scrutineers for cockpit adjustments, cleaning, checks (including data acquisition) and bodywork repairs (placement in the Parc Fermé in a dedicated area near the final scrutineering location)
- to take the car out of the Parc Fermé from 3.30 p.m. to 5.30 p.m., solely for the purposes of taking part in the promotional operation

under the following and necessarily mandatory conditions

- (1) the young driver on board must have signed a disclaimer provided by the organiser
- (2) the young driver must wear a homologated crash helmet, all required safety clothing and equipment in compliance with Appendix L Chapter III - Drivers' Equipment and have their safety harness correctly fastened
- (3) after the promotional operation the car should return to the Parc Fermé.

#### **Reason:**

As an exceptional case and for promotional reasons (in order to improve the promotion of the FIA W2RC), it is allowed to give the opportunity for the young drivers to test T3 cars on a 20km loop near the Merzouga bivouac.

Since the promotional activity will be after the end of Stage 5 it will have no affect to all other competitors.

12<sup>th</sup> – 18<sup>th</sup> October 2023

This decision is based on the waiver granted by FIA.

Competitors are reminded of their right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
