3. All entries must be FULLY PAID and submitted by Thursday 19th September
4. Entries are limited to 70 starters
5. All drivers and navigators must hold a valid competition licence of an appropriate grade and all drivers must be listed on the IRDS/BRDS database which is published weekly on the Motorsport Ireland website.
6. Turbo vehicles are **INELIGIBLE**
7. Birr & District Motor Club will use the SPORTITY App as the official notice board. Competitors/users need to download the Sportity app from AppStore or GooglePlay and insert the notice board channel's password **BIRRENDURANCE24**

CLASSES:

As per updated Appendix 35.15.1, the entry will be divided into six classes, as follows:

- A1:** Cars built to Endurance specification up to 1000cc
- A2:** Cars built to Endurance specification from 1001 to 1400cc
- B:** Navigation Trial cars up to 1400cc, (Navigation Trial cars as defined in appendix 33, including such cars if fitted with cages and Open Sports cars fitted with cages).
- C:** Navigation Trial cars from 1401 to 2000cc, (Navigation Trial cars as defined in appendix 33, including such cars if fitted with cages and Open Sports cars fitted with cages).
- D:** Front Wheel Drive Retro type cars (retro cars as defined in appendix 33).
- E:** Rear Wheel Drive Retro type cars (retro cars as defined in appendix 33).
- F:** All other Sports Cars.

AWARDS:

1st, 2nd & 3rd Overall (2 Trophies)

1st, 2nd & 3rd Class (2 Trophies)

Class A2 will be sub-divided into Master, Expert, Semi-Expert, Novice, Beginner.

The Overall winners will be decided from Class A1/A2 only

(Awards as per Appendix 35.20)

ELIGIBILITY FOR AWARDS:

Those receiving awards for overall placing will not be eligible for class awards. The Organisers reserve the right to re-classify a competitor considered ineligible for a class, and /or amalgamate as required. Classification will be based on the performance of the Driver and not the Navigator

Master	This class qualification is: Finishing in the first three overall in an Endurance Trial or Targa Rally in the previous 12 months, or winning any event, except a Navigation Trial or Rally, promoted under an MSUK or MI Permit.
Expert	This class qualification is: Finishing in the first six overall in an Endurance Trial or Targa Rally in the previous 12 months, or winning any event, except a Navigation Trial or Rally, promoted under an MSUK or MI Permit
Semi Expert	This class qualification is: Finishing in the first fifteen overall in an Endurance Trial or Targa Rally in the previous 12 months, promoted under an MSUK or MI Permit
Novice	This class qualification is: No class wins in an Endurance Trial or Targa Rally in the previous 12 months, or any event promoted under an MSUK or MI Permit
Beginner	First year of Endurance Trials or Targa Rallies

TIMING:

Cars will start at 1 (one) minute intervals, except where directed otherwise by the organisers

GENERAL ROUTE:

Organisers will use only 1:50,000 maps: A map of the route will be provided. OS Map: Sheets 53/59 refer.

FORCE MAJEURE/BAULKING:

The organisers will not accept any claim from competitors concerning either Force Majeure or Baulking as per Appendix 35.13.

PENALTIES:

Penalties as per Appendix 35 of the 2024 Motorsport Ireland Yearbook.

DRIVING STANDARDS:

Driving standards will be monitored carefully. Please be sensible and safe, this is a fun event; show us your skills, not your bravery or foolhardiness. Poor driving standards will likely result in exclusion and the Clerk of the Course decision is final.

SCRUTINY REQUIREMENTS:

1. ALL VEHICLES - Scrutiny Requirements as per Appendix 2 and Appendix 35 of the 2024 Motorsport Ireland Yearbook
2. All cars must have a current and valid NCT/MOT certificate, unless exempt
3. Competitors in **ALL** classes must wear helmets, (these helmets do not have to be in date but do need to be in good condition)

TYRES FOR ENDURANCE EVENTS:

In conjunction with Appendix 35 – Standard Regulations for Endurance Trials: Article 21.14, this list will outline the Tyres permitted for the 2024 Endurance Trial Discipline. Class A1 & A2: Control Tyres ONLY. Mandatory on ALL wheels (including spare wheels).

DECLARATION OF INDEMNITY

(a) I have read the supplementary regulations issued for this event and agree to be bound by them and by the General Competition Rules and Regulations of MI including the guidelines and regulations contained in Motorsport Ireland's Code of Conduct for Children's Sport. In consideration of the acceptance of this entry or of my being permitted to take part in this event I agree to save harmless and keep indemnified the Birr & District Motor Club Ltd (Organising Club), Irish Automobile Club Ltd. t/a Royal Irish Automobile Club, Irish Motorsport Federation Ltd. t/a Motorsport Ireland and their respective officials, servants, representatives and agents from and against all actions, claims, costs, expenses and demands in respect of death, injury, loss of or damage to the person or property of myself, my driver(s), passenger(s) or mechanic(s) (as the case may be) howsoever caused arising out of or in connection with this entry or my taking part in this event and notwithstanding that the same may have been contributed to or occasioned by the negligence of the said bodies, their officials, servants, representatives or agents. Furthermore, in respect of any parts of this event on ground where Third Party Insurance is not required by law, this Agreement shall in addition to the parties named above extend to all and any other competitor(s) and their servants and agents and to all actions, claims, costs, expenses and demands in respect of loss of or damage to the person or property of myself, my driver(s), passenger(s) or mechanic(s).
