The Stewards, having received a report from the FIA Technical Delegate with video evidence, having summoned and heard the Crew Members, have considered the following matter, and after due deliberation determine the following:

**Fact:** Both drivers of Car #312 were reported having been working on the rear left of their car during regrouping after TC P1A.

**Offence:** Breach of Art. 2.28, Art. 39.1.4 and Art. 57.1 of FIA 2025 CCRSR.

**Decision:** **To impose a time penalty of 30 Minutes on Stage 1 on Competitor Car No 312.**

**Reason:** During the hearing, the Crew members admitted to the incident and apologised for it. They explained that they had asked a marshal on site if they could carry out some repairs during regrouping. They said that the marshal, who was wearing a scrutineer's black tabard, had told them it was OK. They were unaware that they had received incorrect information.

Stewards could investigate with the FPAK Technical Delegate to confirm that the Crew members did indeed receive the wrong information.

The Stewards reminded the crew members of the regulations in force and their obligation to comply with them. They are aware that it is forbidden, but there is nothing they can do about it. They apologise for the infringement.

The Stewards conclude that there is a breach of Art. 2.28, Art. 39.1.4 and Art. 57.1 of FIA 2025 CCRSR. In view of the obviously incorrect advice given by an Official of the Organiser, they agreed to impose an appropriate time penalty in this case.

The Decision is based on the FIA International Sporting Code Art. 11.9.1; Art., Art. 11.9.2.a, 11.9.3.a, Art. 12.4.1.h.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
