The Stewards, having received a report from the Technical Delegate (Doc 6.3), having examined the document, summoned and heard the driver and the co-driver, determine the following:

Facts:

At the Start of Leg 2, the Scrutineers remarked that car #213 was found about to leave the service, without being fitted with any left rear light. The Team members were asked to fix a fully operating rear light during the regroup, as per the Art. 58.7.1 of the FIA 2022 CCRSR.

The missing light was replaced, but it was not working properly.

The driver decided to leave the regroup parc fermé anyway.

Offence:

Breach of Art. 283-16 of FIA 2022 Appendix J ISC, Art. 25.3.1 of the FIA 2022 CCRSR.

Decision:

Fine of 250 €

In accordance with Article 12.8 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: <https://fiafines.fia.com>. Any delay in making payment may entail suspension during the period a fine remains unpaid.

Reason:

The Art. 283-16 of the Appendix J states that:

The lighting equipment must comply on all points with the International Convention on Road Traffic.

Each vehicle must be fitted with at least:

- 2 headlights (combined passing lights/headlights)
- 2 front lamps
- 2 rear lamps and number plate lighting
- 2 stop lights
- 2 flashing indicators at the front and at the rear
- Distress lights

The competitor is responsible for the technical conformity of his vehicle throughout the event. (Art. 25.3.1 of the FIA 2022 CCRSR).

The Stewards decision is based on FIA ISC Art. 11.9.1; ISC Art. 11.9.3.f and ISC Art. 12.4.1.c.

The Competitor is reminded of his right to appeal certain decisions of the stewards, in accordance with Article 15 of the FIA International Sporting Code and Article 9.1.1. of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
