2) IMPORTANT REMINDER TO ALL COMPETITORS | RALLY SAFETY.

The event organisers and the FIA EHRC on-event team would like to remind all competing crews and their support teams of the following key points on rally safety:

- The fire extinguisher system is a major safety item to protect the crew in case of fire in the car. It is essential for the driver's safety and safety is one of the major concerns by the FIA. Safety remains a key challenge and the FIA is committed to do everything possible to protect, amongst others, the competing crew. Each rally car's extinguisher system must be armed at all times during the competition. During the competition means that the systems must be activated when leaving the service park, on road sections, on special stages and in the Parc Fermé. This will be checked throughout the rally by the scrutineers and all infringements will be reported to the Stewards who will impose a penalty for non-compliance.
- Drivers must ensure that they wear their safety equipment properly on special stages all the way
 until the STOP control (helmet fastened and connected to HANS/FHR, seat belts fastened over
 HANS/FHR device, balaclava inside the overall, overall zipper closed up, driver's gloves worn etc.).
 Competitors must follow these requirements. All infringements will be reported to the Stewards
 who may impose a penalty. Please see FIA EHRC Sporting Regulations Art. 32.2.3
- Any crew which has the red "SOS" sign displayed to them, or which sees a car which has suffered an
 accident and the OK sign is not shown, shall immediately and without exception STOP to render
 assistance. Any crew stopping on a special stage and who do not require immediate medical
 assistance, must activate the OK display in the GPS safety tracking device within one minute and
 show the OK sign to all other cars. All infringements will be reported to the Stewards who may
 impose a penalty. Please see FIA EHRC Sporting Regulations Art. 53.3.
- All crews that are shown the Red Flag must immediately slow down and continue at that lowered speed until the finish of the stage <u>without exceptions</u>. The Red Flag can be a physical one shown at radio points or an electronic one sent to the event GPS safety tracking device. The electronic Red Flag must be acknowledged by the crew <u>where required to do so</u>. All infringements will be reported to the Stewards who may impose a penalty. Please see FIA EHRC Sporting Regulations Art. 53.5.
- To access an official refuelling zone, <u>all personnel involved in refuelling operations</u> (team or competing crew) <u>must</u> wear clothing that provides adequate protection against fire and includes at least: long trousers, long sleeved top, closed shoes, gloves and a fireproof balaclava. Infringements will be reported to the Stewards who may impose a penalty for non-compliance.

Please - Safety is everyone's responsibility - comply with the regulations at all times. Thank you.
