

CROSS-COUNTRY SAFETY EQUIPMENT FORM GUIDE

The aim of this document is to present you the way the Cross-Country Safety Equipment Form must be filled in.

Preamble:

The base document is a .pdf modifiable file that must be filled in with the requested information, and then printed before the pre-event scrutineering of the event you enter, before being presented to the scrutineers in charge of the safety equipment checks, together with your clothing items, helmets, and FHRs. Here below is a specimen document:

Helmets:

Please fill in the data related to your helmet(s):

- ✓ Each helmet must follow one of the FIA Standards listed on the left-hand side
- ✓ For each helmet, specify its manufacturer and its FIA Homologation Number
- ✓ If a crew member has more than 2 helmets, please write it as shown ❶
- ✓ Then select on the right-hand side the type of each of your helmets: “jet” or “full face” ❷
- ✓ Once your helmet(s) will have been checked and approved, they will be identified thanks to a sticker with a serial number.
- ✓ This sticker serial number will be hand-written by the scrutineers. ❸
- ✓ This sticker/ serial number may be re-used on any FIA 2023 Cross-Country event

Please note that the helmets homologated to the FIA 8858-2002 and 8858-2010 Standards (TL n°41), are not allowed anymore (except for T5.2 crew members).

FHRs:

- ✓ Specify the information relating to your FHR devices the same way.

Flame-proof clothing:

Only the flame-resistant clothing homologated to the FIA 8856-2018 Standard is allowed (except for T5.2 crew members). All garment items must be considered.

- ✓ If you want to register more than 2 items of different manufacturers and/ or with different Homologation Numbers, specify them as for helmets. ❶
- ✓ If a garment has been customized using printing or transfers, be prepared to show the corresponding certificate from the manufacturer to the scrutineers.
- ✓ For the co-drivers, the use of gloves is optional. If you don't use any, please untick the box as shown, otherwise, proceed as above. ❷

Note for T5 teams:

The use of clothing items homologated to the FIA 8856-2000 Standard (TL n°27) and helmets homologated to the FIA 8858-2002 and 8858-2010 Standards (TL n°41), is allowed only for the crew members of the T5 vehicles entered in the T5.2 class (Race Service trucks).

Thus, on the form dedicated to T5 competitors, select the class the truck is entered:

homologation number to be mentioned.

Since those helmets and clothing items (except the overalls) have no homologation number, then, instead the homologation number, please specify the standard the item is homologated to (ex: “8856-2010”).

- ❖ Once dully filled, **print the document, and sign it.**
- ❖ The scrutineer will finally sign the form once the equipment of all crew members will have been **checked compliant and in a good status.**
