- 3) Appendix 10 FREE PRACTICE/QUALIFYING AND SHAKEDOWN
FREE PRACTICE/QUALIFYING AND SHAKEDOWN

This stage will be run in compliance with Article No. 17.5.2 of the 2023 FPAK Rally Specific Prescriptions.

During Shakedown, a special **Free practice and** Qualifying test will take place reserved for priority FIA/FPAK and/or other ASN drivers, plus for the ten (10) top drivers of the Portugal Rally Championship, **for the ten (10) top drivers** for the first three (3) drivers of the 2RM Portugal Rally Championship and the first three (3) drivers of the GT Portugal Rally Championship, participation is mandatory.

The organization may propose the inclusion of more than 5 drivers with sports curriculum and merit and with a rally car in accordance with the 2023 FIA Regional Rally Sports Regulations and V1b – European Rally Trophy (ERT).

The Free Practice/Qualifying route is the same as the Shakedown and has a length of 3,35 km.

Competitors are required to indicate their choice to participate in the Shakedown, by filling in the obligatory field on the Entry Form.

A section in the Service Road Book will indicate the directions to get from the Rally Office (Escola Profissional Atlântico – Av. Arriaga, 7) and the **Free practice/ Qualifying and** Shakedown zone, along with a map of the area, indicating the reserved service and refuelling area.

ONLY vehicles with **CLEARLY VISIBLE SERVICE and AUXILIARY PLATES** will be allowed to park inside Shakedown Service Areas.
