The Stewards, having received a report from the FIA Deputy Technical Delegate with documentary evidence attached, summoned the competitor's representative, have considered the following matter and determine the following:

Facts Two (2) team members were working on Car 66 while the car was in the Tyre Marking

Zone after TC0.

Offence Breach of Article 13.6 of the 2024 FIA WRC Sporting Regulations.

Decision Fine of € 300 on the Competitor EDUARDO CASTRO of car No. 66

In accordance with Art. 12.8 of the 2024 FIA International Sporting Code, fines shall be paid within 48 hours of their notification. Any delay in making payment may entail

Suspension during the period a fine remains unpaid.

Reason A hearing was held on Friday, 31 May 2024 at 20:30 hrs with the Team Coordinator

of the Competitor of Car 66, Ms. Isabel ORTIZ RUIZ.

Ms. ORTIZ CRUIZ was forthright to explain that, at the Tyre Marking Zone (TMZ) following TC0, a member of the team was working on his first WRC event and was not properly aware of the regulations. The Team Coordinator acknowledged that the team had two team members in the TMZ and that they had violated the limitation set in the regulations. She apologised for this lapse.

The Stewards recognise that the team member in question was unexperienced in WRC and possibly had no ill-intentions by assisting his teammate upon entering the zone.

Article 13.6 of the 2024 FIA WRC Sporting Regulations states that for the sole purpose of assisting the tyre marking/barcode/RFID reading procedure and except for shakedown, one team member for each crew may access this zone.


Moreover, offences or infringements are punishable, whether they were committed intentionally or through negligence (FIA ISC Art. 12.1.1.a).

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2024 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.
